#### Please try to use a new Android mobile phone intelligent mobile phone, such asSunSang Note4


Android installation files: TestTool.apk, wqABCBank.jar

Key Automatic input: RSA1024







2) after a few seconds, the password input window pop-up K treasure




password is the default input, direct determination;


4) the pop-up "please wait" prompt, about a few seconds after the pop-up button prompts, as shown in Fig.

### PC end transaction signature

Note: in the same transaction path presentation tool, .Exe tool, there must be a transaction message file TLVDate.dat and TLVDate\_UTF-8.dat.

Rsa1024 certificate transaction test:

1 insert Key, running Key download installation ABC K treasure management tools;

2 open transaction presentation tools, select the transaction message encoding format for GBK or UTF-8;

3 then click SHA1+RSA1024 (SHA256+RSA1024 or SHA384+RSA1024), select a 1024 certificate transaction signature;

4 PIN password pop-up box, enter the correct password PIN (modified PIN wa111111) after confirmation;

5 key pop-up prompt window, confirm the key terminal display transaction message, press confirm;

6 Key terminal display operation is completed, PC end shows the success of the transaction. Enter the correct password and press OK button, the success of the transaction.
