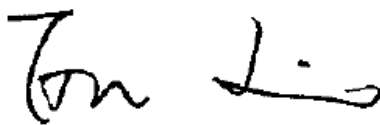

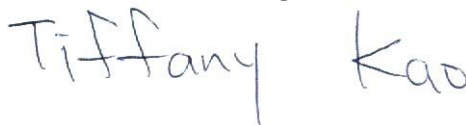

2 SYSTEM TEST CONFIGURATION

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plan. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz. The CISPR Quasi-Peak and Average detector mode is employed according to §15.207. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 0.8 m above ground plan. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through one orthogonal axis and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

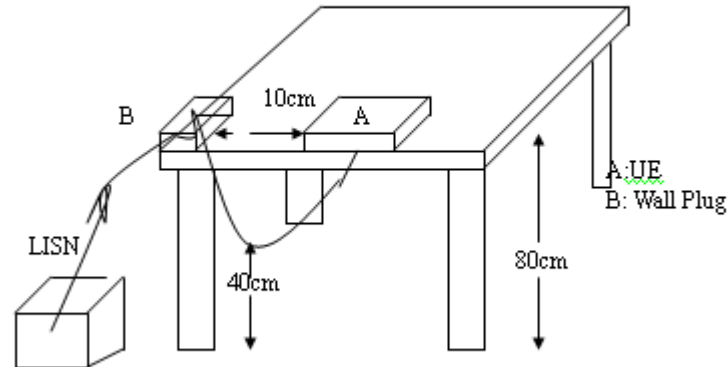

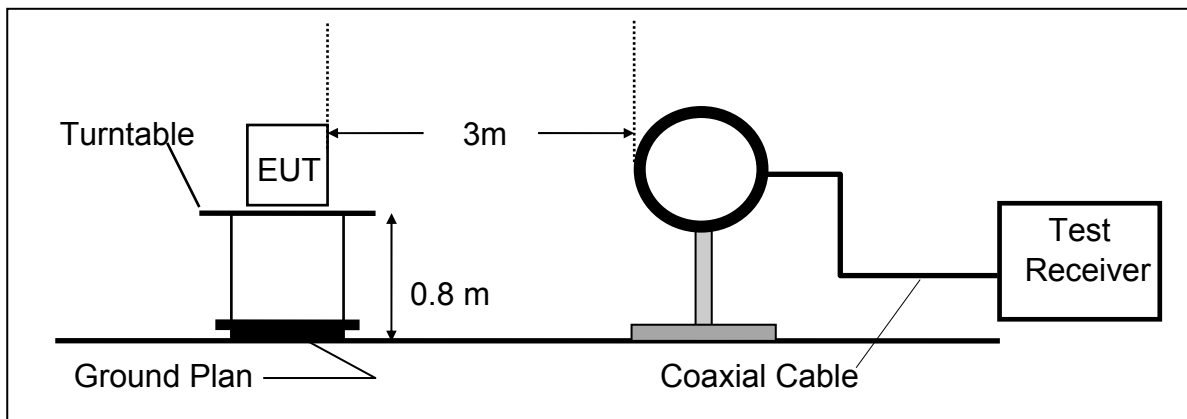

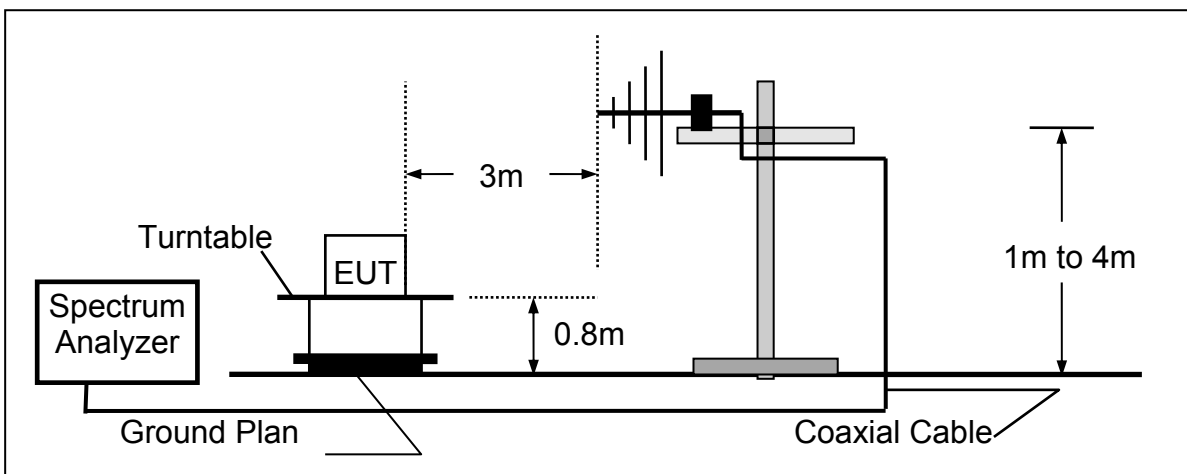

8 FREQUENCY STABILITY

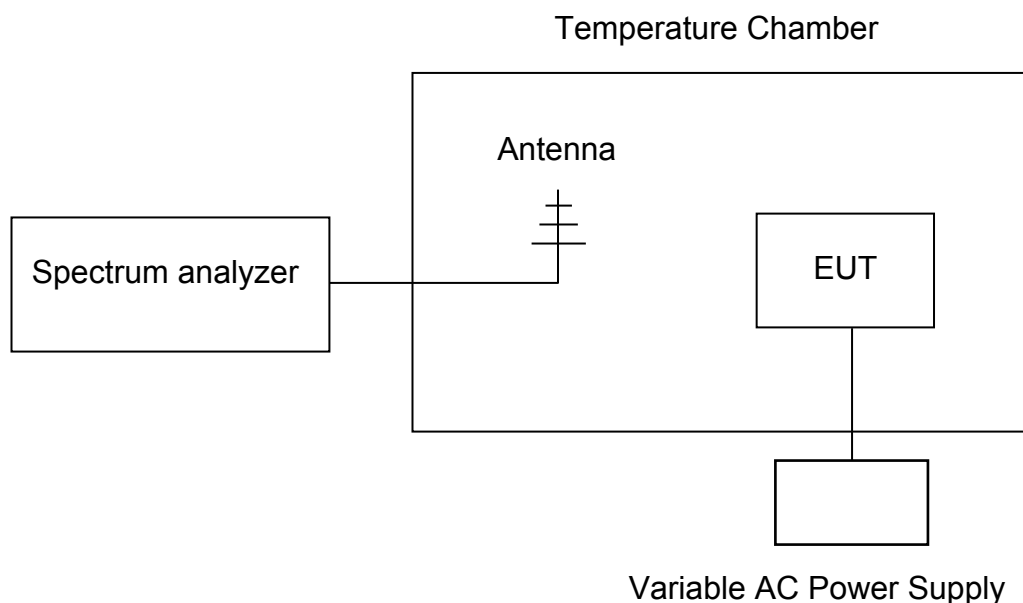

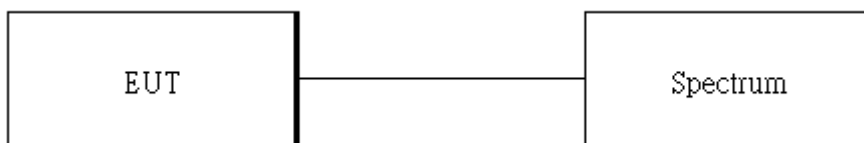

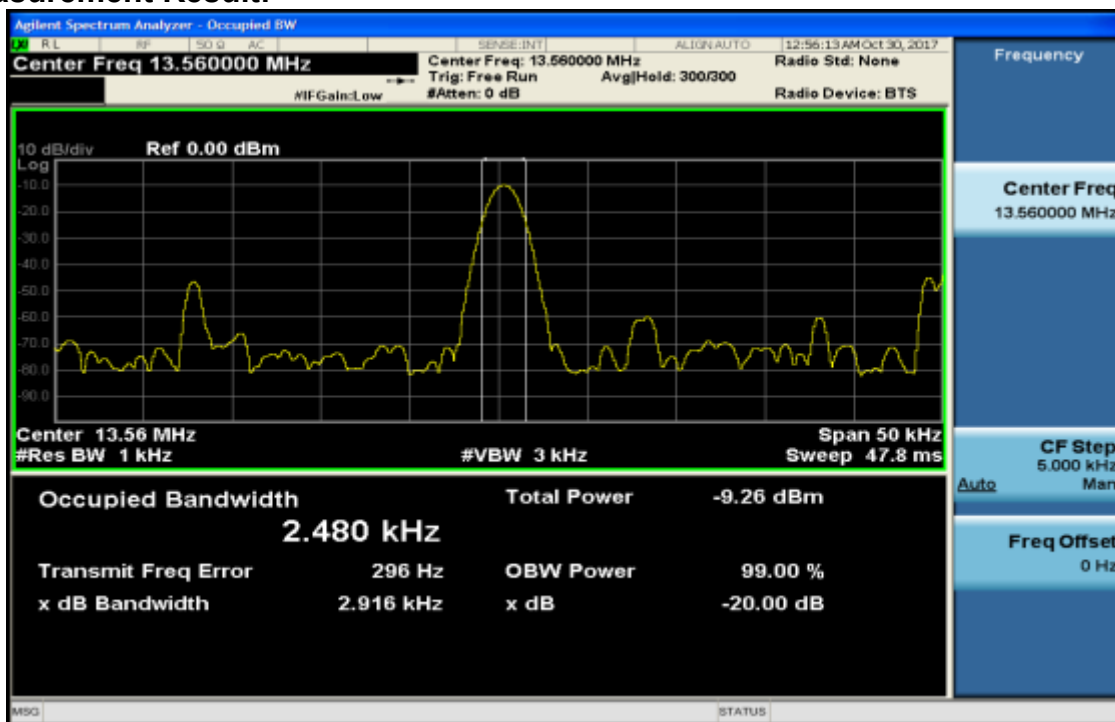

10 ANTENNA REQUIREMENT

10.1. Standard Applicable

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. For transmitters of RF output power of 10 milliwatts or less, only the portion of the antenna gain that is in excess of 6 dBi (6 dB above isotropic gain) shall be added to the measured RF output power to demonstrate compliance with the radiated power limits specified in the applicable standard. For transmitters of output power greater than 10 milliwatts, the total antenna gain shall be added to the measured RF output power to demonstrate compliance to the specified radiated power limits.

An embedded-in antenna design is used.
