


Fig.1 Photograph of the SAR measurement system




Fig.2 Photograph of the tissue simulant fluid liquid depth




Fig.3 Photograph of the tissue simulant fluid liquid depth











Photograph 13. Limb, Front Surface, 0mm




Photograph 21. Limb, Right Edge, 0mm








Photograph 29. Hotspot, Top Edge, 10mm






Photograph 33. Hotspot, Right Edge, 10mm


