Operation Instructions

1. Slide the selector switch to ON. The LED will illuminate blue and you will hear a pop tab sound. This sound means the speaker is in pairing mode, and the LED will begin alternating red and blue.

2. Turn on your music devices Bluetooth connection, and pair it to your POP. You will hear a note indicating a successful pairing, and the LED will flash blue every 7 seconds. You are ready to enjoy your music.

3. To enjoy your music via 3.5mm, plug a 3.5mm cable into the POP's AUX port. If the POP was playing via Bluetooth, you will hear a power down tone indicating the Bluetooth connection is off. Connect your music device to the POP using the other end of the 3.5mm cable and enjoy your music. Simply remove the 3.5mm cable to revert back to a Bluetooth connection.

4. To turn your POP off, simply slide the selector switch from ON to OFF. If you were enjoying a Bluetooth connection, the POP will emit a power down tone and the LED will flash red. If you were playing via a 3.5mm cable, the POP will simply power down.

Charging Your Coda Pop

Plug the micro USB cable into the micro USB charging port, and then connect the USB end into your preferred charging device. While your speaker is charging, the LED will illuminate red. When charging is complete, the LED will turn blue. It typically takes 2-3 hours for the POP to charge fully.
