Question #1: The last statement in the SAR compliance statement is not entirely correct. FCC allows for WMTS portable device with output power less than 1mW (based on source based time averaging ) to issue a compliance statement to justify 2.1091 RF compliance. Such policy does not imply to WMTS portable device is not subject to 2.1093 RF exposure compliance.

Please change the statement from " we justify that FCC section 2.1093 is not applicable to the ZM-940PA " to the following statement :

" We justify that due to the output power is less than 1mW, ZM-940PA is complied with section 2.1093 RF exposure compliance."
