






Fig.3 EUT Back side to flat phantom




Fig.4 EUT Left side to flat phantom




Fig.5 EUT Right side to flat phantom




Fig.6 EUT Top side to flat phantom




Fig.7 EUT Back side to flat phantom




Fig.8 EUT Left side to flat phantom





Fig.9 EUT Right side to flat phantom




Fig.12 EUT Stand mode to flat phantom
