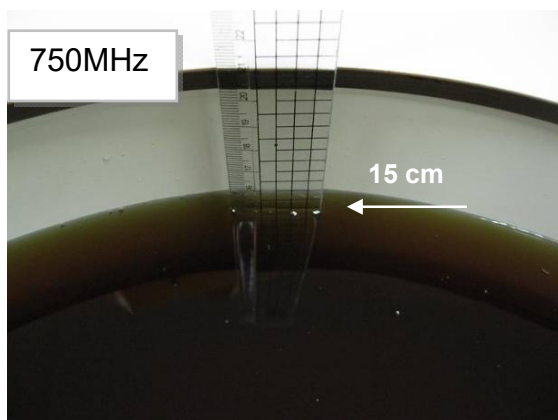

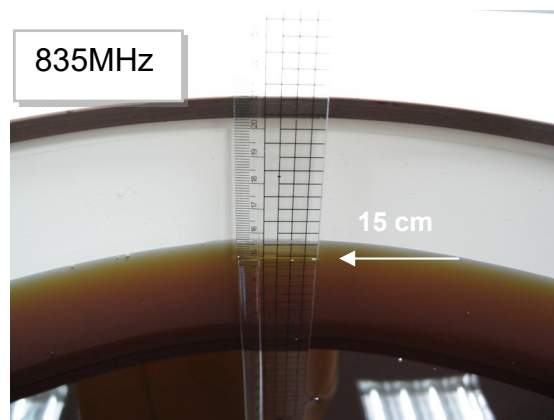

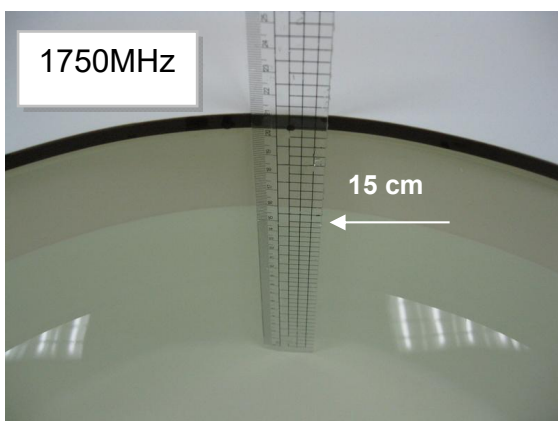

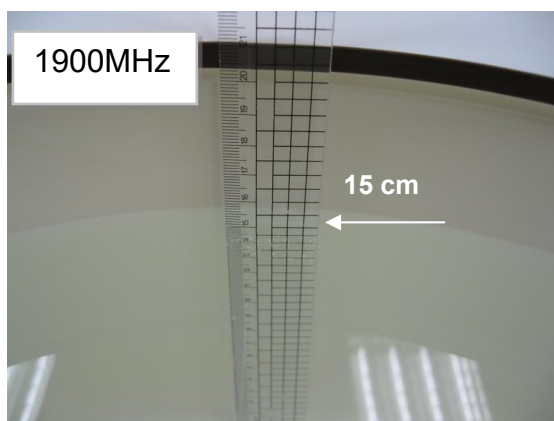

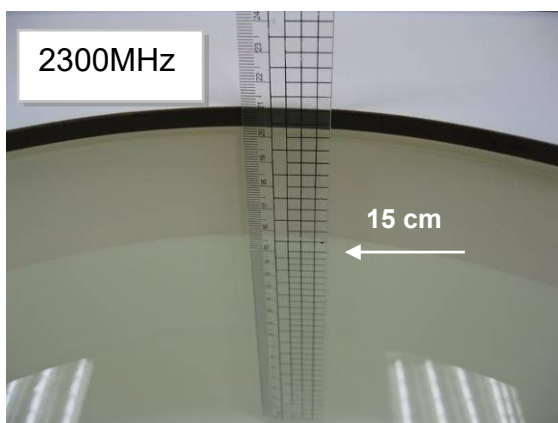

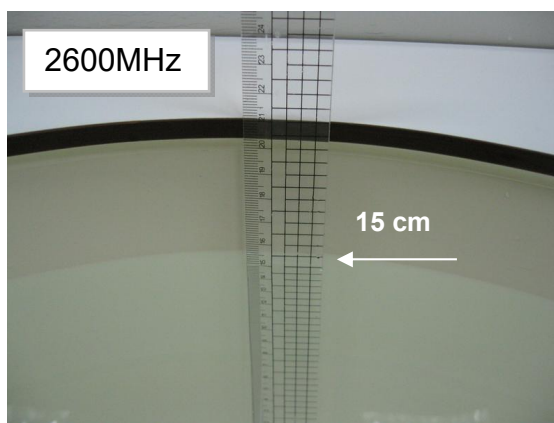

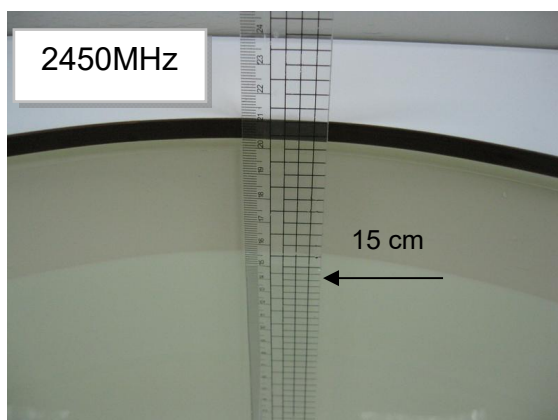

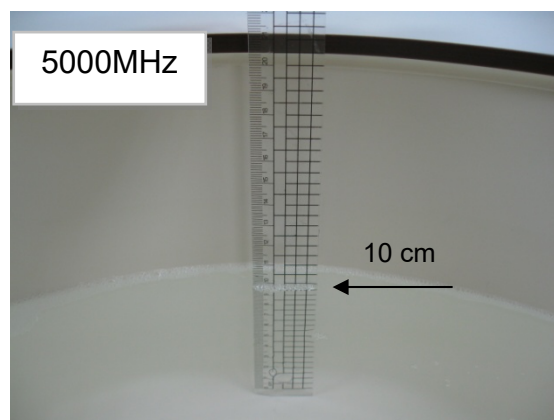

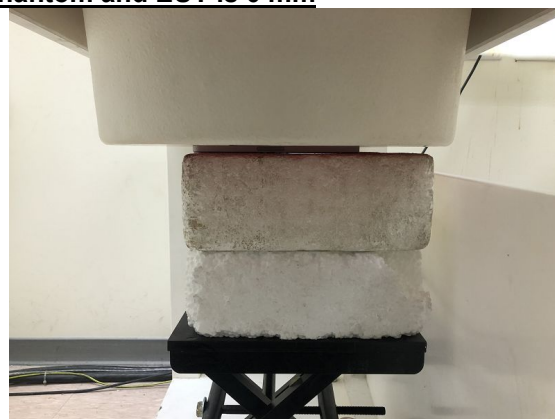
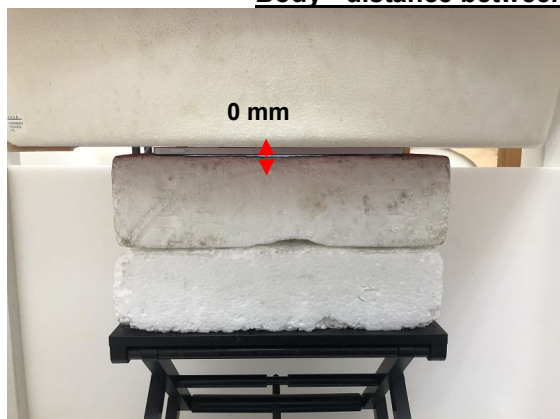

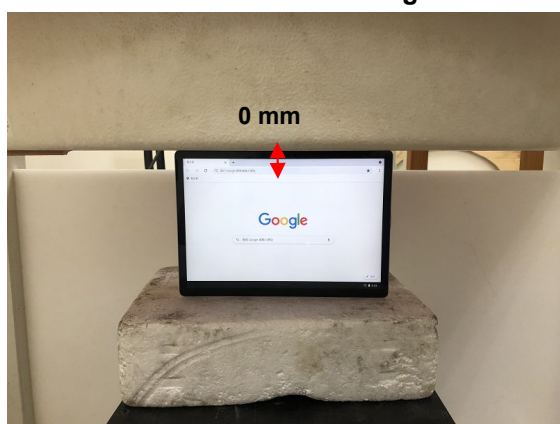

**Fig.4 EUT Top side to flat phantom**

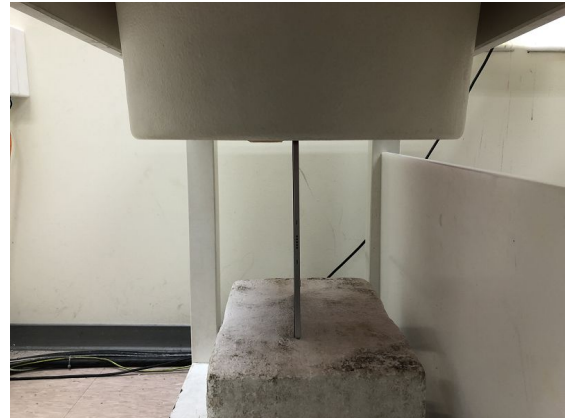


**Fig.5 EUT Bottom side to flat phantom**

**Fig.6 EUT Right side to flat phantom**

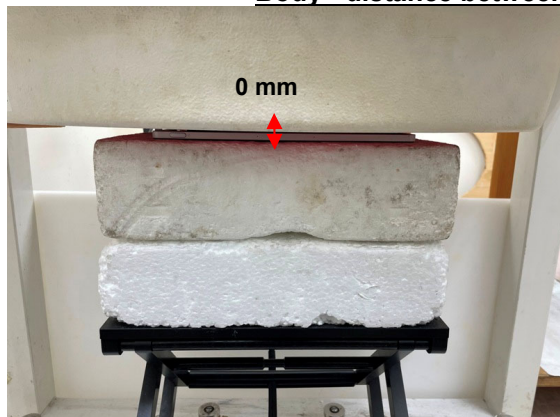


**Fig.7 EUT Left side to flat phantom**

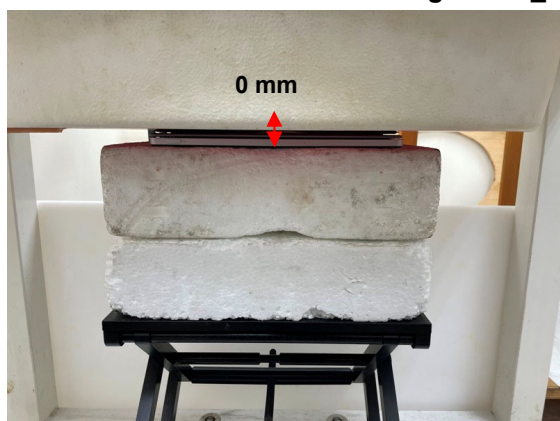

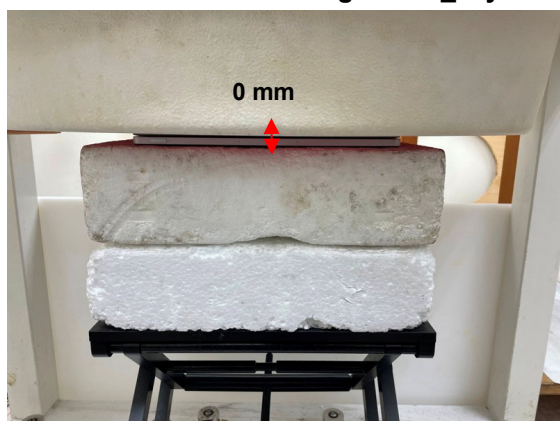

**Fig.9 With\_keyboard and kickstand\_Back side**

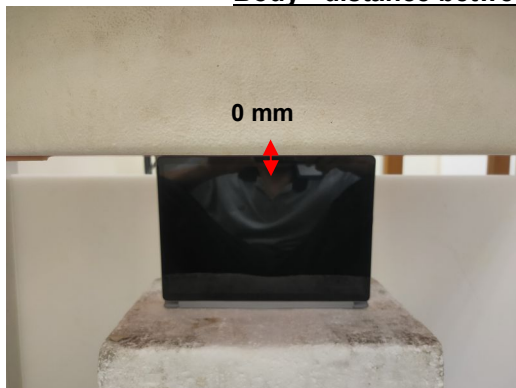


**Fig.10 With\_Kickstand\_Back side**

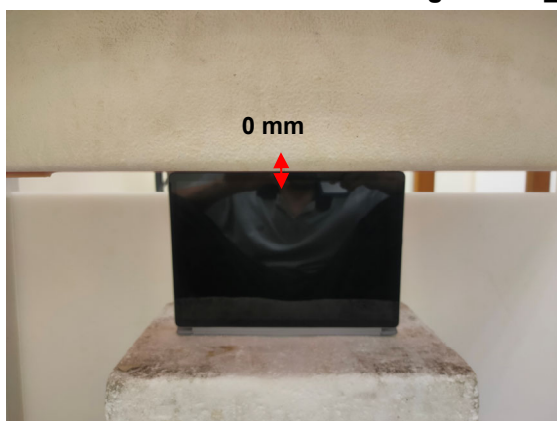

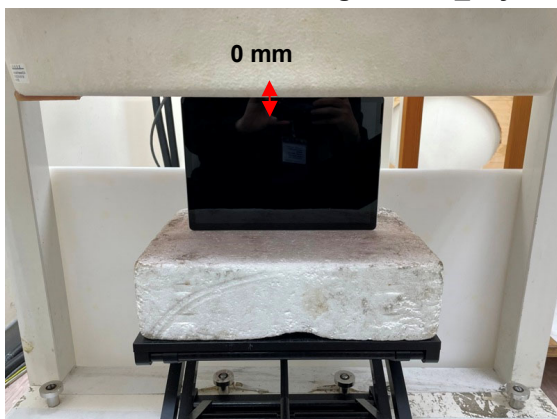

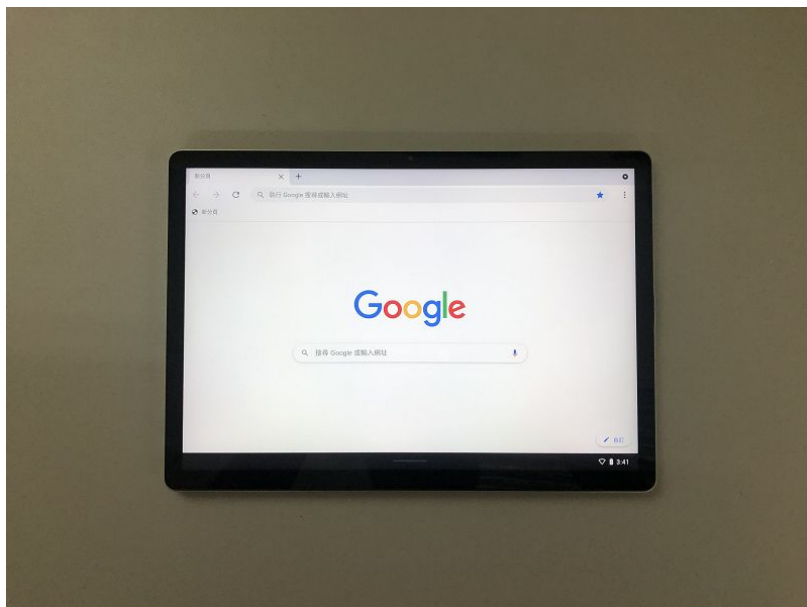


Fig.14 Front view of EUT

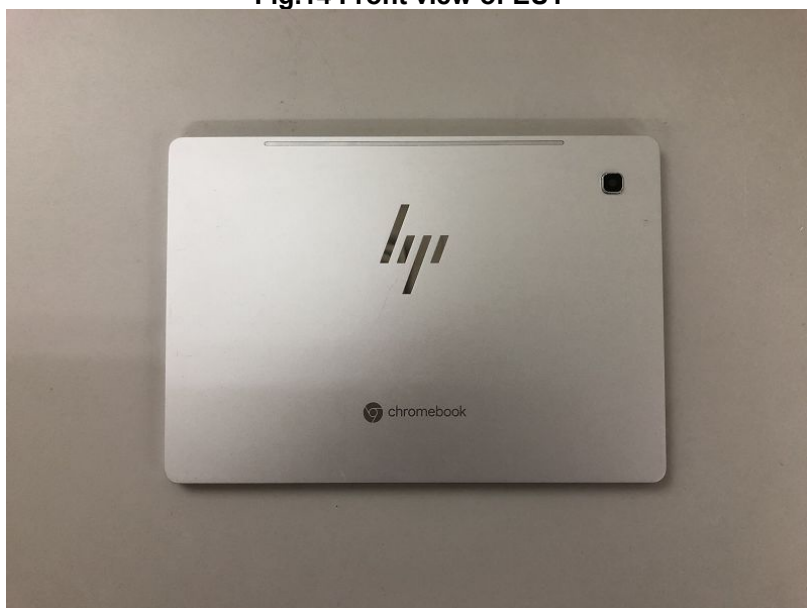


Fig.15 Back view of EUT

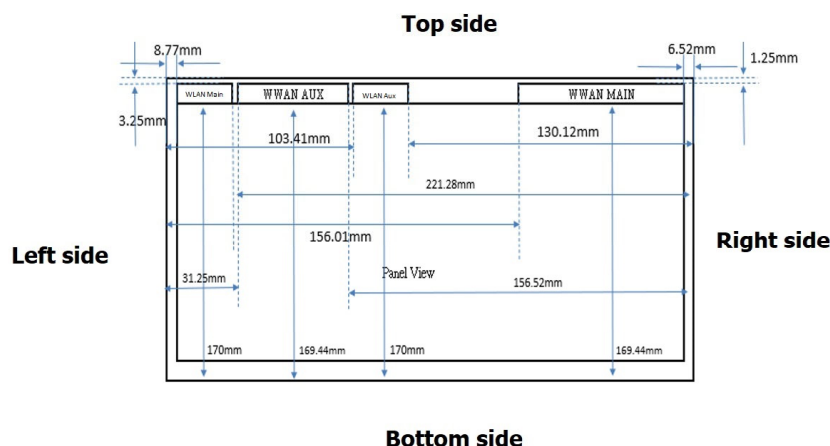

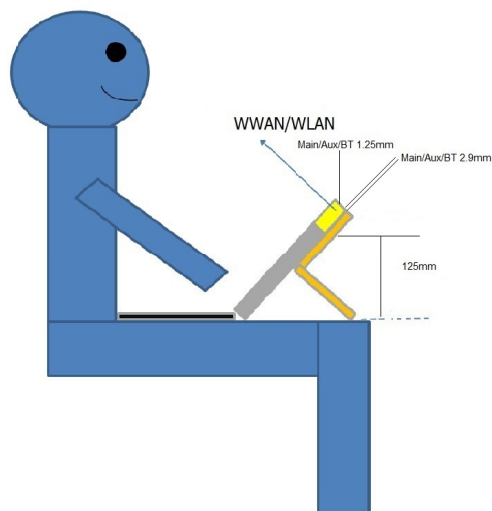
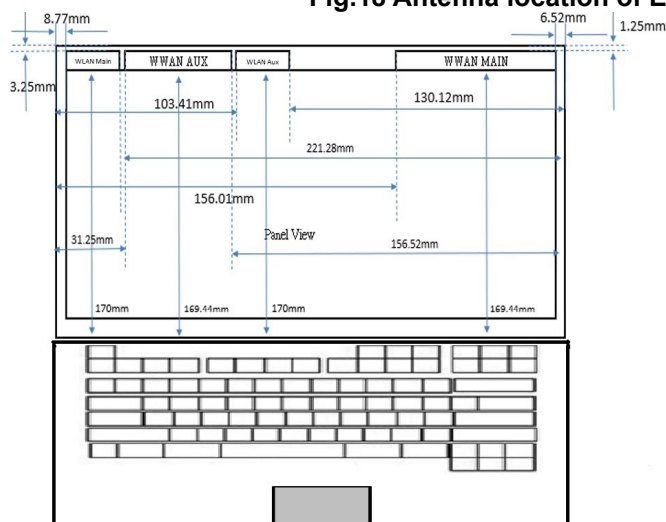
**Fig.16 Keyboard of EUT****Fig.17 Kickstand of EUT**
