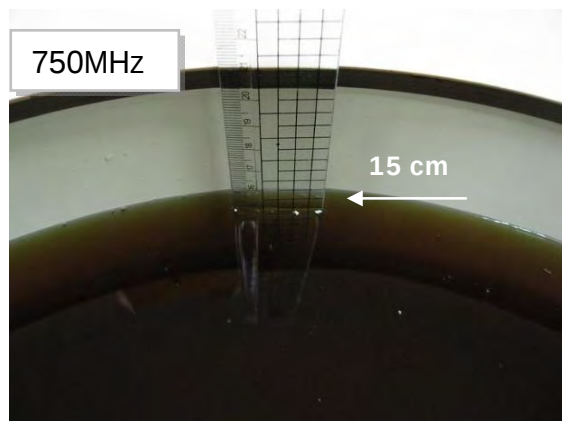

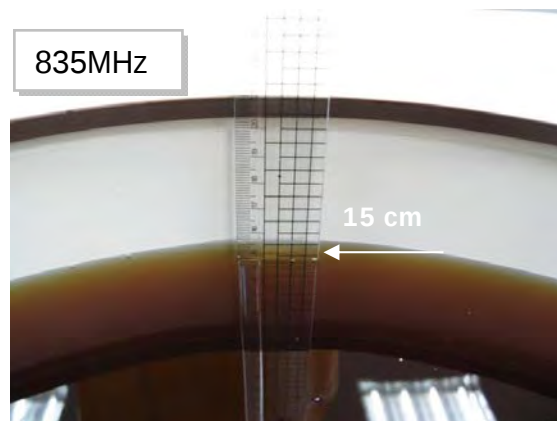

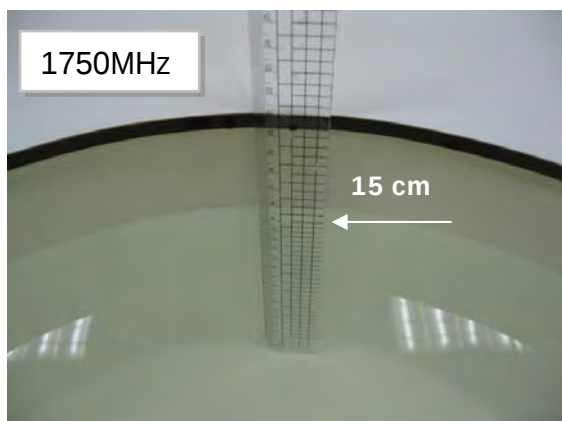

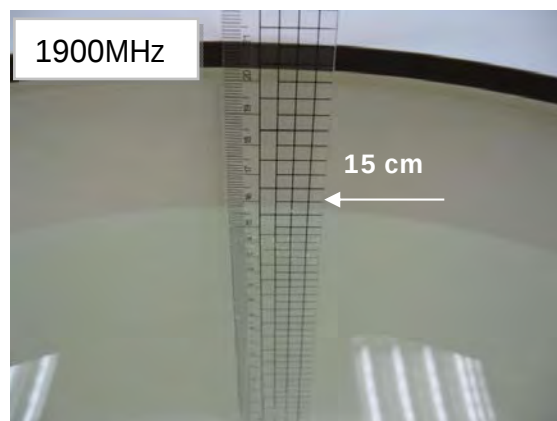

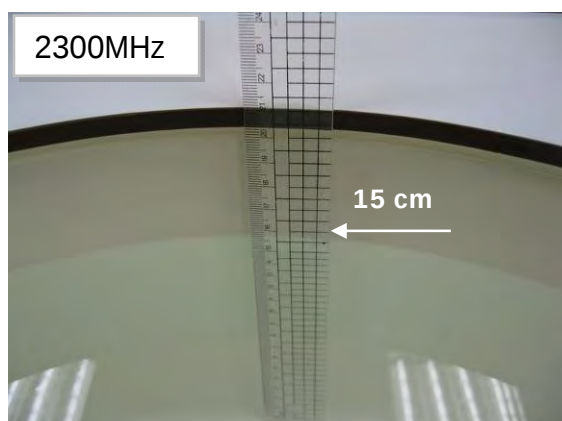

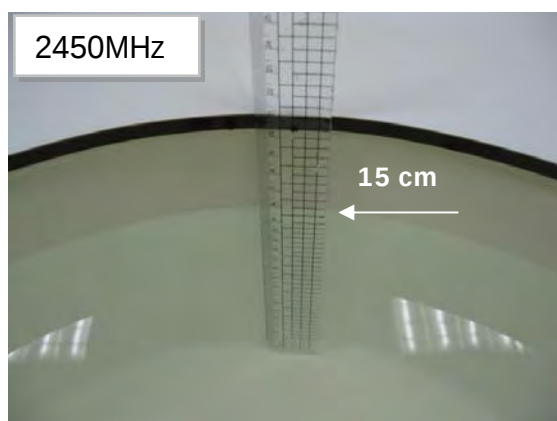

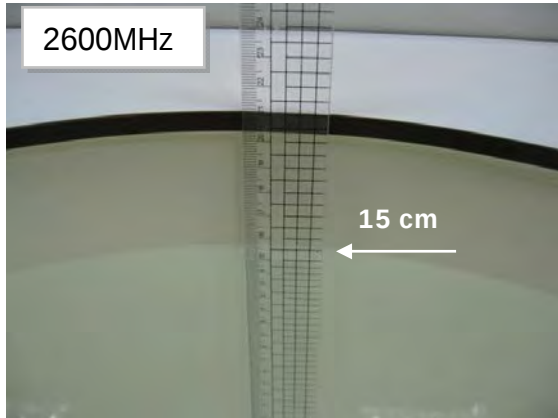

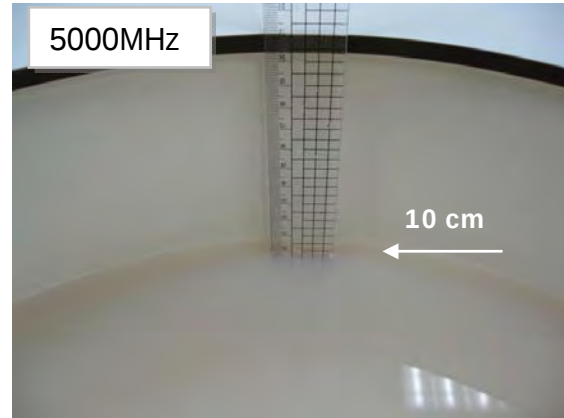

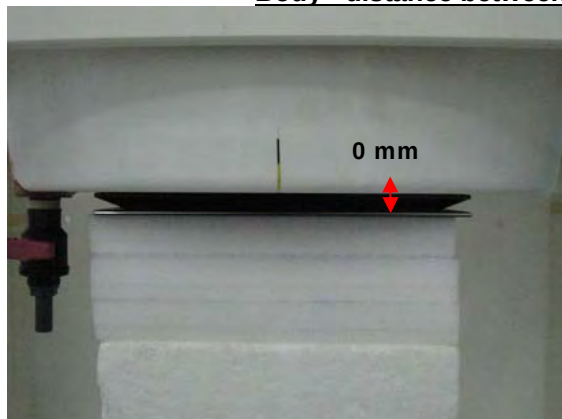


Fig.3 EUT Back side to flat phantom

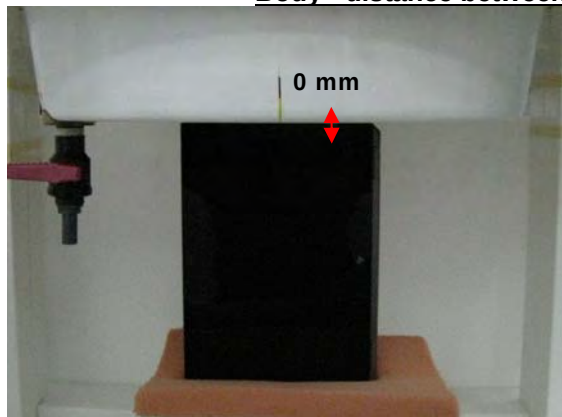


Fig.6 EUT Right side to flat phantom

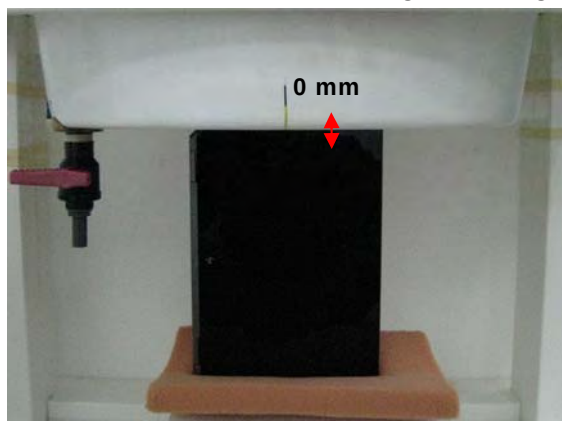


Fig.7 EUT Left side to flat phantom

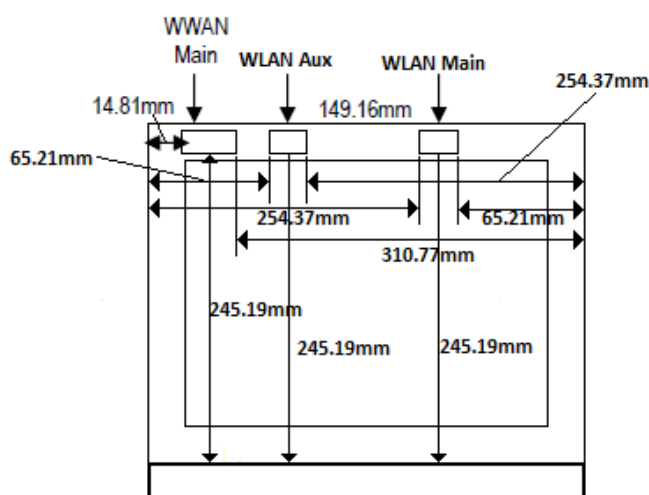

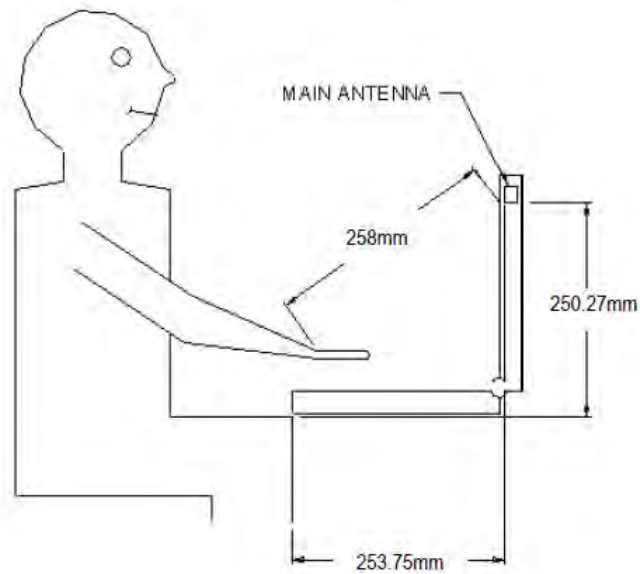


Fig.12 Antenna location of EUT (laptop mode)
