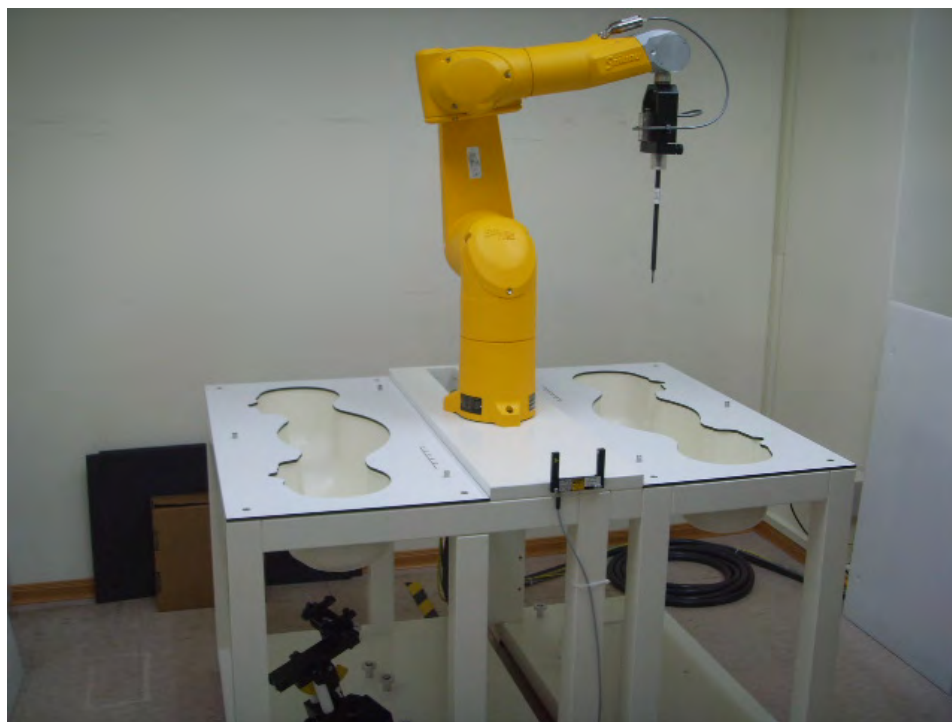


Fig.1 Photograph of the SAR measurement system

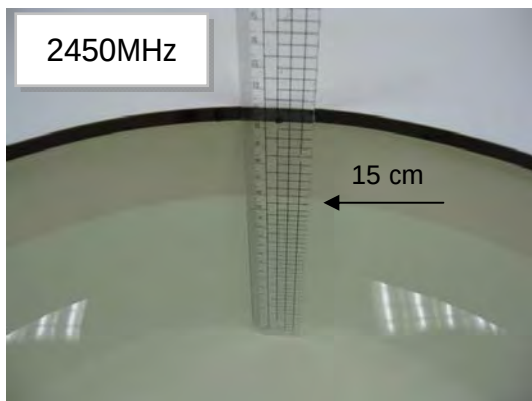

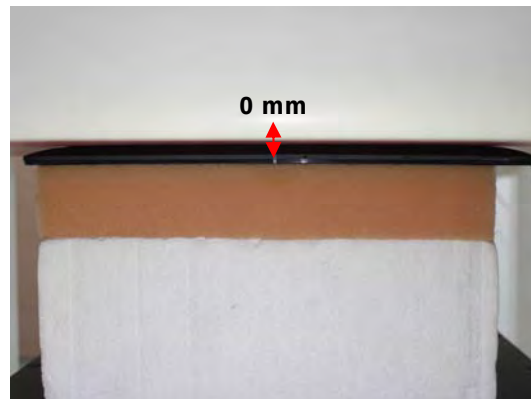


Fig.3 Back side to flat phantom

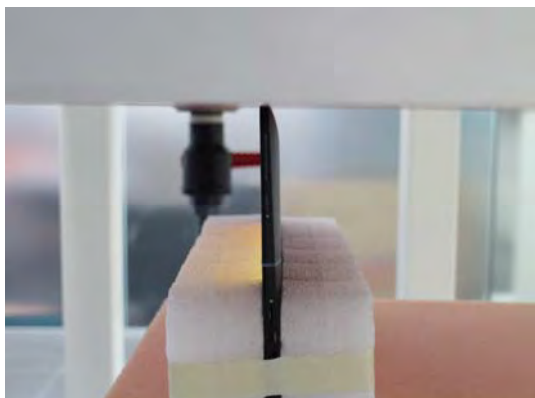


Fig.4 Top side to flat phantom

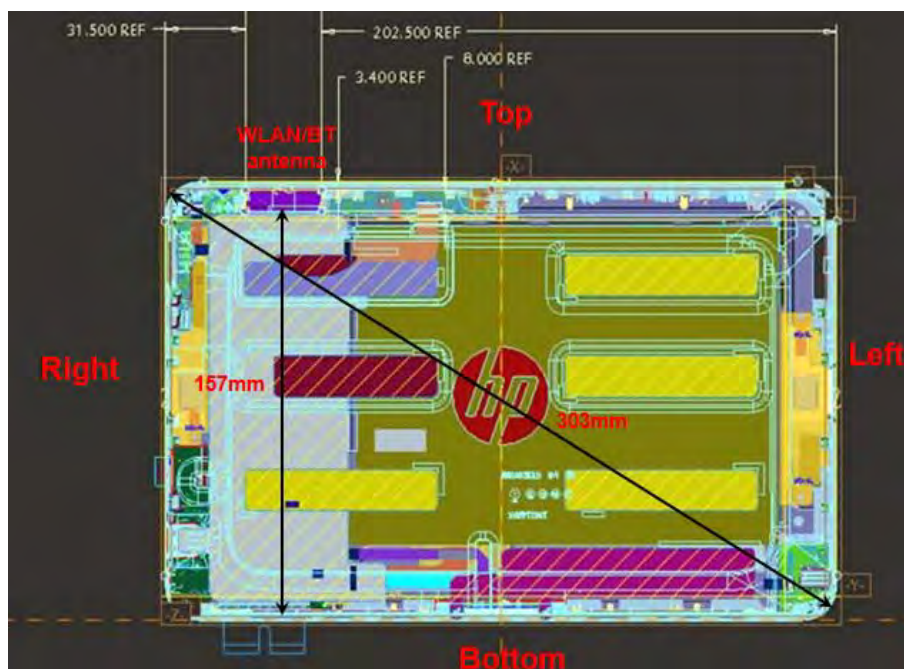


Fig.7 Antenna position (Back view)
