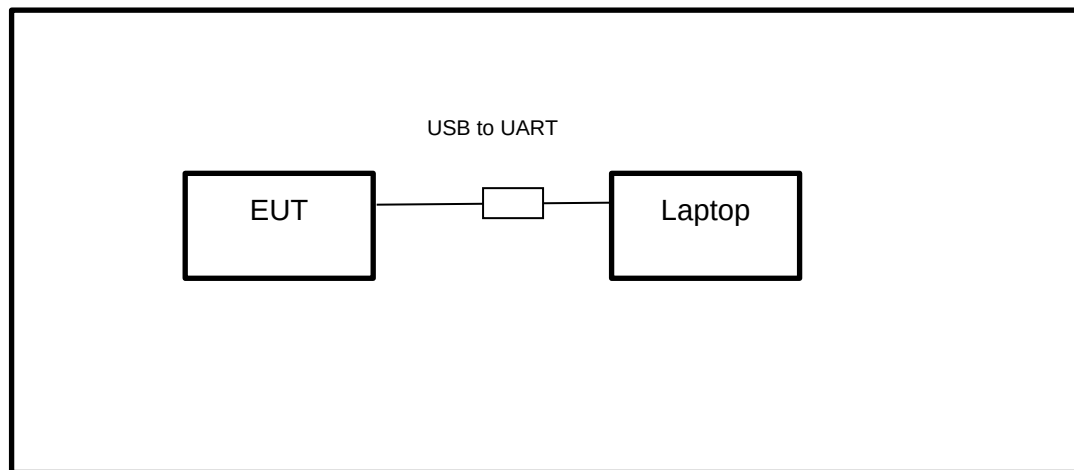

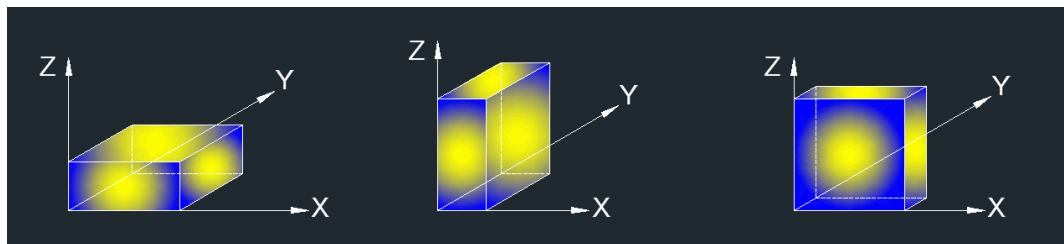

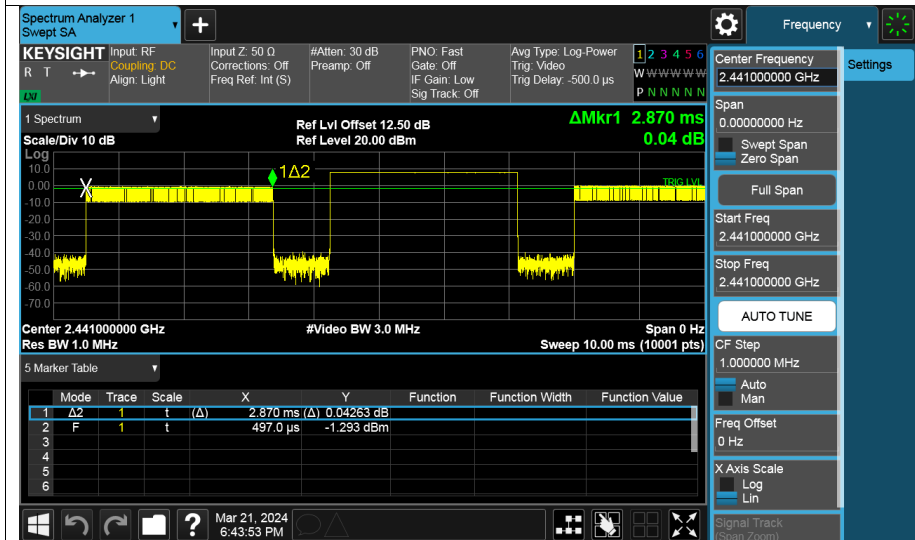
Dwell NVNT 1-DH1 2441MHz Ant1 One Burst

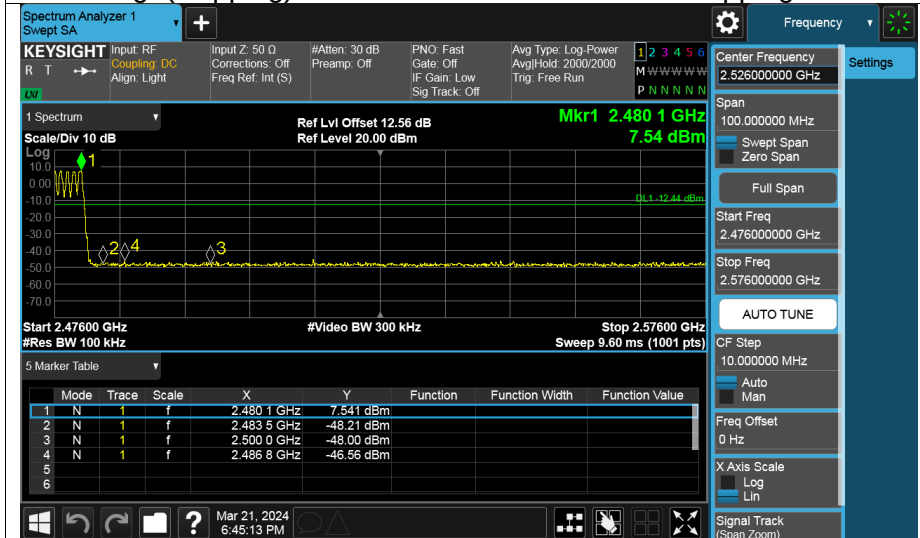
Band Edge(Hopping) NVNT 1-DH5 2402MHz Ant1 Hopping Emission

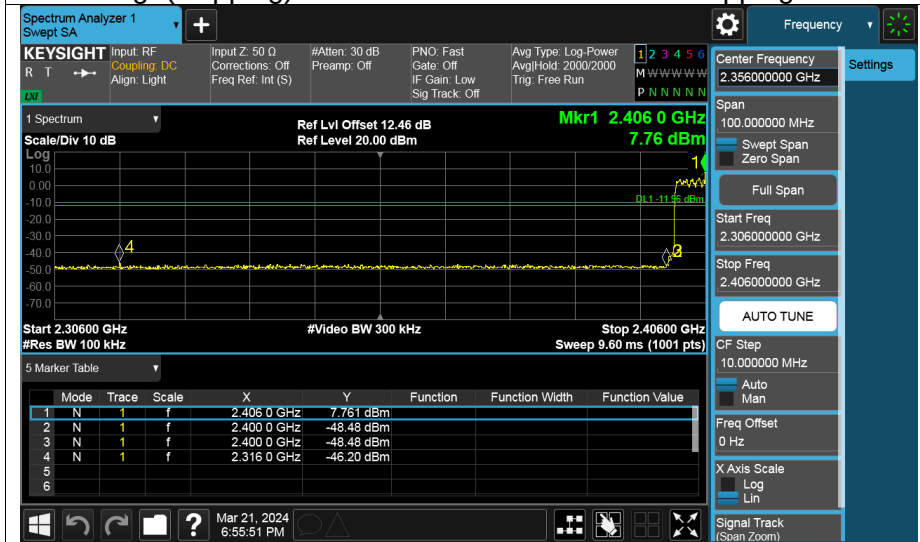

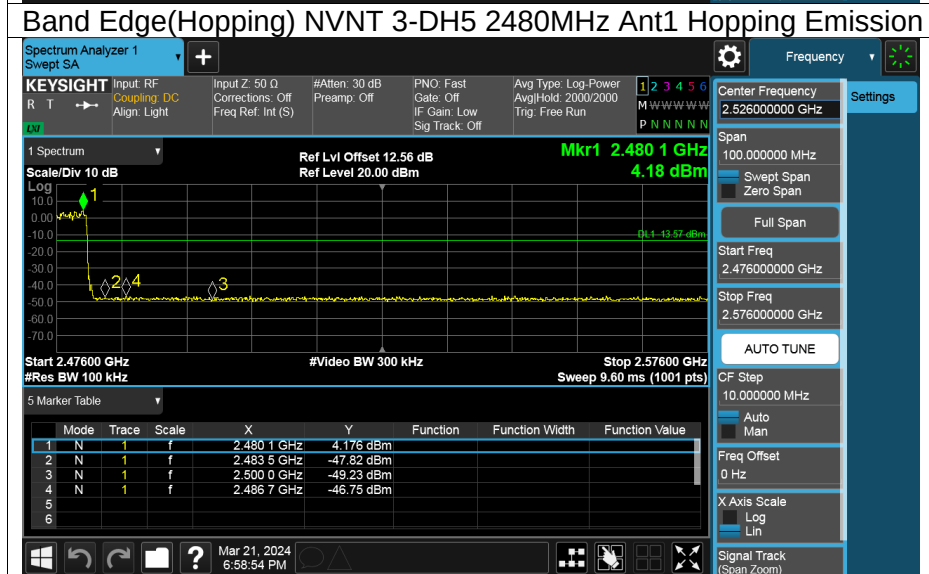
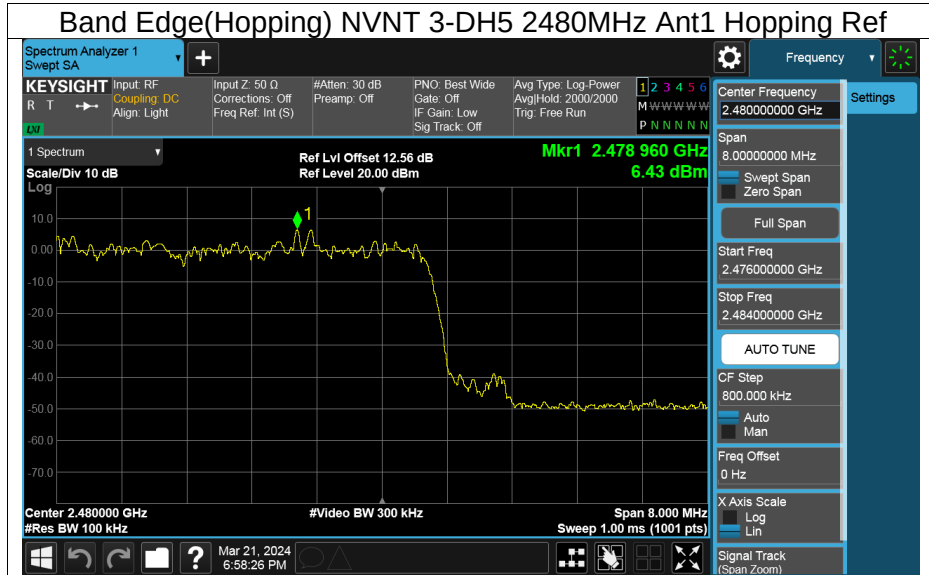


Band Edge(Hopping) NVNT 3-DH5 2402MHz Ant1 Hopping Ref



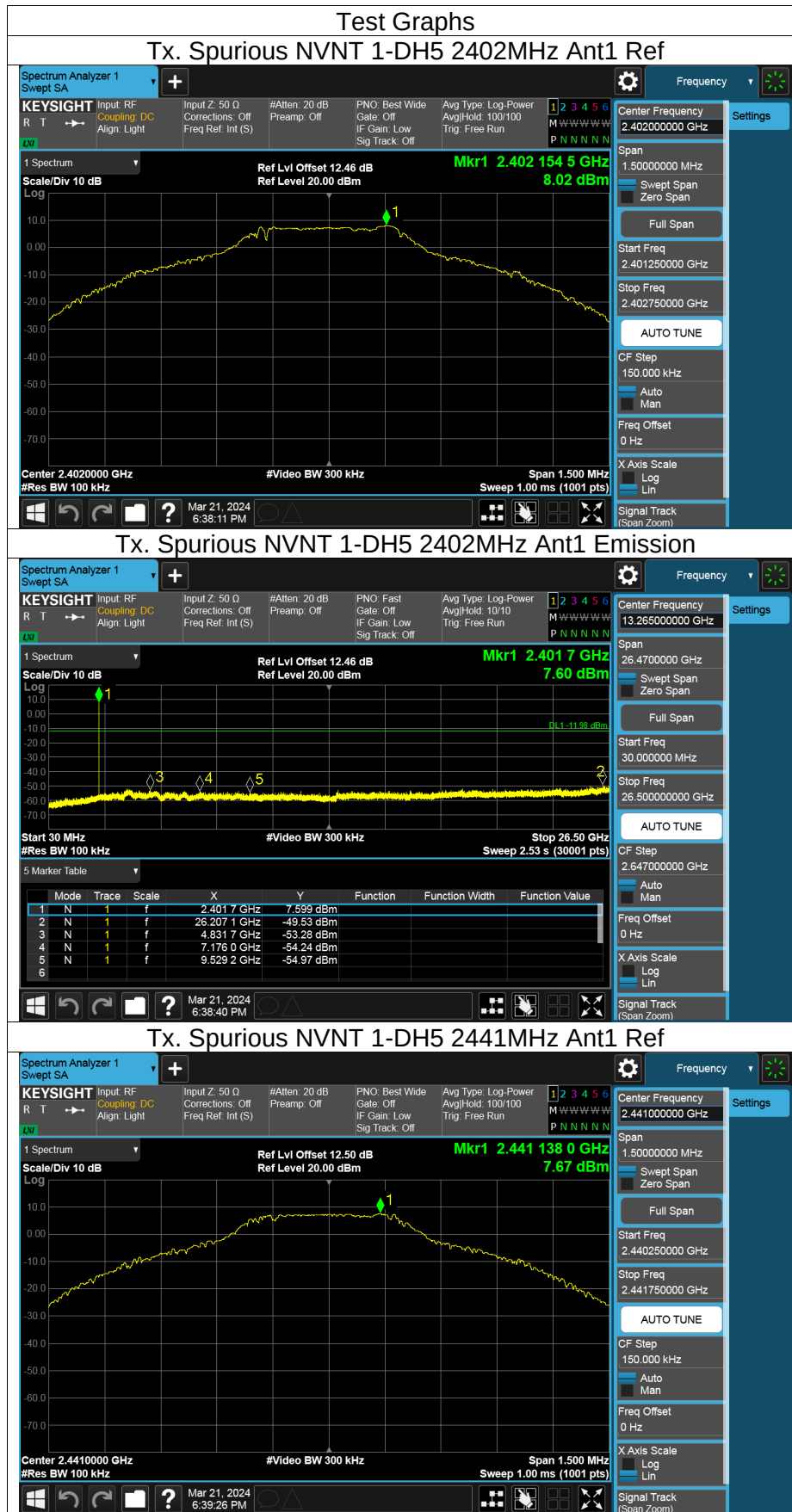

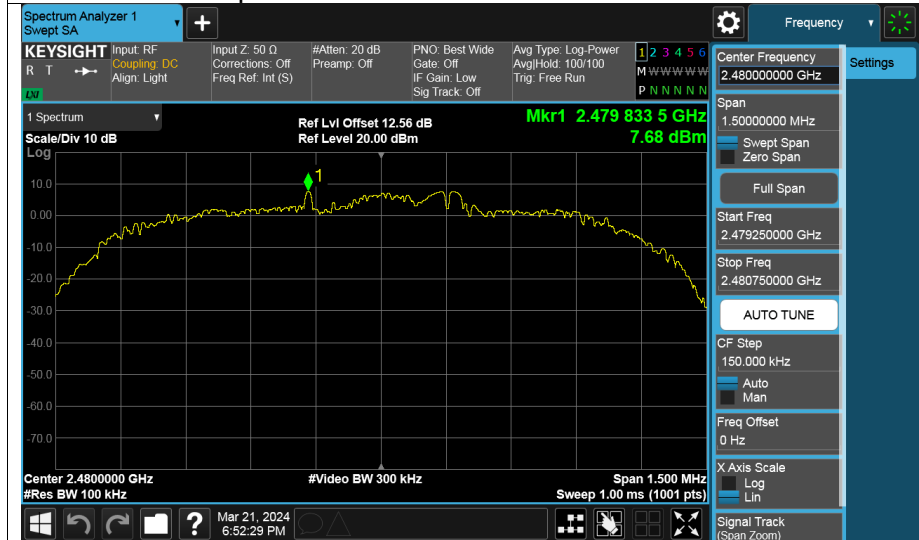




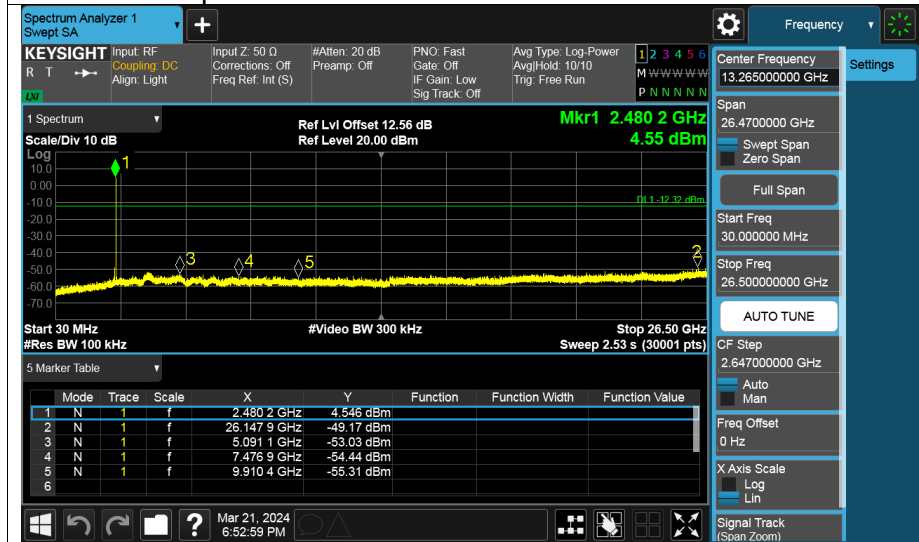
Tx. Spurious NVNT 3-DH5 2441MHz Ant1 Emission

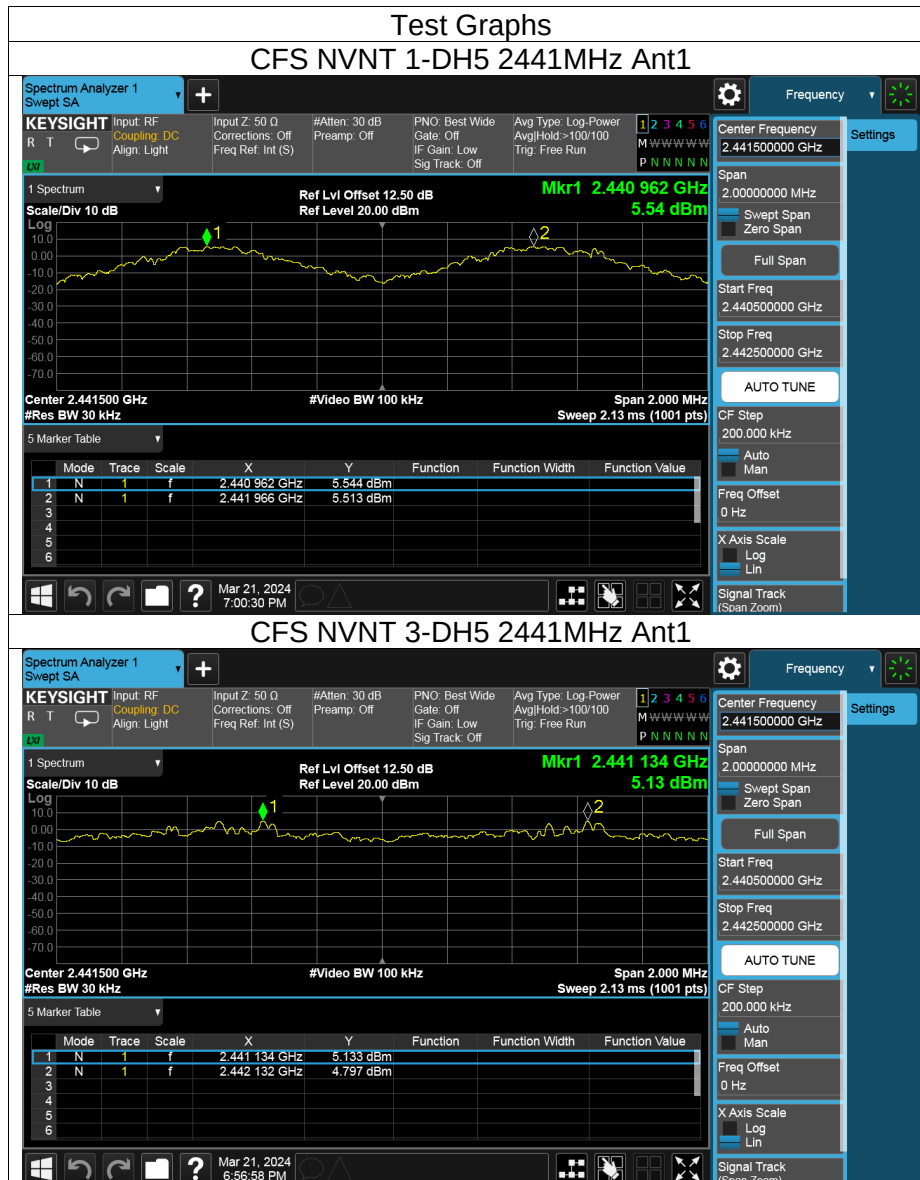

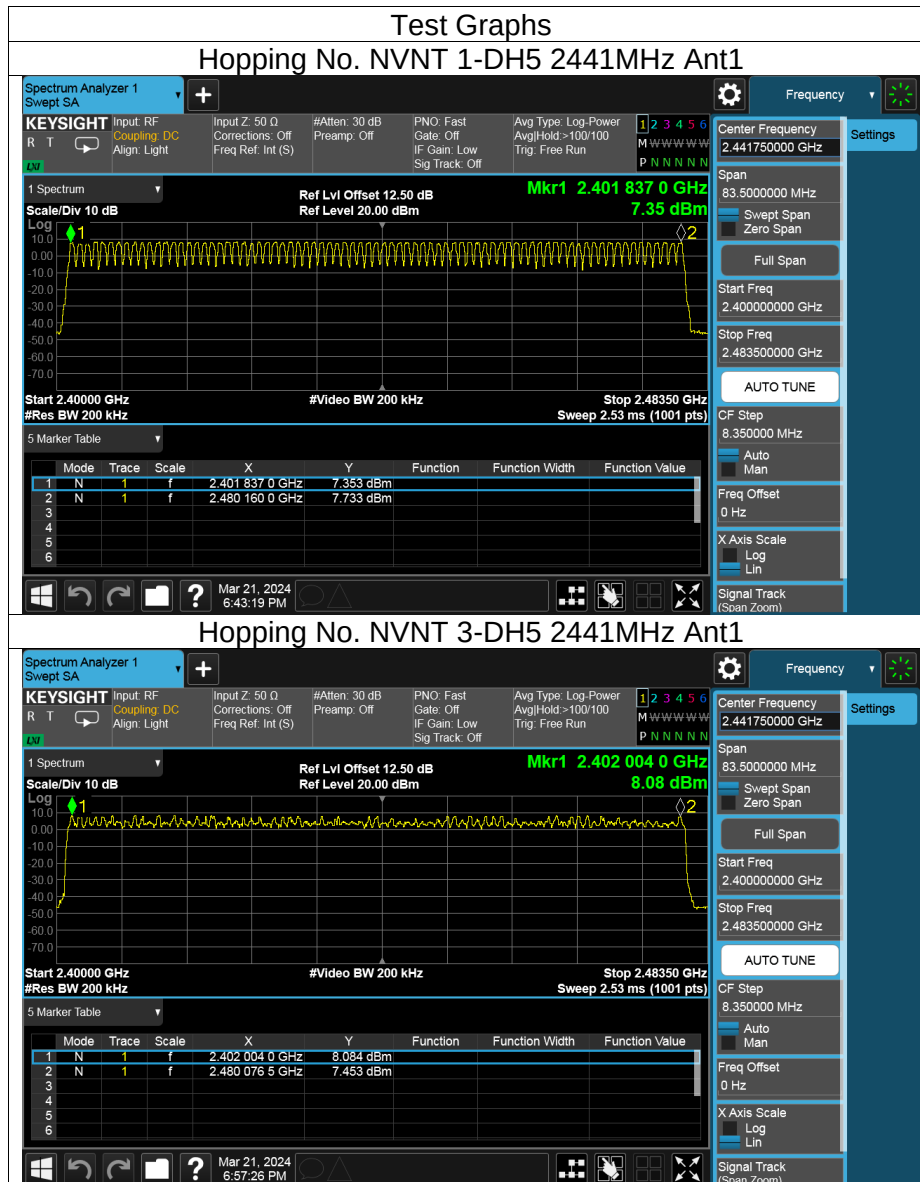

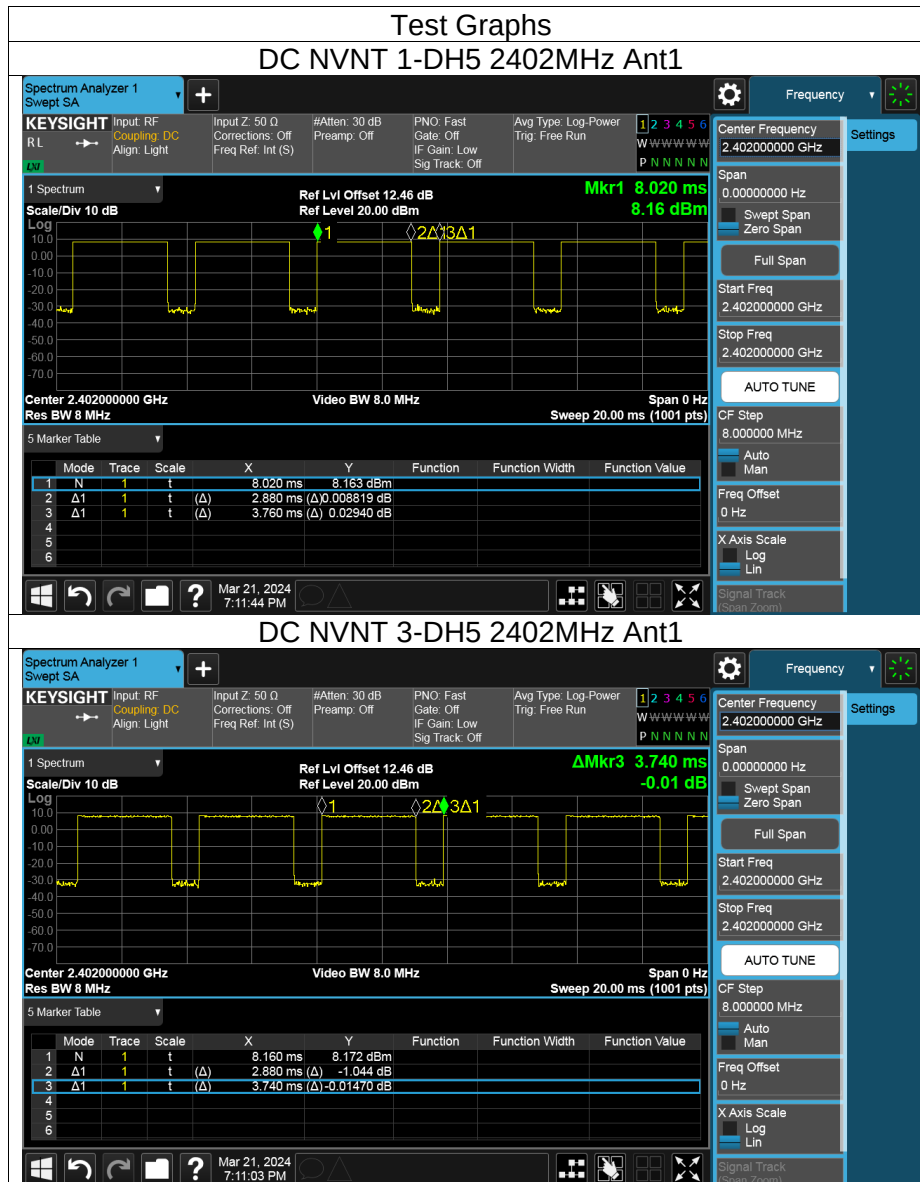
