Extract of the Regulatory section from the Apple Watch Info Guide is shown below:

Regulatory Regulatory information, certification, and compliance marks specific to Apple Watch are available on Apple Watch.

Go to Settings > General > Regulatory. Additional regulatory information is in "Safety, Handling, and Support" in the Apple Watch User Guide.

The Regulatory information is programmed in a secured manner. End-users or third parties cannot modify the Regulatory information page on the device.
