



INTRODUCTION . 0

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 **PCTEST Test Location**

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 18855 Adams Court, Morgan Hill, CA 95037. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014 and KDB 414788 D01 v01.

1.3 **Test Facility / Accreditations**

Measurements were performed at PCTEST Engineering Lab located in Morgan Hill, CA 95037, U.S.A.

2.5 **Test Configuration**

The EUT was tested per the guidance of ANSI/TIA-603-E-2016 and KDB 971168 D01 v03r01. See Section 7.0 of this test report for a description of the radiated and antenna port conducted emissions tests.

There are two vendors of the WiFi/Bluetooth radio modules, variant 1 and variant 2. Both radio modules have the same mechanical outline, same on-board antenna matching circuit, identical antenna structure, and are built and tested to conform to the same specifications and to operate within the same tolerances. The worst case configuration was found between the two variants. The EUT was also investigated with and without charger.

The emissions below 1GHz and above 18GHz were tested with the highest transmitting power channel and the worst case configuration.

The EUT was manipulated through three orthogonal planes of X-orientation (flatbed), Y-orientation (landscape), and Z-orientation (portrait) during the testing. Only the worst case emissions were reported in this test report.

2.6 Software and Firmware

The test was conducted with firmware version 16E31520i installed on the EUT.

2.7 EMI Suppression Device(s)/Modifications

No EMI suppression device(s) were added and no modifications were made during testing.







3.8 **Radiated Measurements**

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled. metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer. Per the quidelines of KDB 412172 D01 v01r01, radiated power levels are measured using the following formula:

ERP or EIRP =
$$P_T + G_T - L_C$$

Where P_T is the transmitter output power, expressed in dBm, G_T is the gain of the transmitting antenna, in dBd (ERP) or dBi (EIRP), and L_C signal attenuation in the connecting cable between the transmitter and antenna in dB.

Per the guidance of ANSI/TIA-603-E-2016, a half-wave dipole is then substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

$$P_{d [dBm]} = P_{g [dBm]} - cable loss [dB] + antenna gain [dBd/dBi]$$

Where, Pd is the dipole equivalent power, Pg is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to Pg [dBm] - cable loss [dB]. The calculated Pd levels are then compared to the absolute spurious emission limit of -13dBm which is equivalent to the required minimum attenuation of 43 + 10log₁₀(Power [Watts]).

Radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI/TIA-603-E-2016.

Spurious Radiated Emission

Example: Spurious emission at 3700.40 MHz

The receive spectrum analyzer reading at 3 meters with the EUT on the turntable was -81.0 dBm. The gain of the substituted antenna is 8.1 dBi. The signal generator connected to the substituted antenna terminals is adjusted to produce a reading of -81.0 dBm on the spectrum analyzer. The loss of the cable between the signal generator and the terminals of the substituted antenna is 2.0 dB at 3700.40 MHz. So 6.1 dB is added to the signal generator reading of -30.9 dBm yielding -24.80 dBm. The fundamental EIRP was 25.50 dBm so this harmonic was 25.50 dBm - (-24.80) = 50.3 dBc.

- All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst case emissions.
- 2) The analyzer plots were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables, directional couplers, and attenuators used as part of the system to maintain a link between the call box and the EUT at all frequencies of interest.
- 3) All antenna port conducted emissions testing was performed on a test bench with the antenna port of the EUT connected to the spectrum analyzer through calibrated cables, attenuators, and couplers.

Plot 7-1. Occupied Bandwidth Plot (Cellular GPRS Mode)








Plot 7-8. Conducted Spurious Plot (Cellular GPRS Mode - Low Channel)




Plot 7-9. Conducted Spurious Plot (Cellular GPRS Mode - Low Channel)


Plot 7-10. Conducted Spurious Plot (Cellular GPRS Mode - Low Channel)




Plot 7-11. Conducted Spurious Plot (Cellular GPRS Mode - Mid Channel)


Plot 7-12. Conducted Spurious Plot (Cellular GPRS Mode - Mid Channel)




Plot 7-13. Conducted Spurious Plot (Cellular GPRS Mode - Mid Channel)




Plot 7-16. Conducted Spurious Plot (Cellular GPRS Mode - High Channel)




Plot 7-17. Conducted Spurious Plot (PCS GPRS Mode - Low Channel)






Plot 7-19. Conducted Spurious Plot (PCS GPRS Mode - Low Channel)




Plot 7-20. Conducted Spurious Plot (PCS GPRS Mode - Mid Channel)


Plot 7-21. Conducted Spurious Plot (PCS GPRS Mode - Mid Channel)






Plot 7-23. Conducted Spurious Plot (PCS GPRS Mode - High Channel)




Plot 7-25. Conducted Spurious Plot (PCS GPRS Mode - High Channel)






Plot 7-28. Conducted Spurious Plot (Cellular WCDMA Mode - Low Channel)






Plot 7-30. Conducted Spurious Plot (Cellular WCDMA Mode - Mid Channel)








Plot 7-34. Conducted Spurious Plot (Cellular WCDMA Mode - High Channel)






Plot 7-37. Conducted Spurious Plot (AWS WCDMA Mode - Low Channel)










Plot 7-46. Conducted Spurious Plot (PCS WCDMA Mode - Low Channel)


Plot 7-48. Conducted Spurious Plot (PCS WCDMA Mode - Mid Channel)


Plot 7-50. Conducted Spurious Plot (PCS WCDMA Mode - High Channel)





Plot 7-53. Band Edge Plot (Cellular GPRS Mode - Low Channel)




Plot 7-54. Band Edge Plot (Cellular GPRS Mode - High Channel)




Plot 7-55. Band Edge Plot (PCS GSM Mode - Low Channel)





Plot 7-57. Band Edge Plot (PCS GSM Mode - High Channel)




Plot 7-58. 4MHz Span Plot (PCS GSM Mode - High Channel)





Plot 7-61. Band Edge Plot (AWS WCDMA Mode - Low Channel)




Plot 7-62. 4MHz Span Plot (AWS WCDMA Mode - Low Channel)

Plot 7-64. 4MHz Span Plot (AWS WCDMA Mode - High Channel)



Plot 7-65. Band Edge Plot (PCS WCDMA Mode - Low Channel)




Plot 7-66. 4MHz Span Plot (PCS WCDMA Mode - Low Channel)

7.5 Peak-Average Ratio

Test Overview

A peak to average ratio measurement is performed at the conducted port of the EUT. The spectrum analyzers Complementary Cumulative Distribution Function (CCDF) measurement profile is used to determine the largest deviation between the average and the peak power of the EUT in a given bandwidth. The CCDF curve shows how much time the peak waveform spends at or above a given average power level. The percent of time the signal spends at or above the level defines the probability for that particular power level.


Figure 7-4. Test Instrument & Measurement Setup




Plot 7-69. Peak-Average Ratio Plot (Cellular GPRS Mode)




Plot 7-70. Peak-Average Ratio Plot (EDGE850 Mode)


Plot 7-71. Peak-Average Ratio Plot (PCS GPRS Mode)




Plot 7-72. Peak-Average Ratio Plot (EDGE1900 Mode)


Plot 7-73. Peak-Average Ratio Plot (Cellular WCDMA Mode)




Figure 7-6. Test Instrument & Measurement Setup

- **Primary Supply Voltage:** The primary supply voltage is varied from 85% to 115% of the nominal value for b.) non hand-carried battery and AC powered equipment. For hand-carried, battery-powered equipment, primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacturer.

For Part 22, RSS-132, and RSS-133, the frequency stability of the transmitter shall be maintained within ±0.00025% (±2.5 ppm) of the center frequency. For Part 24, Part 27, and RSS-139, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block.

Test Procedure Used

ANSI/TIA-603-E-2016

Test Settings

- 1. The carrier frequency of the transmitter is measured at room temperature (20°C to provide a reference).
- 2. The equipment is turned on in a "standby" condition for fifteen minutes before applying power to the transmitter. Measurement of the carrier frequency of the transmitter is made within one minute after applying power to the transmitter.
- 3. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A period of at least one half-hour is provided to allow stabilization of the equipment at each temperature level.

Test Setup

The EUT was connected via an RF cable to a spectrum analyzer with the EUT placed inside an environmental chamber.




Figure 7-7. Frequency Stability Graph (Cellular GPRS Mode - Ch. 190)




Figure 7-8. Frequency Stability Graph (Cellular WCDMA Mode – Ch. 4183)




Figure 7-9. Frequency Stability Graph (AWS WCDMA Mode - Ch. 1413)




Figure 7-10. Frequency Stability Graph (PCS GPRS Mode – Ch. 661)




Figure 7-11. Frequency Stability Graph (PCS WCDMA Mode - Ch. 9400)
