





2.2. Limit

2.2.1. FCC

According to §15.247(d), in any 100 klb bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 klb bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emission which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

According to §15.209(a), except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

2.2.2. IC

According to RSS-247 Issue 3, 5.5, in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under section 5.4(d), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

According to RSS-Gen Issue 5, 8.9, except where otherwise indicated in the applicable RSS, radiated emissions shall comply with the field strength limits shown in table 5 and table 6. Additionally, the level of any transmitter unwanted emission shall not exceed the level of the transmitter's fundamental emission.

2.3. Test Procedures

Radiated emissions from the EUT were measured according to the dictates in section 11.11 & 11.12 of ANSI C63.10-2013.

2.3.1. Test Procedures for emission below 30 Mb

- 1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel and perpendicular of the antenna are set to make the measurement.
- 3. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 4. The test-receiver system was set to average or quasi peak detect function and Specified Bandwidth with Maximum Hold Mode.

2.3.2. Test Procedures for emission from above 30 Mb

- 2. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 3 meter away from the interference-receiving antenna.
- 3. The antenna is a bi-log antenna, a horn antenna and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 6. For measurements Above 1 (resolution bandwidth is set to 1 Mb, the video bandwidth is set to 3 Mb for peak measurements and as applicable for average measurements.

- 1. Unwanted Emissions into Non-Restricted Frequency Bands
- The Reference Level Measurement refer to section 11.11.2 Set analyzer center frequency to DTS channel center frequency, SPAN \geq 1.5 times the DTS bandwidth, the RBW = 100 kHz and VBW \geq 3 x RBW, Detector = Peak, Sweep time = Auto couple, Trace = Max hold.
- Unwanted Emissions Level Measurement refer to section 11.11.3 Set the center frequency and span to encompass frequency range to be measured, the RBW = 100 $\,\mathrm{kHz}$ and $\,\mathrm{VBW} \ge 3 \,\mathrm{x}$ RBW, Detector = Peak, Sweep time = Auto couple, Trace = Max hold.
- 2. Unwanted Emissions into Restricted Frequency Bands
- Peak Power measurement procedure refer to section 11.12.2.4 Set RBW = as specified in Table 9, VBW ≥ 3 x RBW, Detector = Peak, Sweep time = auto, Trace = Max hold.

If the peak – detected amplitude can be shown to comply with the average limit, then it is not necessary to perform a separate average measurement.

- Average Power measurements procedure refer to section 11.12.2.5.2 The EUT shall be configured to operate at the maximum achievable duty cycle. Measure the duty cycle D of the transmitter output signal as described in section 11.6. Set RBW = 1 ME, VBW \geq 3 x RBW, Detector = RMS, if span / (# of points in sweep) \leq (RBW/2). Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If this condition cannot be satisfied then the detector mode shall be set to peak.

Averaging type = power (i.e., RMS).

As an alternative the detector and averaging type may be set for linear voltage averaging. Some instruments require linear display mode in order to use linear voltage averaging. Log or dB averaging shall not be used. Sweep time = auto, Perform a trace average of at least 100 traces.

A correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:

- 1) If power averaging (rms) mode was used in step f), then the applicable correction factor is [10 log (1 / D)], where D is the duty cycle.
- 2) If a specific emission is demonstrated to be continuous (D ≥ 98%) rather than turning ON and OFF with the transmit cycle, then no duty cycled correction is required for that emission.
- 3. Definition of DUT Axis.

The radiation test of the EUT was investigated in three orthogonal orientations X, Y, and Z described in the test setup photo. All radiated testing of EUT was performed with worst case axis.

2.3.3. Test Procedures for Conducted Spurious Emissions

Per the guidance of ANSI C63.10-2013, section 11.11.1 & 11.11.2 & 11.11.3, the reference level for out of band emissions is established from the plots of this section since the band edge emissions are measured with a RBW of 100 kHz. This reference level is then used as the limit in subsequent plots for out of band spurious emissions shown in section 2.4.3. The limit for out of band spurious emission at the band edge is 20 dB below the fundamental emission level measured in a 100 kHz bandwidth.

1. Conducted Emissions at Band Edge

- The Measurement refer to section 11.11.3

Set the center frequency and span to encompass frequency range to be measured, the RBW = 100 kHz and VBW ≥ 3 x RBW, Detector = Peak, Sweep time = Auto couple, Trace mode = Max hold, The trace was allowed to stabilize.

2. Conducted Spurious Emissions

- The Measurement refer to section 11.11.3

Start frequency was set to 9 № and stop frequency was set to 25 № (separated into two plots per channel), RBW = 1 №, VBW ≥ 3 x RBW, Detector = Peak, Sweep time = Auto couple, Trace = Max hold, The trace was allowed to stabilize.






Low channel 2nd harmonic (Peak)






Low channel 2nd harmonic (Peak)



Middle channel 2nd harmonic (Peak)





According to RSS-247 Issue 3, 5.2(a), the minimum 6 dB bandwidth shall be 500 kHz.

The test follows section 11.8 DTS bandwidth of ANSI C63.10-2013. Tests performed using section 11.8.1 Option 1.

3.3.2. 99 % Bandwidth

The following conditions shall be observed for measuring the occupied bandwidth and $x \ \mathrm{d} B$ bandwidth:

- The transmitter shall be operated at its maximum carrier power measured under normal test conditions.
- The span of the spectrum analyzer shall be set large enough to capture all products of the modulation process, including the emission skirts, around the carrier frequency, but small enough to avoid having other emissions (e.g. on adjacent channels) within the span.
- The detector of the spectrum analyzer shall be set to "Sample". However, a peak, or peak hold, may be used in place of the sampling detector since this usually produces a wider bandwidth than the actual bandwidth (worst-case measurement). Use of a peak hold (or "Max Hold") may be necessary to determine the occupied / x dB bandwidth if the device is not transmitting continuously.
- ullet The resolution bandwidth (RBW) shall be in the range of 1 % to 5 % of the actual occupied / x ${
 m dB}$ bandwidth and the video bandwidth (VBW) shall not be smaller than three times the RBW value. Video averaging is not permitted.

Note: It may be necessary to repeat the measurement a few times until the RBW and VBW are in compliance with the above requirement.

For the 99 % emission bandwidth, the trace data points are recovered and directly summed in linear power level terms. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5 % of the total is reached, and that frequency recorded. The process is repeated for the highest frequency data points (starting at the highest frequency, at the right side of the span, and going down in frequency). This frequency is then recorded. The difference between the two recorded frequencies is the occupied bandwidth (or the 99 % emission bandwidth).

4.2. Limit

4.2.1. FCC

According to §15.247(b)(3), for systems using digital modulation in the 902-928 Mb, 2 400-2 483.5 Mb, and 5 725-5 850 Mb bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to §15.247(b)(4), the conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraph (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

4.2.2. IC

According to RSS-247 Issue 3, 5.4(d), for DTSs employing digital modulation techniques operating in the bands 902-928 Mb and 2 400-2 483.5 Mb, the maximum peak conducted output power shall not exceed 1 W. The e.i.r.p. shall not exceed 4 W, except as provided in section 5.4(e).

As an alternative to a peak measurement, compliance can be based on a measurement of the maximum conducted output power. The maximum conducted output power is the total transmit power delivered to all antennas and antenna elements, averaged across all symbols in the signalling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or transmitting at a reduced power level. If multiple modes of operation are implemented, the maximum conducted output power is the highest total transmit power occurring in any mode.

5.2. Limit

5.2.1 FCC

According to §15.247(e), for digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dB m in any 3 kllz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

5.2.2 IC

According to RSS-247 Issue 3, 5.2(b), the transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dB m in any 3 kb band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of section 5.4(d), (i.e. the power spectral density shall be determined using the same method as is used to determine the conducted output power).

5.3. Test Procedure

The measurements are recorded using the PKPSD measurement procedure in section 11.10.2 of ANSI C63.10-2013.

- This procedure shall be used if maximum peak conducted output power was used to demonstrate compliance, and is optional if the maximum conducted (average) output power was used to demonstrate compliance.
- 1. Set analyzer center frequency to DTS channel center frequency.
- 2. Set the span to 1.5 times the DTS bandwidth.
- 3. Set the RBW to 3 kHz ≤ RBW ≤ 100 kHz.
- 4. Set the VBW ≥ [3 x RBW].
- 5. Detector = peak.
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.
- 9. Use the peak marker function to determine the maximum amplitude level within the RBW.
- 10. If measured value exceeds requirement, then reduce RBW (but no less than 3 klb) and repeat.





Middle Channel







6.2. Limit

According to §15.207(a), for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 $\,\mathrm{Mz}$ to 30 $\,\mathrm{Mz}$, shall not exceed the limits in the following table, as measured using a 50 $\,\mathrm{\mu H}$ /50 ohms line impedance stabilization network (LISN).

Compliance with the provision of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

6.3. Test Procedures

AC conducted emissions from the EUT were measured according to the dictates of ANSI C63.10-2013.

- 1. The test procedure is performed in a 6.5 m \times 3.5 m \times 3.5 m (L \times W \times H) shielded room. The EUT along with its peripherals were placed on a 1.0 m (W) \times 1.5 m (L) and 0.8 m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane.
- 2. The EUT was connected to power mains through a line impedance stabilization network (LISN) which provides 50 ohm coupling impedance for measuring instrument and the chassis ground was bounded to the horizontal ground plane of shielded room.
- 3. All peripherals were connected to the second LISN and the chassis ground also bounded to the horizontal ground plane of shielded room.
- 4. The excess power cable between the EUT and the LISN was bundled. The power cables of peripherals were unbundled. All connecting cables of EUT and peripherals were moved to find the maximum emission.





7. Antenna Requirement

7.1. Standard Applicable

For intentional device, according to FCC 47 CFR Section $\S15.203$, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. And according to FCC 47 CFR Section $\S15.247(b)$ if transmitting antennas of directional gain greater than $6~\mathrm{dB}~\mathrm{i}$ are used, the conducted output power shall be reduced appropriate, by the amount in dB that the directional gain of the antenna exceeds $6~\mathrm{dB}~\mathrm{i}$.

7.2. Antenna Connected Construction

Antenna used in this product is PCB Pattern Antenna with gain of 1.75 dB i.
