1. Please correct the following typo: p.23/61 of the PCE EMC report, the top of the page lists WCDMA850 as the modulation signal instead of WCDMA1900.

2. Please correct the following typo: p.3 of the JBP (15B) report lists an incorrect WCDMA1900 transmit frequency range (in 2 places).

3. Page 23 of the SAR report lists the antenna separation distance as 1.0 cm, while the antenna location photo shows 0.7 cm. Please reconcile.

4. Please provide 2450 MHz System Verification SAR results using the dominant tissue type (muscle) for the test dates. Please note that this is the same issue as in previous applications- we are waiting for you to submit the FCC's response to the SAR lab's request for relief from this requirement.

5. FYI: regarding the 15B testing, ANSI C63.4 requires that all devices located at the back of the test stand be flush with the back edge of the table. In the future, please be sure that this is the case.
