


Fig.1 Photograph of the SAR measurement system

## Photograph of the Tissue Simulant Fluid liquid depth








Photograph 2. Body, Bottom Surface, 0mm




Photograph 3. Body, Back Surface, 0mm




Photograph 7. Body, Bottom Edge, 0mm




Photograph 8. Body, Bottom Edge, 0mm




Photograph 9. Body, Right Edge, 0mm






Photograph 19. Body, Bottom Edge, 0mm




Photograph 20. Body, Bottom Edge, 0mm




Photograph 21. Body, Right Edge, 0mm
