





5.3. Test Procedure

- 5.3.1. To set up the EUT as indicated in ANSI C63.10. The EUT was placed on the table which has 80 cm height to the ground and 40 cm distance to the conducting wall.
- 5.3.2. Power supplier of the EUT was connected to the AC mains through an Artificial Mains Network (A.M.N.).
- 5.3.3. The AC power supplies to all peripheral devices must be provided through line impedance stabilization network (L.I.S.N.)
- 5.3.4. Checking frequency range from 150kHz to 30 MHz and record the emission which does not have 20 dB below limit.








6.1. Block Diagram of Test Setup

6.1.2. Setup Diagram for 9kHz-30MHz




6.1.3. Setup Diagram for 30-1000MHz






6.1.4. Setup Diagram for above 1GHz

6.2. Radiated Emission Limits

In any 100kHz bandwidth outside the frequency band, the radio frequency power produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level. In addition, radiated emissions which fall in restricted bands, as defined in Section 15.205/RSS-Gen Section 8.10 table 6, must also comply with the radiated emission limits specified as below.

- (2) The tighter limit applies to the edge between two frequency bands.
- (3) Distance refers to the distance in meters between the measuring instrument antenna and the closed point of any part of the device or system.
- (4) Fundamental and emission fall within operation band are exempted from this section.
- (5) Pursuant to ANSI C63.10: 6.6.4.3, if the maximized peak measured value complies with the average limit, then it is unnecessary to perform an average measurement.

6.3. Test Procedure

Frequency Range 9kHz~30MHz:

The EUT setup on the turntable which has 0.8 m height to the ground. The turn table rotated 360 degrees and antenna fixed to 1 m to find the maximum emission level. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10-2013 regulation.

- (1) RBW = 9kHz with peak and average detector.
- (2) Detector: average and peak (9kHz-490kHz)

Q.P. (490kHz-30MHz)

Frequency Range 30MHz ~ 25GHz:

The EUT setup on the turn table which has 80cm (for 30-1000MHz) and 1.5m (for above 1GHz) height to the ground. The turn table rotated 360 degrees and antenna varied from 1 m to 4 m (for 30-1000MHz) and from 1m to 3m (for above 1GHz at fully Anechoic Chamber)or from 1 m to 4 m (for above 1GHz at Semi Anechoic Chamber) to find the maximum emission level. Both horizontal and vertical polarization are required. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10-2013 regulation.

Frequency below 1GHz:

Spectrum Analyzer is used for pre-testing with following setting:

- (1)RBW = 120KHz
- $(2)VBW > 3 \times RBW$.
- (3)Detector = Peak.
- (4)Sweep time = auto.
- (5)Trace mode = max hold.
- (6) Allow sweeps to continue until the trace stabilizes.
- Note 1: When peak-detected value is lower than limit that the measurement using the Q.P. detector is not required, otherwise using Q.P. for final measurement.
- Note 2: When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds.

Frequency above 1GHz to 10th harmonic(up to 25 GHz): Peak Detector:

- (1)RBW = 1MHz
- (2)VBW $\geq 3 \times RBW$.
- (3)Detector = Peak.
- (4)Sweep time = auto.
- (5)Trace mode = max hold.
- (6) Allow sweeps to continue until the trace stabilizes.

Note: When peak-detected value is lower than limit that the measurement using the average detector is not required, otherwise using average detector for final measurement.



Average Detector:

Option 1:

- (1)RBW = 1MHz
- $(2)VBW \ge 1/T$.
- (3)Detector = Peak.
- (4)Sweep time = auto.
- (5)Trace mode = max hold.
- (6) Allow sweeps to continue until the trace stabilizes.



Alternatively, frequency hopping systems operating in the 2400-2483.5MHz band may have hopping channel carrier frequencies that are separated by 25kHz or two-thirds of the 20dB bandwidth of the hopping channel, whichever is greater.

7.3. Test Procedure

Following measurement procedure is reference to ANSI C63.10:2013:

For 20dB Bandwidth

- (1) Set Span range 2~5 times the OBW
- (2) Set VBW≥3xRBW.
- (3) Detector = Peak.
- (4) Trace mode = Max hold.
- (5) Sweep = Auto couple.
- (6) Allow the trace to stabilize.
- (7) Setting channel bandwidth function x dB to -20 dB to record the final bandwidth.



8.2. Specification Limits

Alternatively, frequency hopping systems operating in the 2400-2483.5MHz band may have hopping channel carrier frequencies that are separated by 25kHz or two-thirds of the 20dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output no greater than 125mW.

8.3. Test Procedure


Following measurement procedure is reference to ANSI C63.10:2013:

- (1) Span = Wide enough to capture the peaks of two adjacent channels
- (2) RBW: Start with the RBW set to approximately 30% of the channel spacing; adjust as necessary to best identify the center of each individual channel.
- (3) $VBW \ge RBW$
- (4) Sweep = Auto
- (5) Detector function = Peak
- (6) Trace = Max hold

9. TIME OF OCCUPANCY

9.2. Specification Limits

Frequency hopping systems in the 2400-2483.5MHz shall use at least 15 non-overlapping channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by number of hopping channels employed.

9.3. Test Procedure


Following measurement procedure is reference to ANSI C63.10:2013:

- (1) Span: Zero span, centered on a hopping channel.
- (2) RBW shall be \leq channel spacing and where possible RBW should be set >> 1/T, where T is the expected dwell time per channel.
- (3) Sweep: As necessary to capture the entire dwell time per hopping channel; where possible use a video trigger and trigger delay so that the transmitted signal starts a little to the right of the start of the plot. The trigger level might need slight adjustment to prevent triggering when the system hops on an adjacent channel; a second plot might be needed with a longer sweep time to show two successive hops on a channel.
- (4) Detector function = Peak
- (5) Trace = Max hold

10.2. Specification Limits

Frequency hopping systems which use fewer than 20 hopping frequencies may employ intelligent hopping techniques to avoid interference to other transmissions. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 non-overlapping channels.

10.3.Test Procedure


Following measurement procedure is reference to ANSI C63.10:2013:

- (1) Span: The frequency band of operation. Depending on the number of channels the device supports, it may be necessary to divide the frequency range of operation across multiple spans, to allow the individual channels to be clearly seen.
- (2) RBW: To identify clearly the individual channels, set the RBW to less than 30% of the channel spacing or the 20 dB bandwidth, whichever is smaller.
- (3) $VBW \ge RBW$
- (4) Sweep = Auto



12.2. Specification Limits

In any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, that the required attenuation shall be 30 dB instead of 20 dB.

Attenuation below the general limits specified in Section 15.209(a)/RSS-Gen Section 8.9table 4is not required. In addition, radiated emissions which fall in restricted bands, asdefined in Section 15.205(a)/RSS-Gen Section 8.10 table 6,, must also comply withthe radiated emission limits specified in Section 15.209(a)/RSS-Gen Section 8.9 table 4 (See Section 15.205(c)).

12.3. Test Procedure

Following measurement procedure is reference to ANSI C63.10:2013:

- (1) Set span wide enough to capture the peak level of the in-band emission and all spurious emissions; up to 10th harmonic.
- (2) RBW = 100 kHz
- (3) $VBW \ge RBW$
- (4) Sweep = Auto
- (5) Detector function = Peak
- (6) Trace = Max hold
