- 1. The change note document is titled "Change Note Sample". Please confirm that this is the complete list of changes for the EUT.
 - ==> We confirm that this is the complete list.
- 2. The limits provided for 835MHz head in the tissue verification table in section 8.1 of the SAR test report are incorrect since the probe calibration is greater than 50MHz from the measured band per IEEE 1528. Please revise and ensure that the parameter deviations are within these tighter limits.
 - ==> Please double check the Probe Calibration data on page 100, 101 of 120. We used the correct ConV. Factor.
- 3. The FCC has stated that the inclusion in the SAR report of body SAR data for the front of the phone facing the body where the measurement separation distance is in excess of 5mm must be justified (e.g., in order to cover the potential situation where an accessory positions the phone with its front facing the user). Please revise the SAR report accordingly. Alternatively, the body-worn front facing phantom data may be removed from the test report.
 - ==> We removed the front data from the report. Please find the revised SAR report.
- 4. The page numbers for all sections listed in the Table of Contents in the 22/24 Test report refer to the same page number. Please revise.
