1.0 GENERAL DESCRIPTION

1.1 Product Description

The Equipment Under Test (EUT) is a Wireless Door Chime Transmitter (315MHz Wireless push button). When the button of the EUT is activated, the corresponding 315MHz remote door bell receiver (Wireless Plug-in Chime) will sound. No battery is needed as the EUT is powered by the electro-motive force generated by the induction coil activated by mechanical bouncing energy at the releasing moment of the push button. The EUT will be deactivated after the button bouncing.

Antenna Type: Internal, Integral

For electronic filing, the brief circuit description is saved with filename: descri.pdf.

1.2 Related Submittal(s) Grants

This is a single application for certification of a transmitter.

1.3 Test Methodology

Radiated emission measurements were performed according to the procedures in ANSI C63.10 (2013). All radiated measurements were performed in an 3m Chamber. Preliminary scans were performed in the 3m Chamber only to determine worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application.

1.4 Test Facility

The 3m Chamber used to collect the radiated data is located at Workshop No. 3, G/F., World-Wide Industrial Centre, 43-47 Shan Mei Street, Fo Tan, Sha Tin, N.T., Hong Kong. This test facility and site measurement data have been placed on file with the FCC and IC No. 2042H.



2.0 SYSTEM TEST CONFIGURATION

2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.10 (2013).

The device was powered by 3.0V DC power supply during test.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The unit was operated standalone and placed in the center of the turntable.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was mounted to a plastic stand if necessary and placed on the wooden turntable, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

2.2 EUT Exercising Software

There was no special software to exercise the device. Once the unit is powered up, it transmits the RF signal continuously.

2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

2.4 Measurement Uncertainty

When determining of the test conclusion, the Measurement Uncertainty of test has been considered.

3.0 EMISSION RESULTS

Data is included of the worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any), Average Factor (optional) from the measured reading. The basic equation with a sample calculation is as follows:

FS = RA + AF + CF - AG - AV

where $FS = Field Strength in dB\mu V/m$

RA = Receiver Amplitude (including preamplifier) in $dB\mu V$

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB AG = Amplifier Gain in dB AV = Average Factor in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain. An example for the calculations in the following table is as follows:

FS = RR + LF

where $FS = Field Strength in dB\mu V/m$

RR = RA - AG - AV in $dB\mu V$

LF = CF + AF in dB

Assume a receiver reading of 52.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB are added. The amplifier gain of 29 dB and average factor of 5 dB are subtracted, giving a field strength of 32 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

 $RA = 52.0 dB\mu V/m$

 $AF = 7.4 \text{ dB} \qquad \qquad RR = 18.0 \text{ dB}\mu\text{V}$

CF = 1.6 dB LF = 9.0 dB

AG = 29.0 dBAV = 5.0 dB

 $FS = 18 + 9 = 27 dB\mu V/m$

Level in $\mu V/m = Common Antilogarithm [(27 dB<math>\mu V/m)/20] = 22.4 \mu V/m$



3.2 Radiated Emission Configuration Photograph

The worst case in radiated emission was found at 315.005 MHz




8.0 MISCELLANEOUS INFORMATION

Timing Plot – Pursuant to FCC Part 15 Section 15.231(a1)- A manually operated transmitter shall employ a switch that will automatically deactivate the transmitter within not more than 5 seconds of being released.



8.1 Measured Bandwidth

The plot shows the fundamental emission when modulated. From the plot, the bandwidth is observed to be 31.8Hz, at 20dBc where the bandwidth limit is 787.5kHz.





8.2 Discussion of Pulse Desensitization

Pulse desensitivity is not applicable for this device. The effective period (Teff) is approximately 21.648ms for a digital "1" bit which illustrated on technical specification, with a resolution bandwidth (3dB) of 1MHz, so the pulse desensitivity factor is 0dB.

8.3 Calculation of Average Factor

The duty cycle is simply the on-time divided by the period:

The duration of one cycle = 100ms


Effective period of the cycle = $4 \times 4.8 \text{ms} + 1 \times 2.4 \text{ms} + 1 \times 48 \mu \text{s} = 21.648 \text{ms}$


DC = 21.648 / 100 = 0.21648ms

Therefore, the averaging factor is found by 20log 0.21648 = -13.3dB.







8.4 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services Hong Kong Ltd. in the measurements of transmitter operating under the Part 15, Subpart C rules.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately 0.8m in height above the ground plane for emission measurement at or below 1GHz and 1.5m in height above the ground plane for emission measurement above 1GHz. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axis to obtain maximum emission levels. The antenna height and polarization are also varied during the testing to search for maximum signal levels. The height of the antenna is varied from one to four meters.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in Exhibit 8.3.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.



8.4 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements were made as described in ANSI C63.10 (2013).

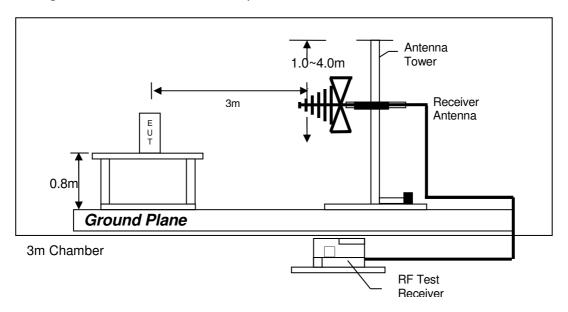
The IF bandwidth used for measurement of radiated signal strength was 100 kHz or greater when frequency is below 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. A discussion of whether pulse desensitivity is applicable to this unit is included in this report (See Exhibit 8.1). Above 1000 MHz, a resolution bandwidth of 3 MHz is used.

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the forbidden bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, unless otherwise reported. Measurements taken at a closer distance are so marked.

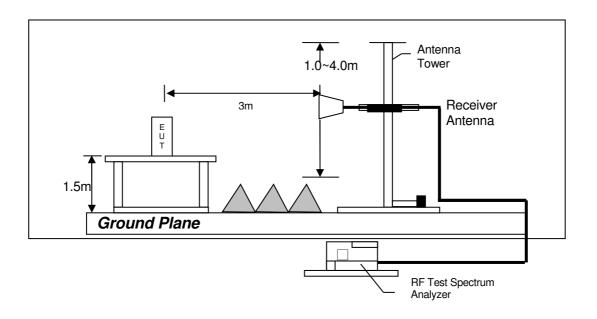

Test setup of radiated emissions above 1GHz


