The System receiver have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shift frequencies in synchroniztation with the transmitted signals.

B) All channels are used equally on average

C) The receiver input bandwidth equals the transmit bandwidth

D) The receiver hops in sequence with the transmit signal

- 15.247(g) : In accordance with the Bluetooth Industry Standard, the system is designed to comply with all of the regulations in Section 15.247 when the transmitter is presented with a continuous data (or information) system.
- 15.247(h) : In accordance with the Bluetooth Industry Standard, the system does not coordinate its channels selection / hopping sequence with other frequency hopping systems for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters.
- 15.247(h) : The EUT employs Adaptive Frequency Hopping (AFH) which identifies sources of interference namely devices operating in 802.11 WLAN and excludes them from the list of available channels. The process of re-mapping reduces the number of test channels from 79 channels to a minimum number of 20 channels.

2.1 Test Setup

2.2 Limit

■ FCC Requirements

The maximum peak output power of the intentional radiator shall not exceed the following :

1. §15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.
2. §15.247(b)(1), For frequency hopping systems operating in the 2400 – 2483.5 MHz employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725 – 5805 MHz band : 1 Watt. For all other frequency hopping systems in the 2400-2483.5 MHz band: 0.125 watts.

■ IC Requirements

1. RSS-247(5.4) (b), For FHSS operating in the band 2400 - 2483.5 MHz, the maximum peak conducted output power shall not exceed 1.0 W if the hopset uses 75 or more hopping channels, the maximum peak conducted output power shall not exceed 0.125 W if the hopset uses less than 75 hopping channels. The e.i.r.p shall not exceed 4 W, except as provided in section 5.4(e)

2.3 Test Procedure

1. The RF output power was measured with a spectrum analyzer connected to the RF Antenna connector (conducted measurement) while EUT was operating in transmit mode at the appropriate center frequency, A spectrum analyzer was used to record the shape of the transmit signal.
2. The peak output power of the fundamental frequency was measured with the spectrum analyzer using ;
Span = approximately 5 times of the 20 dB bandwidth, centered on a hopping channel
RBW $\geq$ 20 dB BW
VBW $\geq$ RBW
Sweep = auto

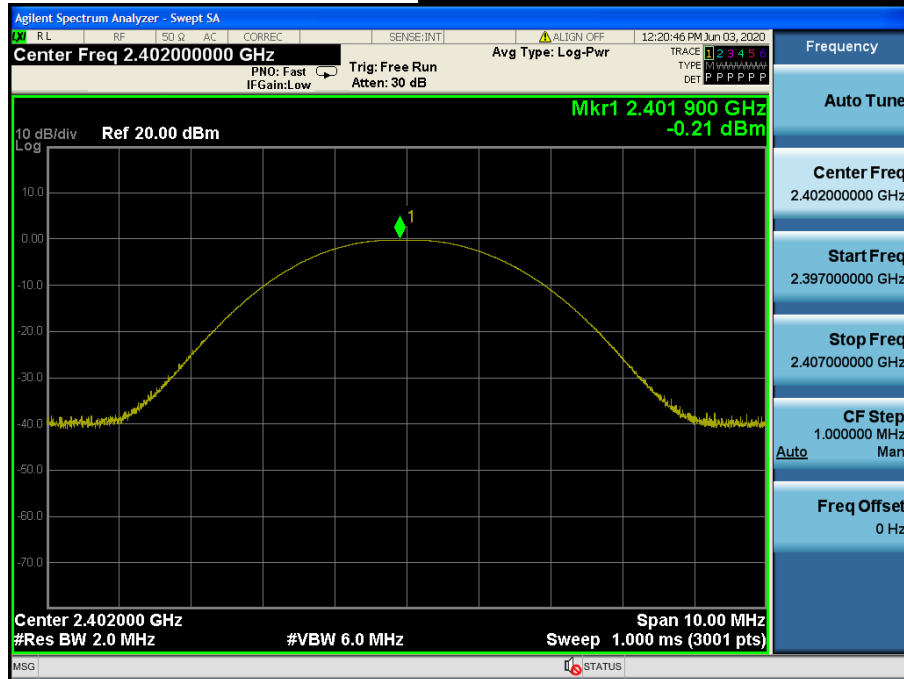

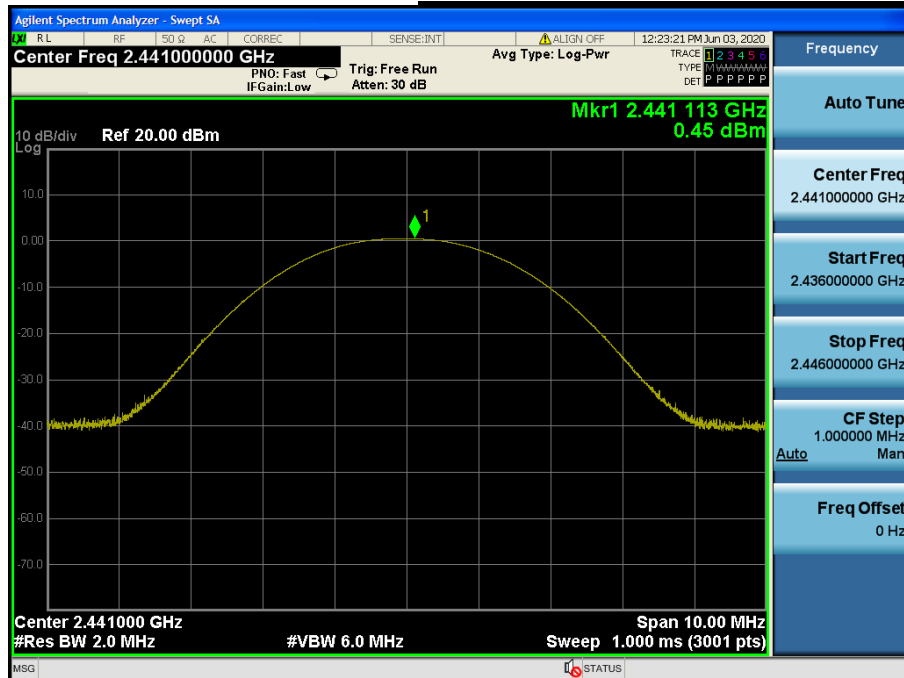
Peak Output Power

Lowest Channel & Modulation : GFSK



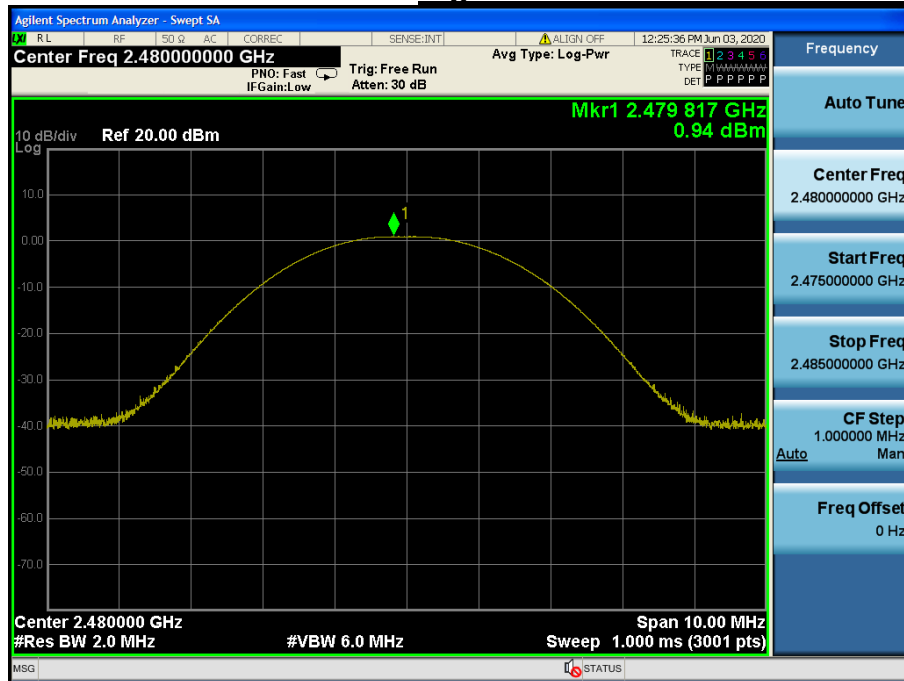
Peak Output Power

Middle Channel & Modulation : GFSK



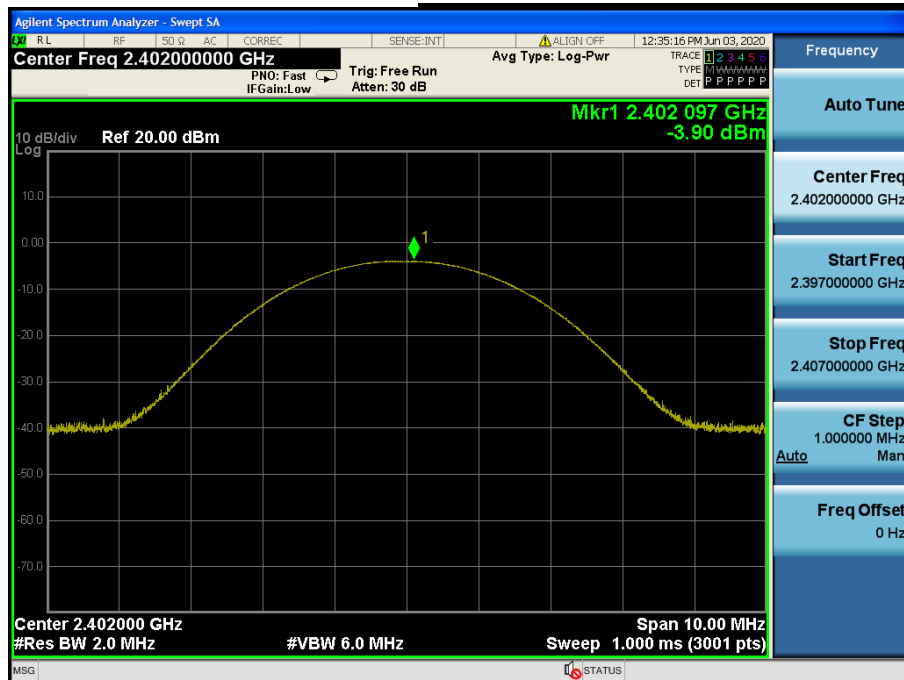
Peak Output Power

Highest Channel & Modulation : GFSK



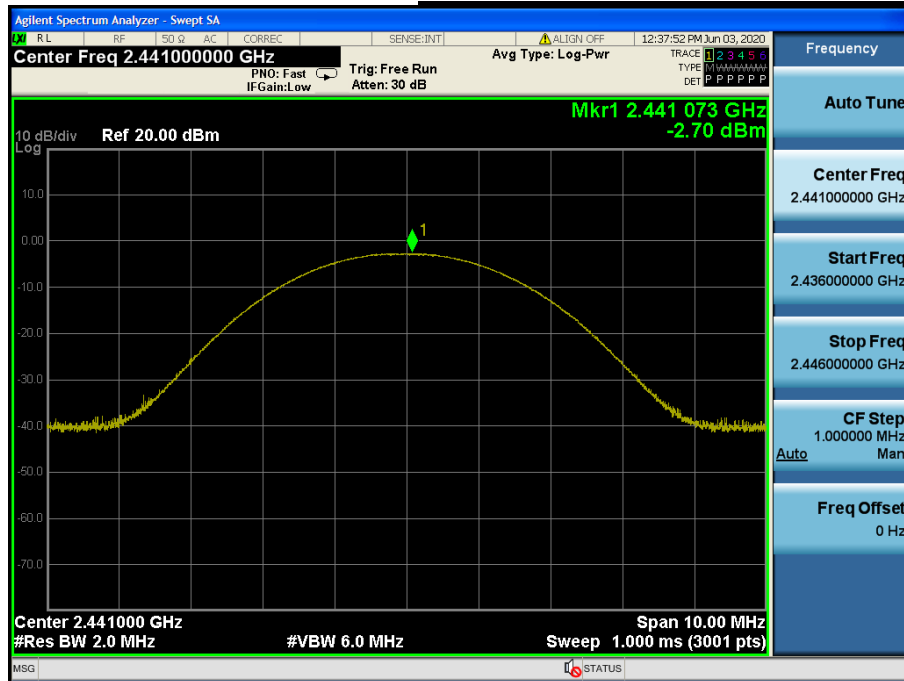

Lowest Channel & Modulation : $\pi/4$ DQPSK



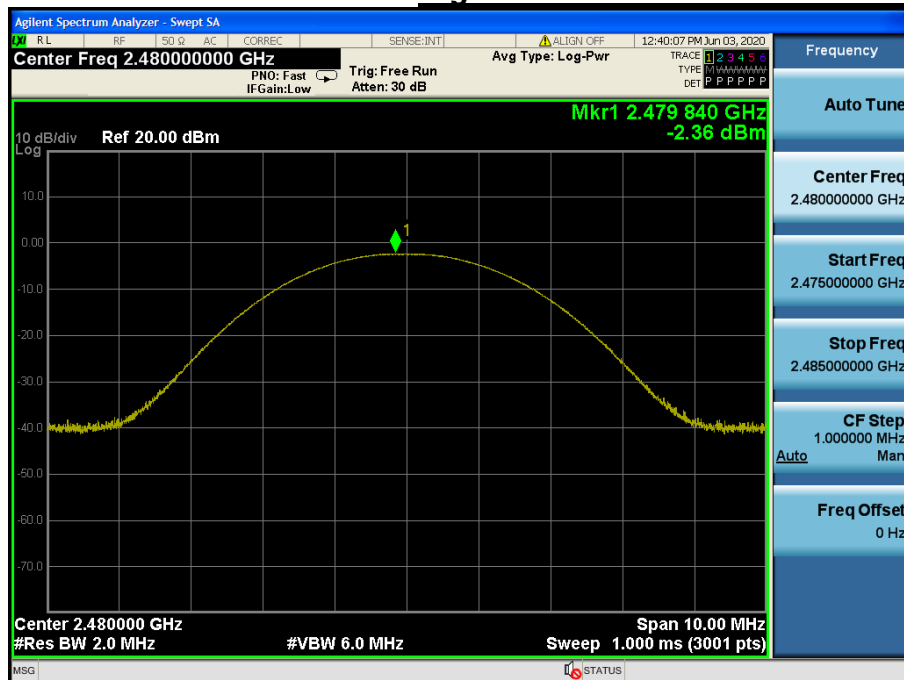

Middle Channel & Modulation : $\pi/4$ DQPSK



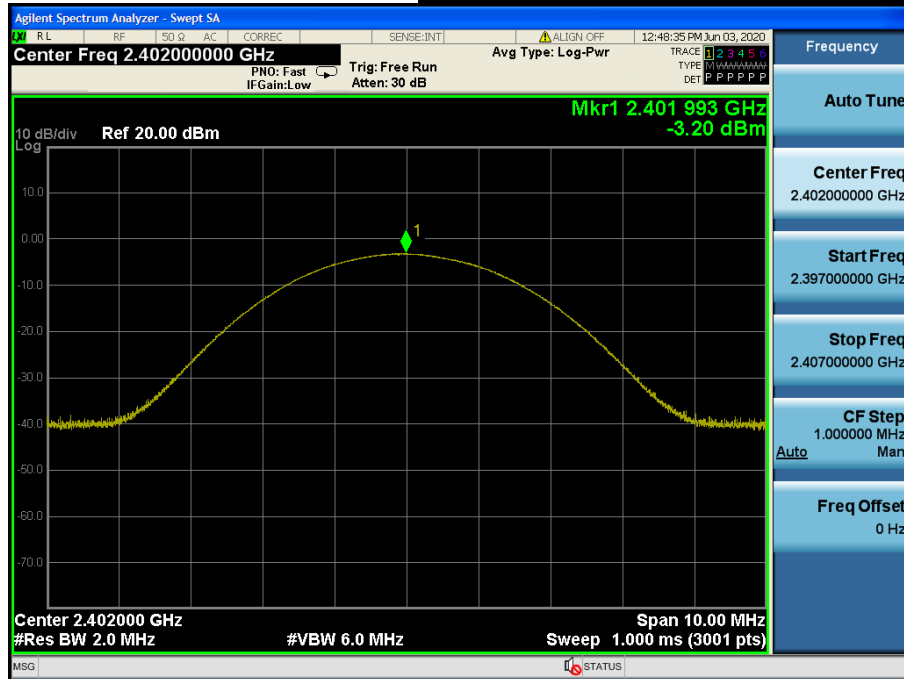

Highest Channel & Modulation : $\pi/4$ DQPSK



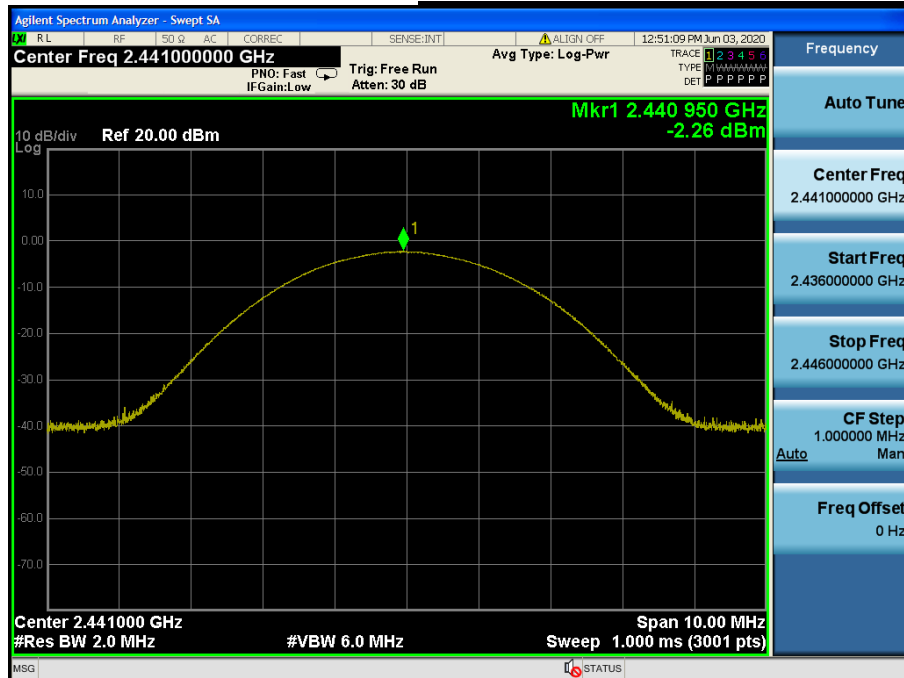

Lowest Channel & Modulation : 8DPSK



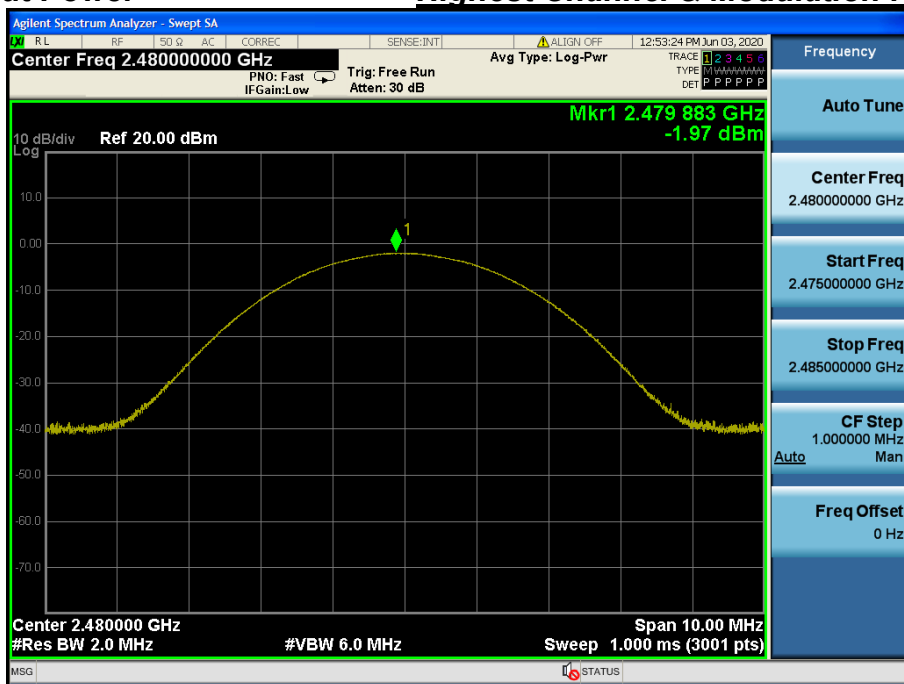

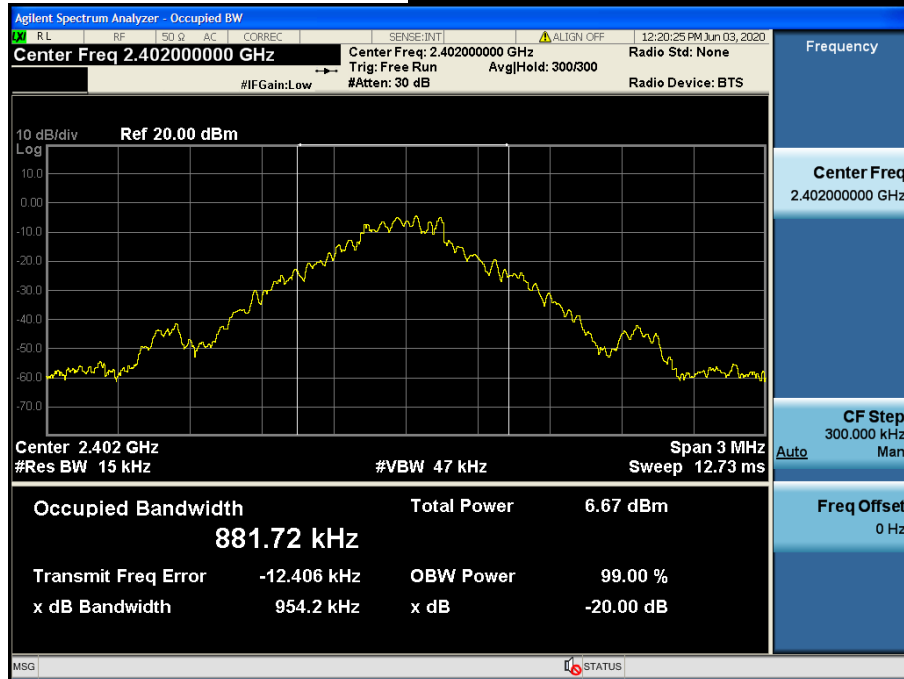
1. The 20 dB bandwidth & Occupied bandwidth were measured with a spectrum analyzer connected to RF antenna Connector(conducted measurement) while EUT was operating in transmit mode. The analyzer center frequency was set to the EUT carrier frequency, using the analyzer.
2. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using below setting:
RBW = 1% to 5% of the 20 dB BW & Occupied BW
VBW $\geq 3 \times$ RBW
Span = between two times and five times the 20 dB bandwidth & Occupied BW
Sweep = auto

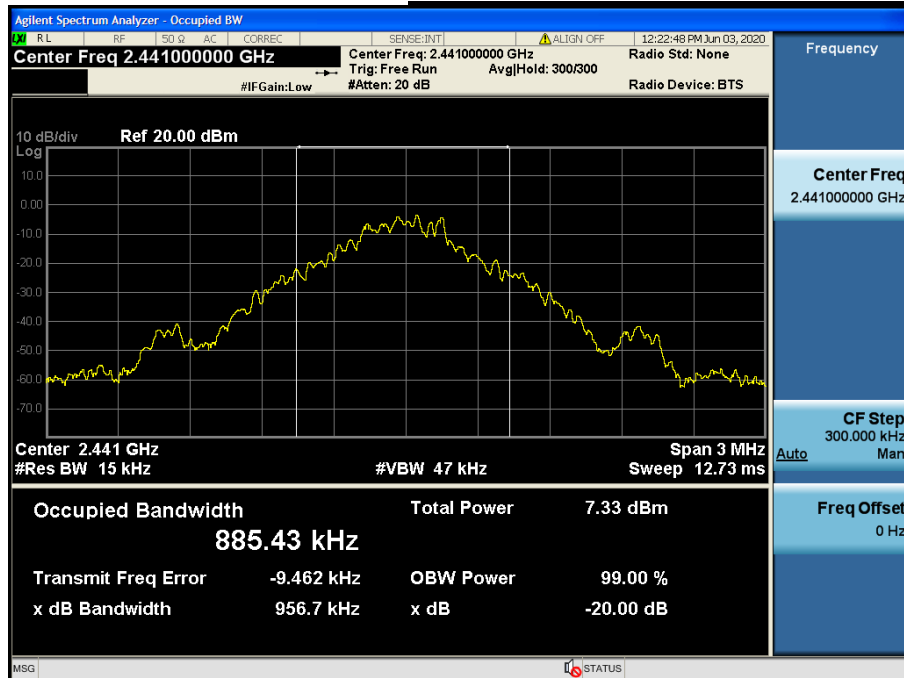

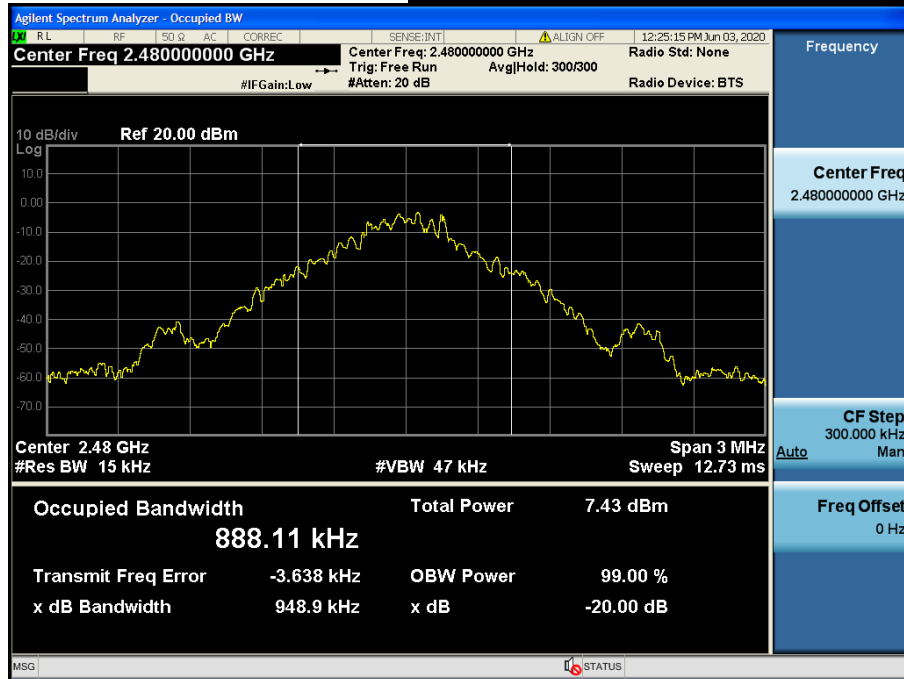

Middle Channel & Modulation : GFSK



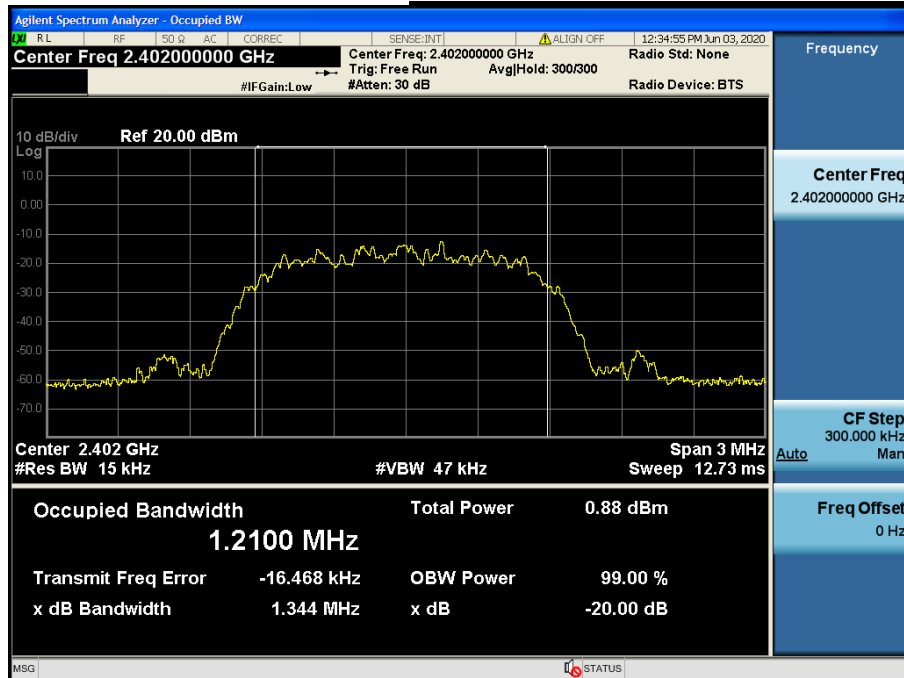

Lowest Channel & Modulation : 8DPSK

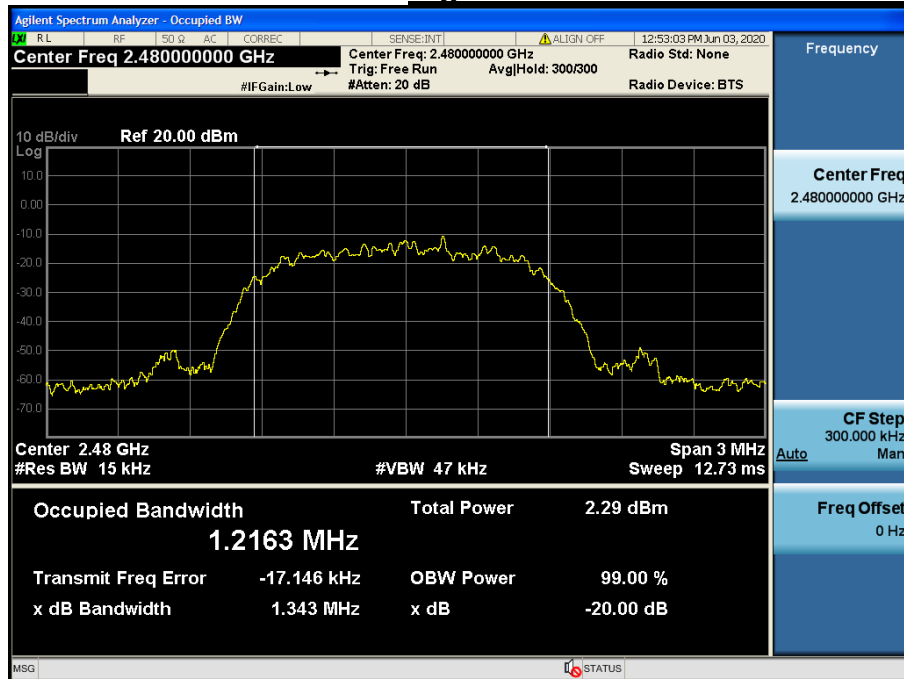

4. Carrier Frequency Separation

4.1 Test Setup

Refer to the APPENDIX I.

4.2 Limit

Limit : ≥ 25 kHz or $\geq$ Two-Thirds of the 20 dB BW whichever is greater.

4.3 Procedure

The carrier frequency separation was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function enabled.

After the trace being stable, the reading value between the peaks of the adjacent channels using the marker-delta function was recorded as the measurement results.

The spectrum analyzer is set to :

Span = wide enough to capture the peaks of two adjacent channels

RBW = Start with the RBW set to approximately 30% of the channel spacing; adjust as necessary to best identify the center of each individual channel.

VBW $\geq$ RBW

Sweep = auto

Detector function = peak

Trace = max hold

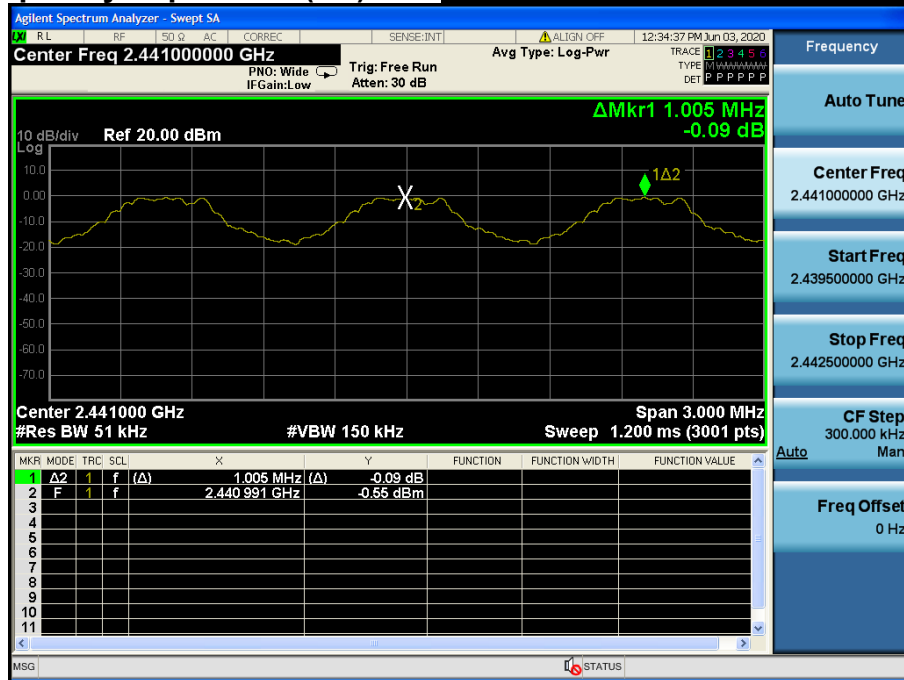

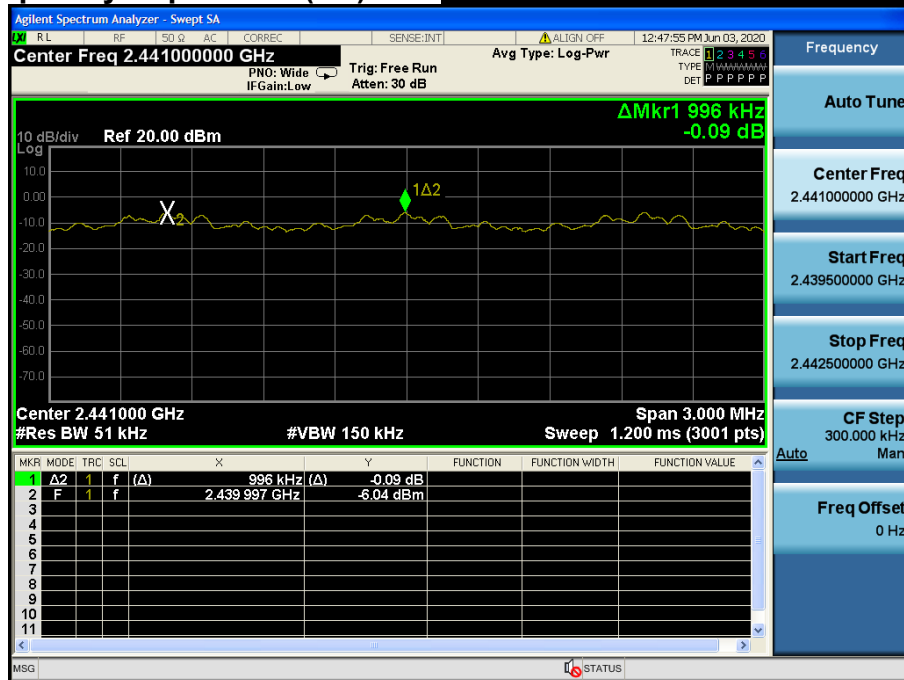

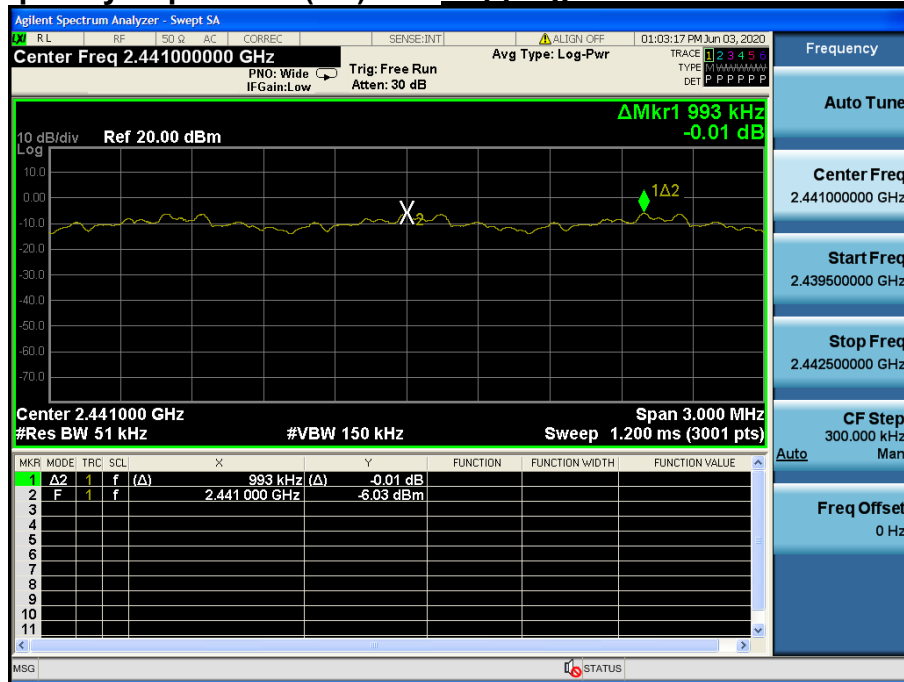
Carrier Frequency Separation (FH) *Hopping mode : Enable & GFSK*



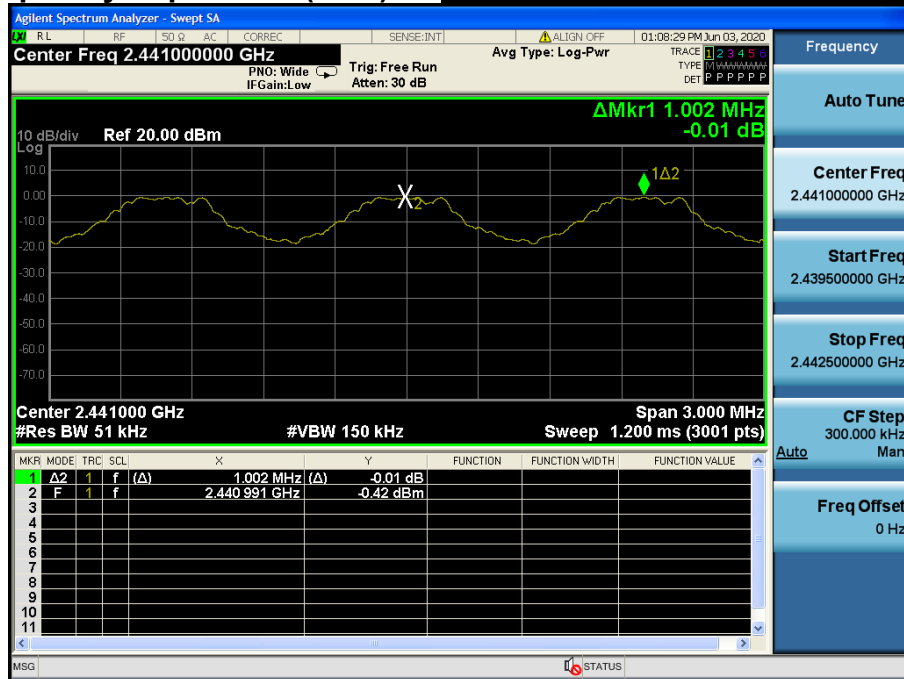
Carrier Frequency Separation (FH) *Hopping mode : Enable & π/4DQPSK*



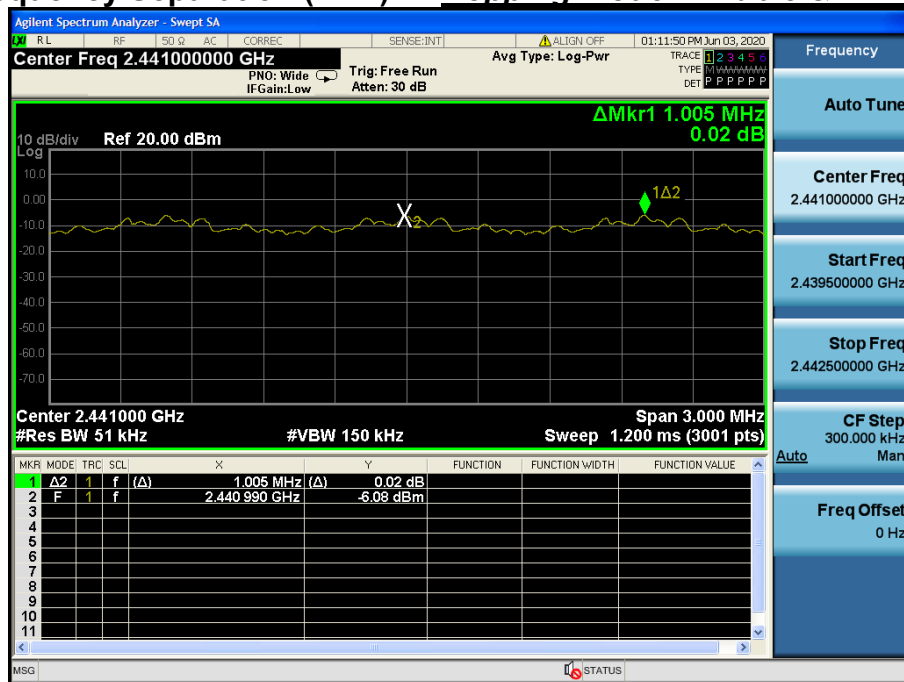
Carrier Frequency Separation (FH) *Hopping mode : Enable & 8DPSK*



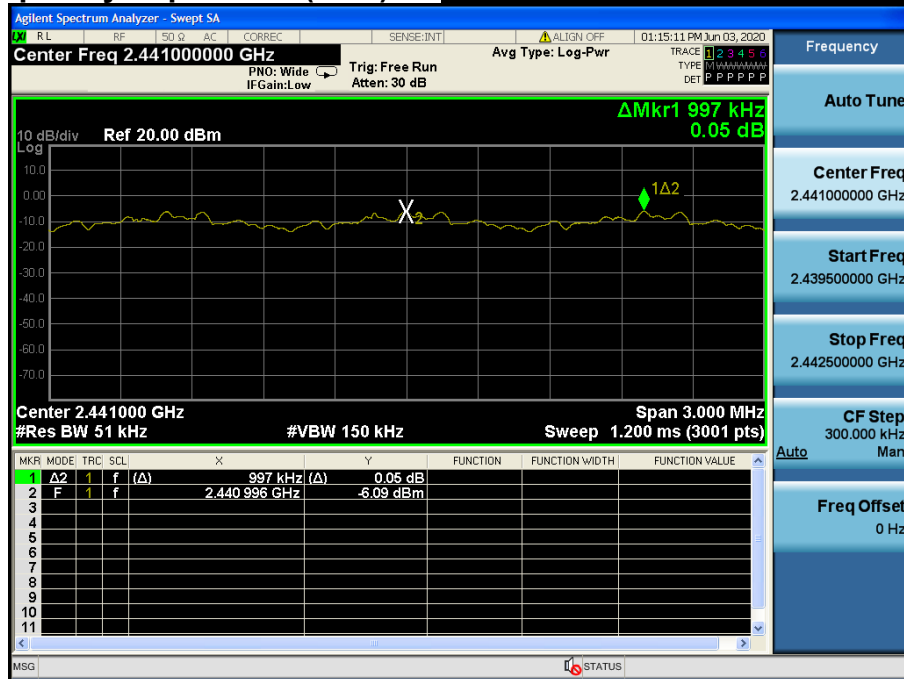
Carrier Frequency Separation (AFH) *Hopping mode : Enable & GFSK*

5.3 Procedure

The number of hopping frequencies was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function enabled.

To get higher resolution, two frequency ranges for FH mode within the 2400 ~ 2483.5 MHz were examined.

The spectrum analyzer is set to :

Span for FH mode = 50 MHz Start Frequency = 2 391.5 MHz, Stop Frequency = 2 441.5 MHz

Start Frequency = 2 441.5 MHz, Stop Frequency = 2 491.5 MHz

Span for AFH mode = 30 MHz Start Frequency = 2 426.0 MHz, Stop Frequency = 2 456.0 MHz

RBW = To identify clearly the individual channels, set the RBW to less than 30% of the channel spacing or the 20 dB bandwidth, whichever is smaller.

VBW $\geq$ RBW

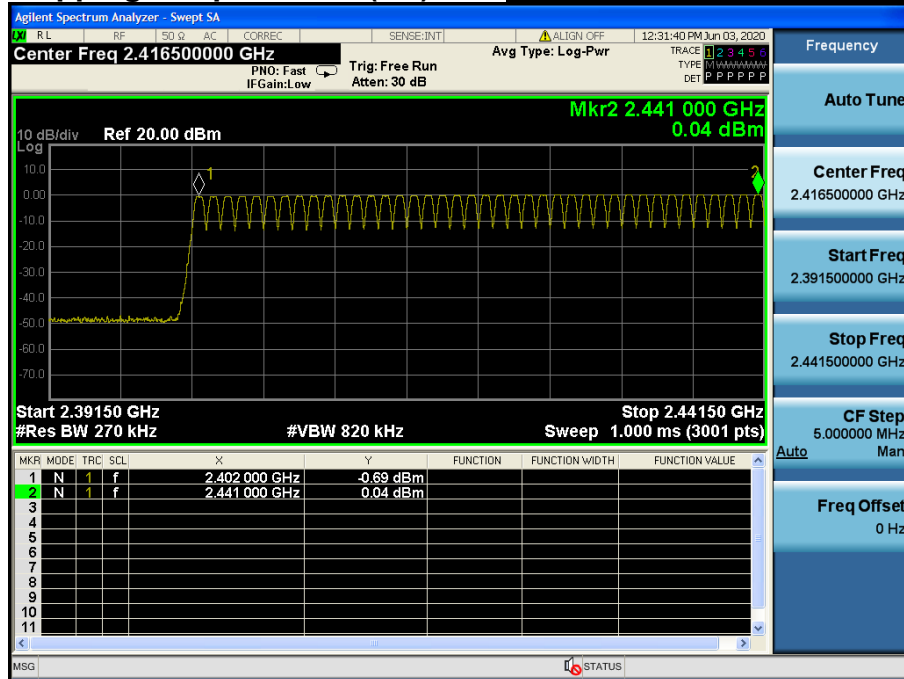

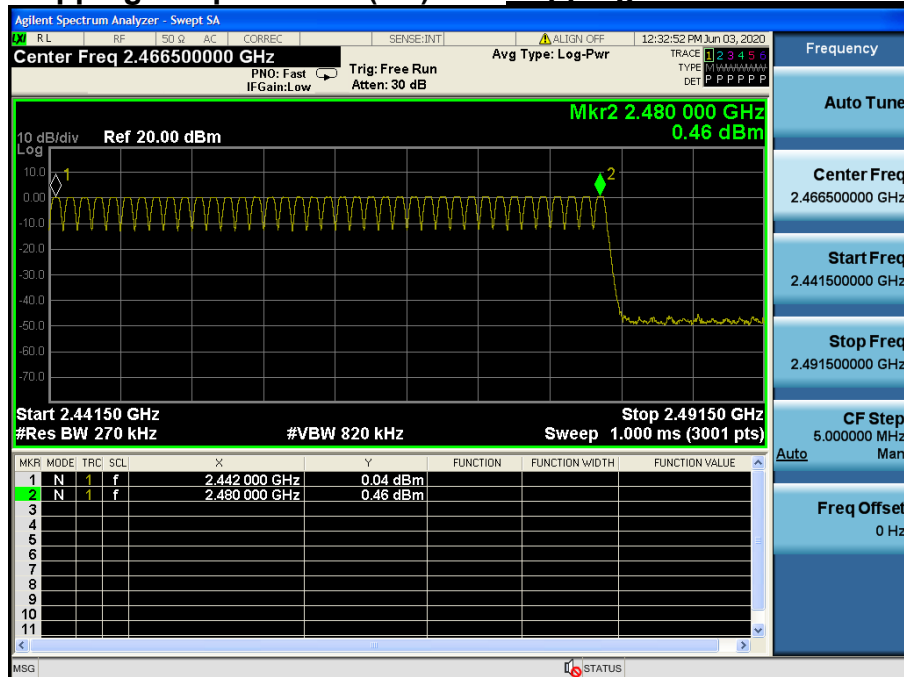

Number of Hopping Frequencies 1(FH) *Hopping mode : Enable & GFSK*

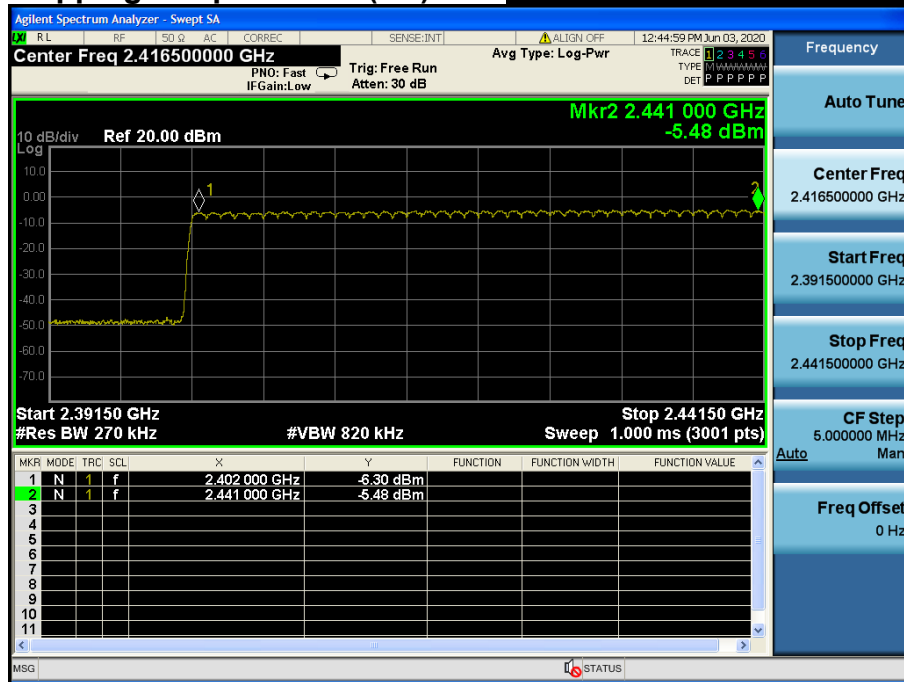


Number of Hopping Frequencies 2(FH) *Hopping mode : Enable & GFSK*



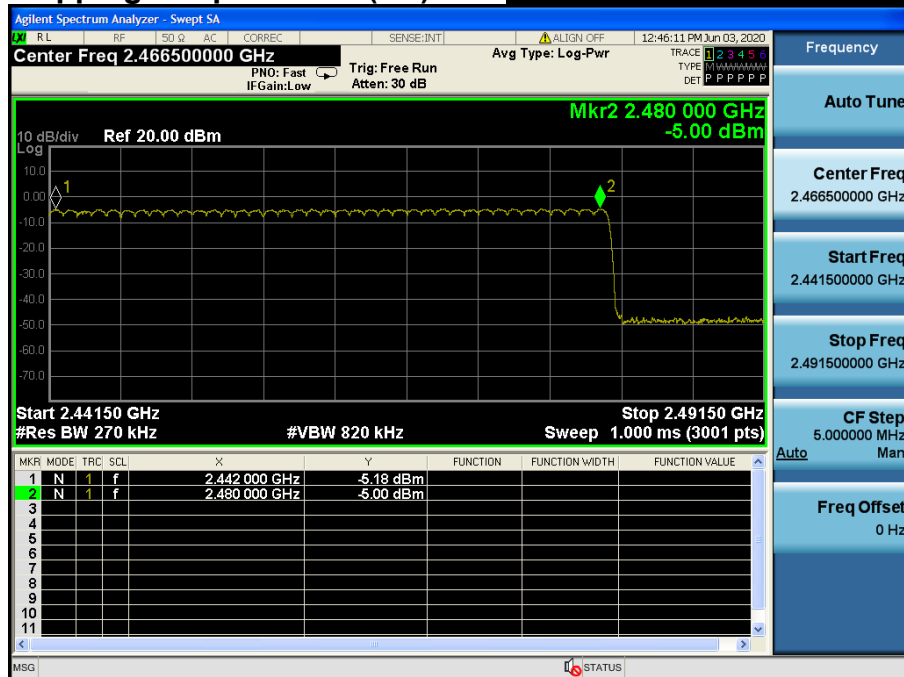

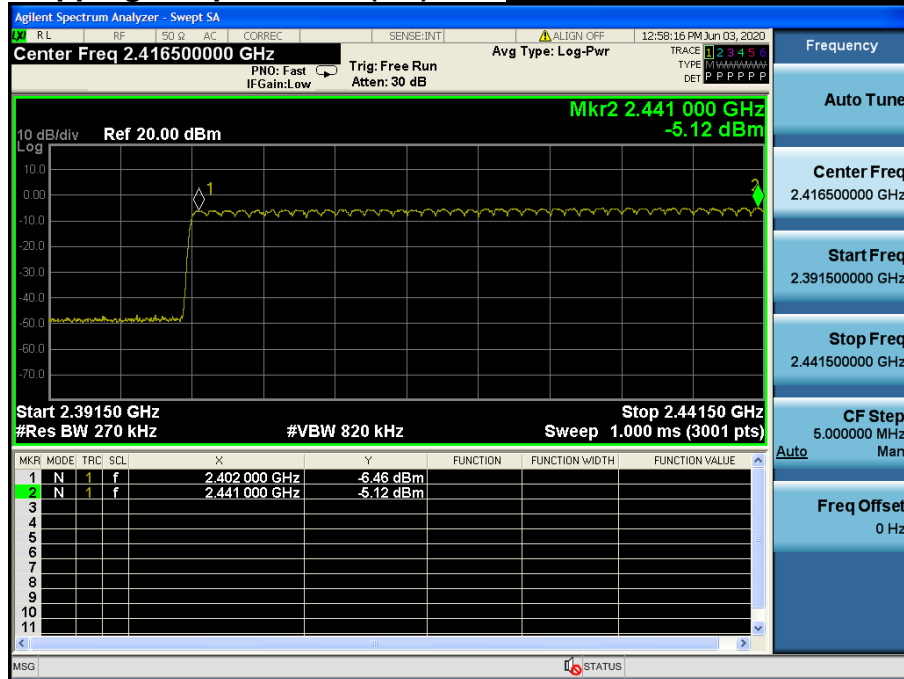


Number of Hopping Frequencies 2(FH)

Hopping mode : Enable & $\pi/4$ DQPSK



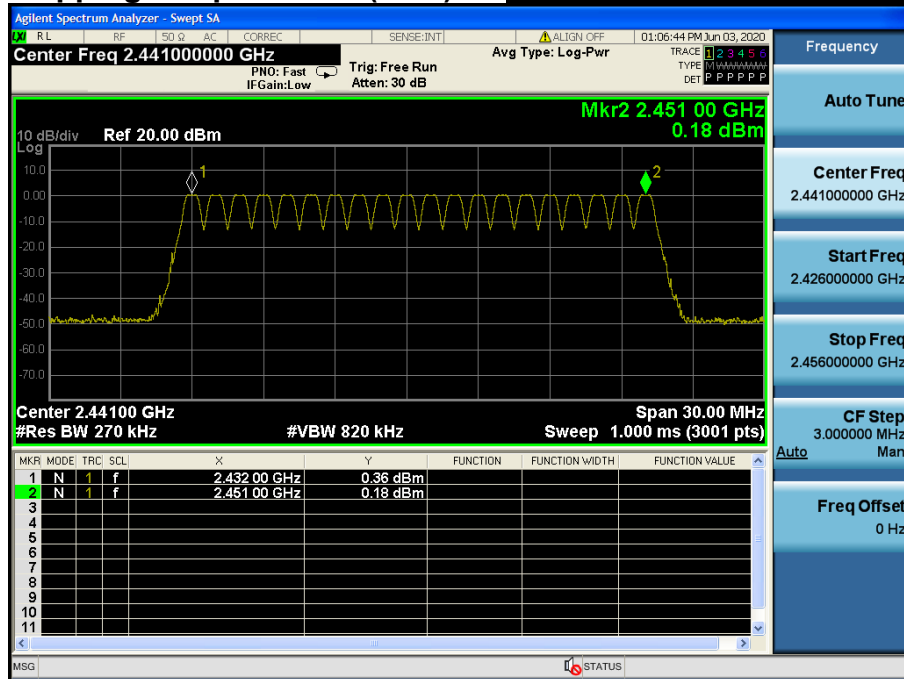
Number of Hopping Frequencies 1(FH) *Hopping mode : Enable & 8DPSK*



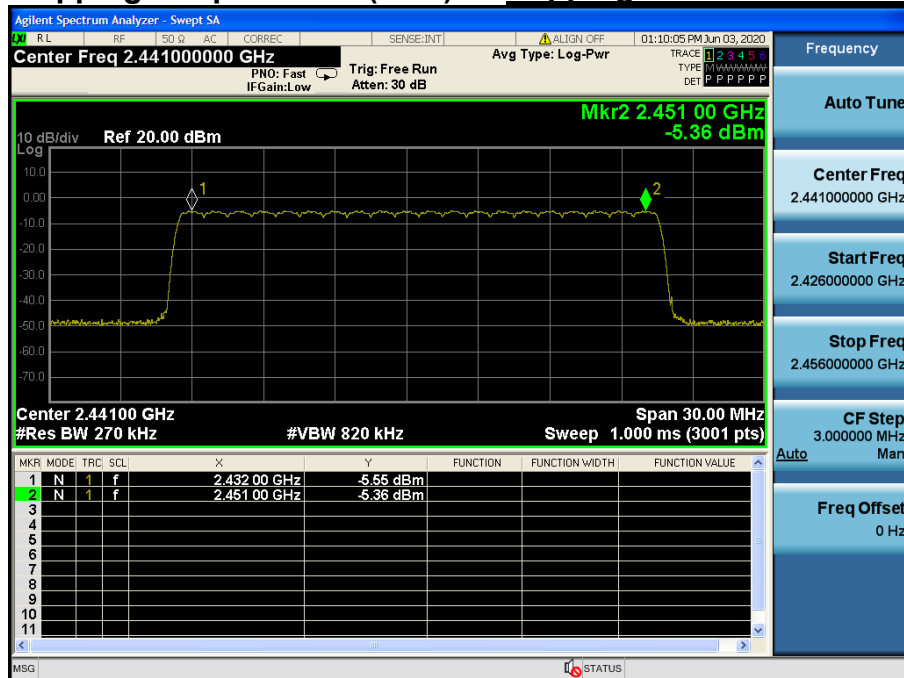
Number of Hopping Frequencies 2(FH) *Hopping mode : Enable & 8DPSK*



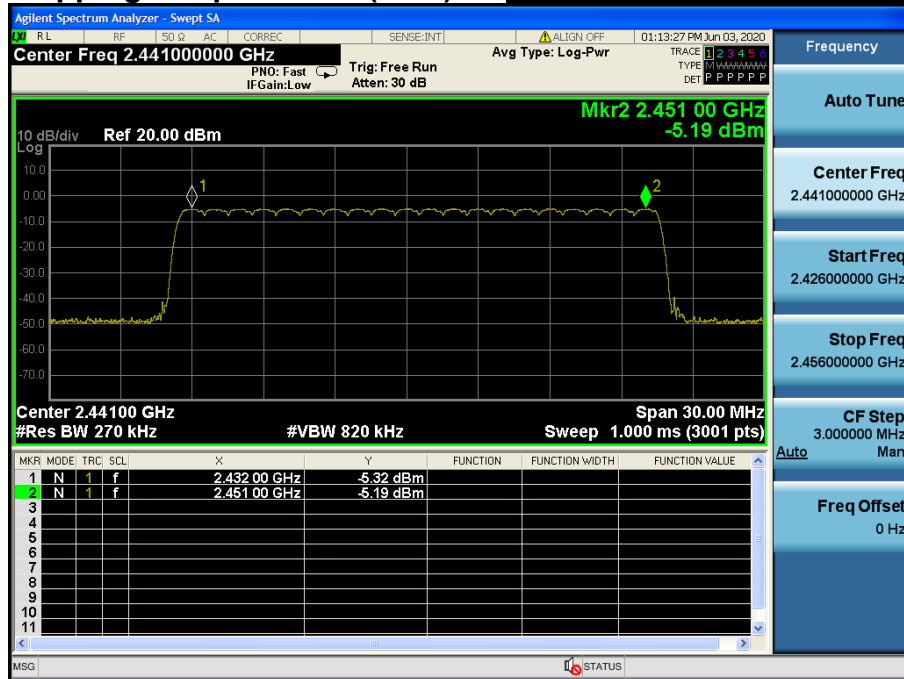
Number of Hopping Frequencies 1(AFH) Hopping mode : Enable & GFSK

6. Time of Occupancy (Dwell Time)

6.1 Test Setup

6.2 Limit

The maximum permissible time of occupancy is 400 ms within a period of 400 ms multiplied by the number of hopping channels employed.

6.3 Test Procedure

The dwell time was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function enabled.

7.1 Test Setup

7.2 Limit

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section §15.209(a) is not required. In addition, radiated emission which in the restricted band, as define in section §15.205(a), must also comply the radiated emission limits specified in section §15.209(a) (see section §15.205(c))

According to § 15.209(a), except as provided elsewhere in this Subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table

The field strength of emissions appearing within these frequency bands shall not exceed the limits shown in §15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in §15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in §15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in §15.35 apply to these measurements.

7.3. Test Procedures

7.3.1. Test Procedures for Radiated Spurious Emissions

1. The EUT is placed on a non-conductive table. For emission measurements at or below 1 GHz, the table height is 80 cm. For emission measurements above 1 GHz, the table height is 1.5 m.
The table was rotated 360 degrees to determine the position of the highest radiation.
2. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 1 or 3 meter away from the interference-receiving antenna.
3. For measurements above 1GHz absorbers are placed on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections. For measurements below 1 GHz, the absorbers are removed.
4. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
5. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
6. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
7. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

Measurement Instrument Setting

- Frequencies less than or equal to 1000 MHz
The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 kHz for Quasi-peak detection (QP) at frequency below 1 GHz.
- Frequencies above 1000 MHz
The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection and frequency above 1 GHz.
The result of Average measurement is calculated using PK result and duty correction factor.

7.3.2. Test Procedures for Conducted Spurious Emissions

1. The transmitter output was connected to the spectrum analyzer.
2. The **reference level** of the fundamental frequency was measured with the spectrum analyzer using RBW = 100 kHz, VBW = 300 kHz.
3. The conducted spurious emission was tested each ranges were set as below.

Frequency range : 9 kHz ~ 30 MHz

RBW = 100 kHz, VBW = 300 kHz, SWEEP TIME = AUTO, DETECTOR = PEAK, TRACE = MAX HOLD, SWEEP POINT : 40001

Frequency range : 30 MHz ~ 10 GHz, 10 GHz ~ 25 GHz

RBW = 1 MHz, VBW = 3 MHz, SWEEP TIME = AUTO, DETECTOR = PEAK, TRACE = MAX HOLD, SWEEP POINT : 40001

LIMIT LINE = 20 dB below of the reference level of above measurement procedure Step 2. (RBW = 100 kHz, VBW = 300 kHz)

If the emission level with above setting was close to the limit (ie, less than 3 dB margin) then zoom scan is required using RBW = 100 kHz, VBW = 300 kHz, SPAN = 100 MHz and BINS = 2001 to get accurate emission level within 100 kHz BW.

Also the path loss for conducted measurement setup was used as described on the Appendix I of this test report.

7.4. Test Results

7.4.1. Radiated Emissions

▪ Test Notes.

- The radiated emissions were investigated 9 kHz to 25 GHz. And no other spurious and harmonic emissions were found below listed frequencies.
- Information of Distance Factor
For finding emissions, measurements may be performed at a distance closer than that specified in the regulations.
In this case, the distance factor is applied to the result.
- Calculation of distance factor
At frequencies below 30 MHz = $40 \log(\text{tested distance} / \text{specified distance})$
At frequencies at or above 30 MHz = $20 \log(\text{tested distance} / \text{specified distance})$
When distance factor is "N/A", the measurements were performed at the specified distance and distance factor is not applied.
- D.C.F Calculation. (D.C.F = Duty Cycle Correction Factor)
- Time to cycle through all channels = $\Delta t = T [\text{ms}] \times 20$ minimum hopping channels, where T = pulse width = **2.88 ms**
- $100 \text{ ms} / \Delta t [\text{ms}] = H \rightarrow$ Round up to next highest integer, to account for worst case, $H' = 100 / (2.88 \times 20) = 1.74 \approx 2$

8.2 Limit

According to §15.207(a) for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table, as measured using a 50 uH/50 ohm line impedance stabilization network (LISN).

Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequency ranges.

8.3 Test Procedures

Conducted emissions from the EUT were measured according to the ANSI C63.10.

1. The test procedure is performed in a 6.5 m × 3.5 m × 3.5 m (L × W × H) shielded room. The EUT along with its peripherals were placed on a 1.0 m (W) × 1.5 m (L) and 0.8 m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane.
2. The EUT was connected to power mains through a line impedance stabilization network (LISN) which provides 50 ohm coupling impedance for measuring instrument and the chassis ground was bounded to the horizontal ground plane of shielded room.
3. All peripherals were connected to the second LISN and the chassis ground also bounded to the horizontal ground plane of shielded room.
4. The excess power cable between the EUT and the LISN was bundled. The power cables of peripherals were unbundled. All connecting cables of EUT and peripherals were moved to find the maximum emission.
