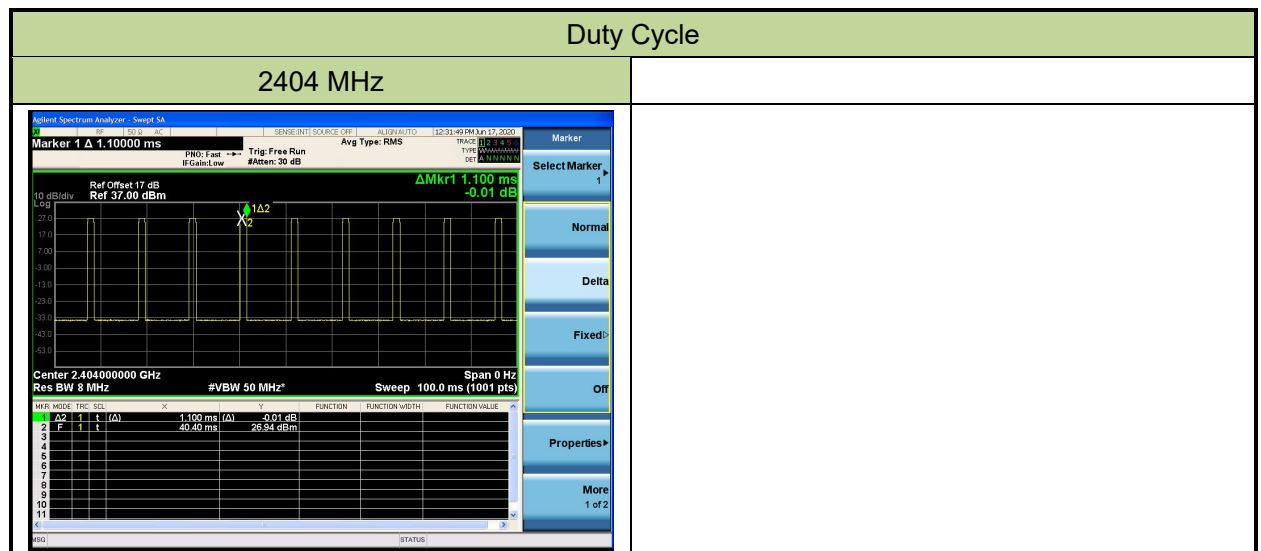
2.5. Duty Cycle

The maximum achievable duty cycles was determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz, Sweep time = 100ms. The duty cycles are as follows:

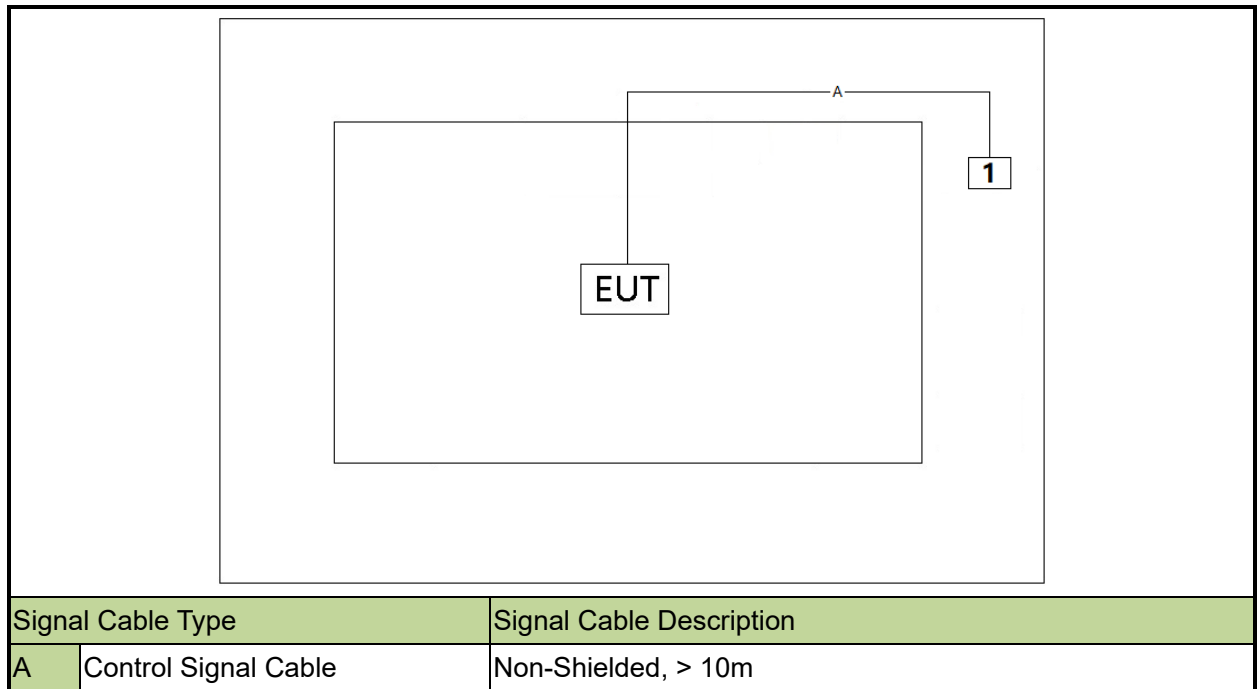

- 1) The analyzer plots shown in this section were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables and attenuators used as part of the system to connect the EUT to the analyzer at all frequencies of interest.
- 2) All modes of operation and data rates were investigated. For radiated emission test, every axis (X, Y, Z) was also verified. The test results shown in the following sections represent the worst-case emissions.

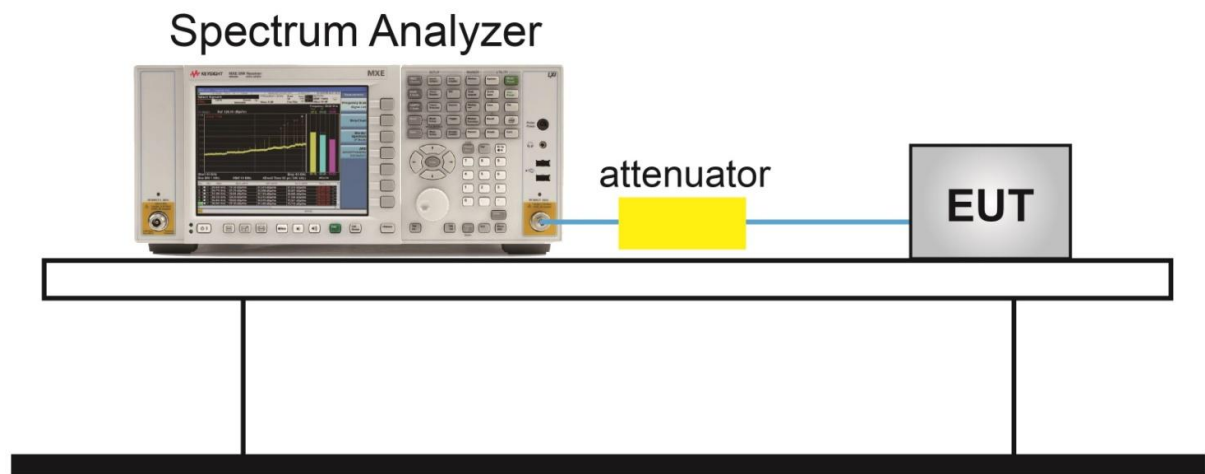
For 6dB bandwidth

1. The Spectrum's automatic bandwidth measurement capability was used to perform the 6dB bandwidth measurement. The "X" dB bandwidth parameter was set to $X = 6$. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
2. Set RBW = 100 kHz
3. $VBW \geq 3 \times RBW$
4. Detector = Peak
5. Trace mode = Max hold
6. Sweep = Auto couple
7. Allow the trace was allowed to stabilize

For 99% bandwidth

1. Span = 1.5 times to 5 times the OBW
2. Set RBW = 1% to 5% the OBW
3. $VBW \geq 3 \times RBW$
4. Detector = Peak
5. Trace mode = Max hold
6. Sweep = Auto couple
7. Allow the trace was allowed to stabilize

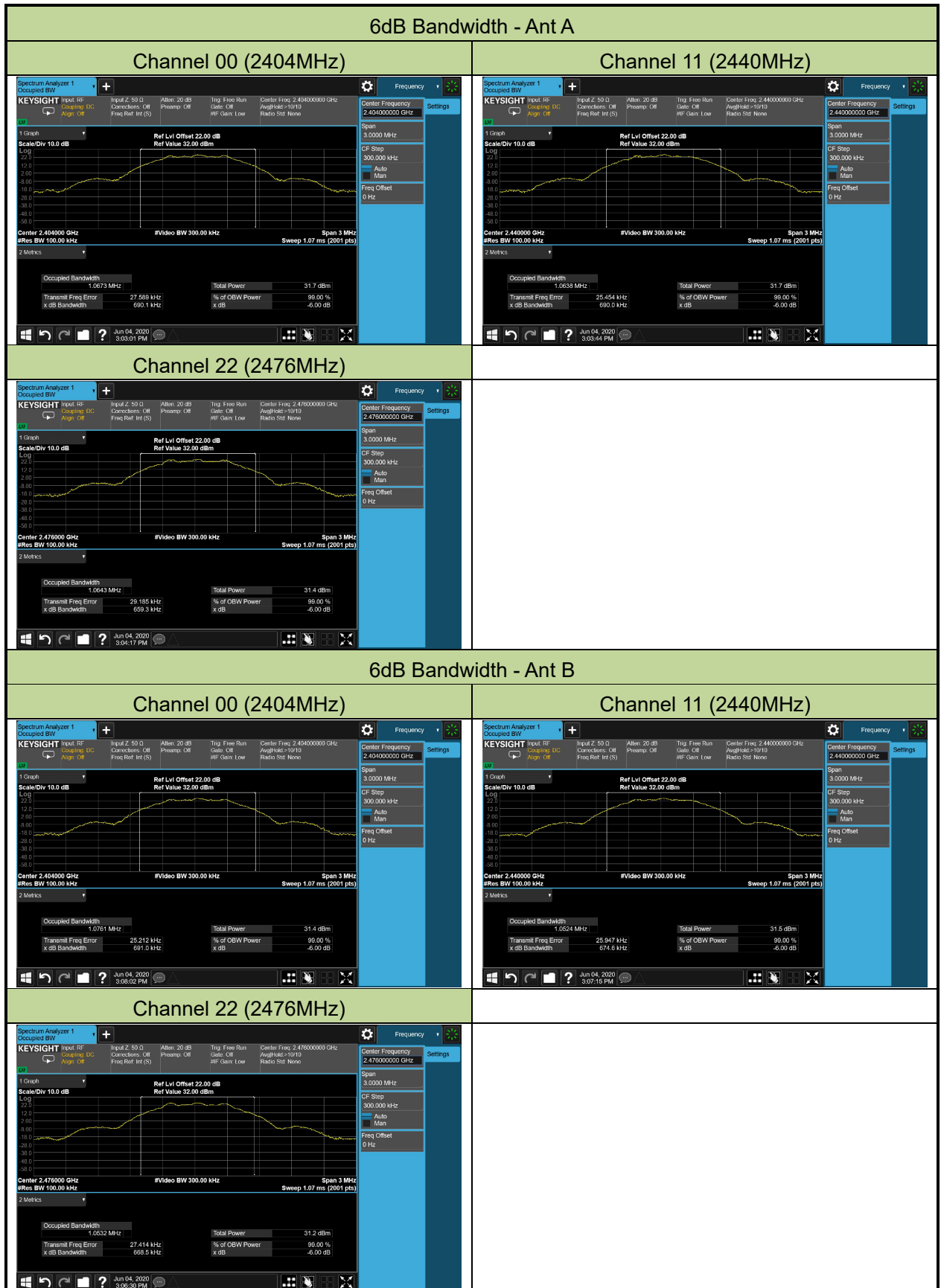

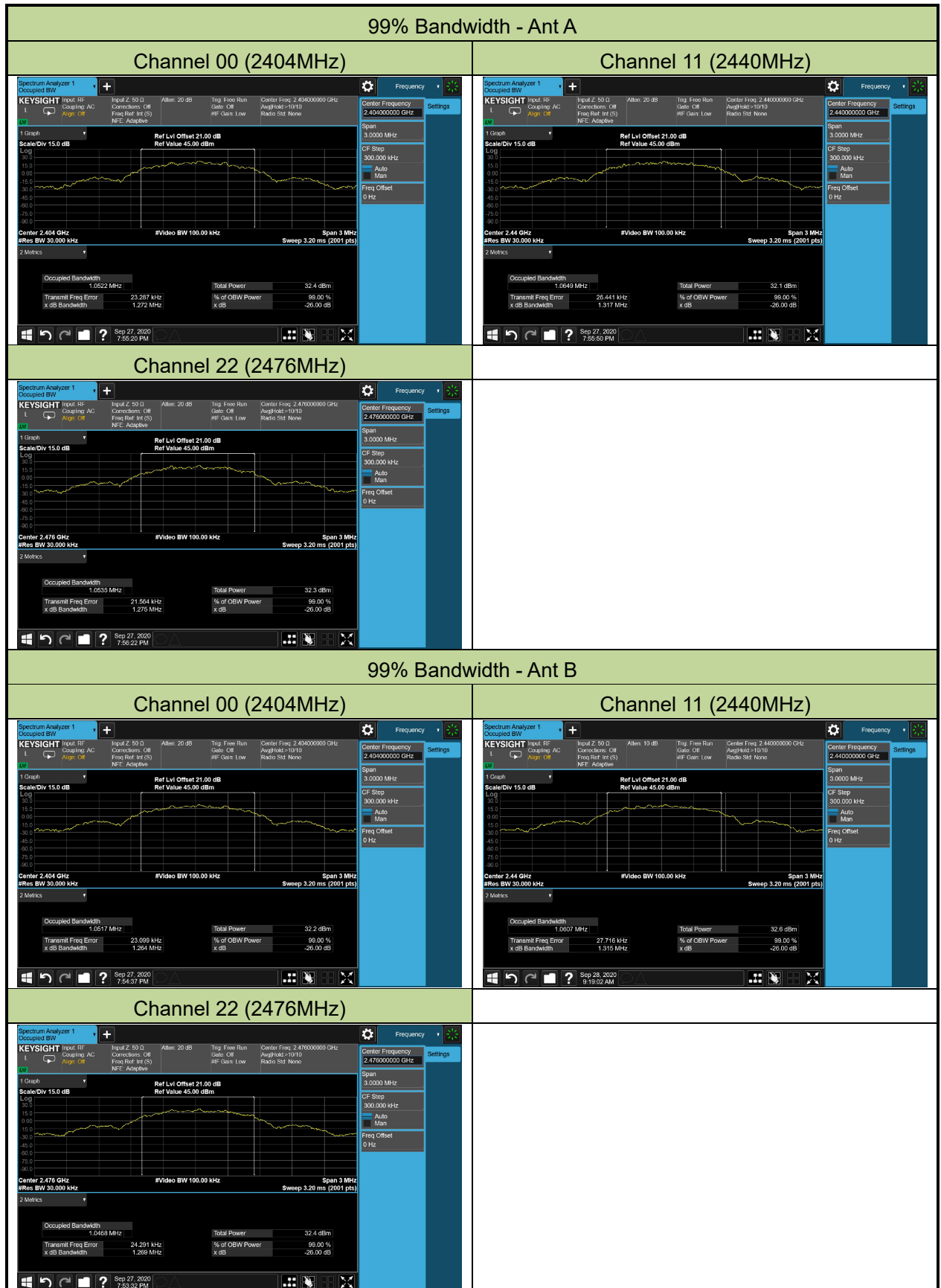

6.3.1. Test Limit

The maximum conducted output power shall be exceeded 1 Watt (30dBm) and the E.I.R.P shall not exceed 4 Watt (36.02dBm).

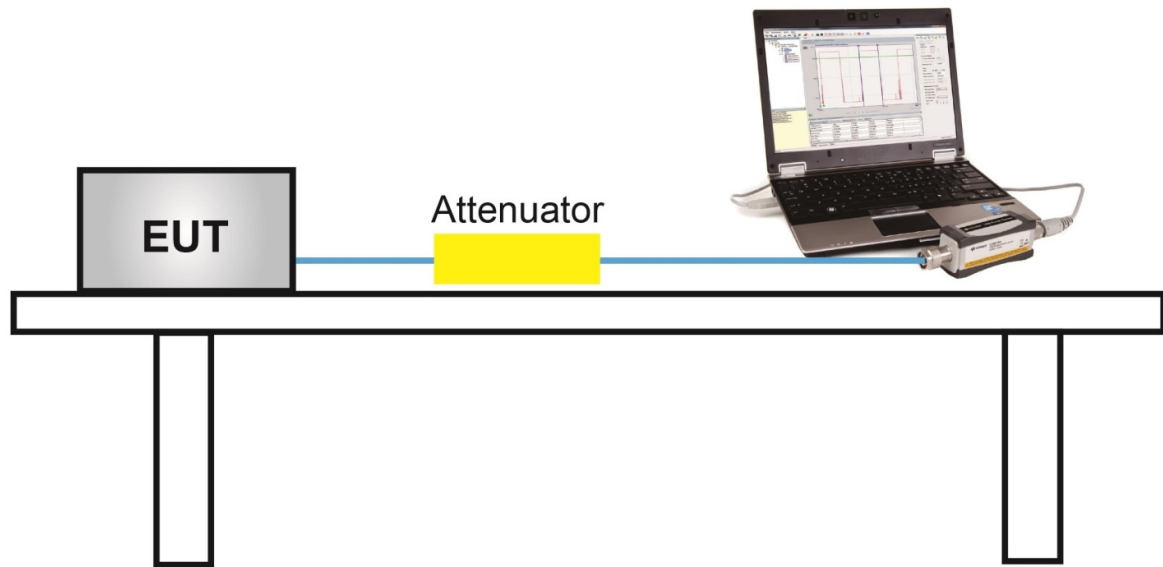
PKPM1 Peak-reading power meter method

The maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast-responding diode detector.

Method AVGPM-G (Measurement using a gated RF average-reading power meter)

Measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Since this measurement is made only during the ON time of the transmitter, no duty cycle correction is required.

6.4. Power Spectral Density Measurement

6.4.1. Test Limit

The maximum permissible power spectral density is 8dBm in any 3 kHz band.

The same method of determining the conducted output power shall be used to determine the power spectral density.

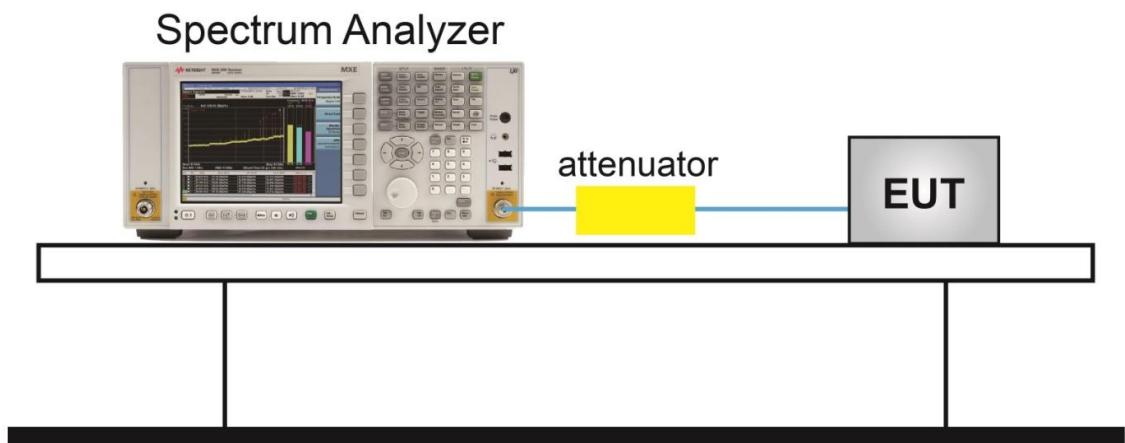
6.4.2. Test Procedure Used

ANSI C63.10 Section 11.10.5

6.4.3. Test Setting

1. Measure the duty cycle (x) of the transmitter output signal.
2. Set instrument center frequency to DTS channel center frequency.
3. Set span to at least 1.5 times the OBW.
4. RBW = 10 kHz.
5. VBW = 30 kHz.
6. Detector = RMS.
7. Ensure that the number of measurement points in the sweep $\geq 2 \times \text{span/RBW}$.
8. Sweep time = auto couple.
9. Don't use sweep triggering. Allow sweep to "free run".
10. Employ trace averaging (RMS) mode over a minimum of 100 traces.
11. Use the peak marker function to determine the maximum amplitude level.

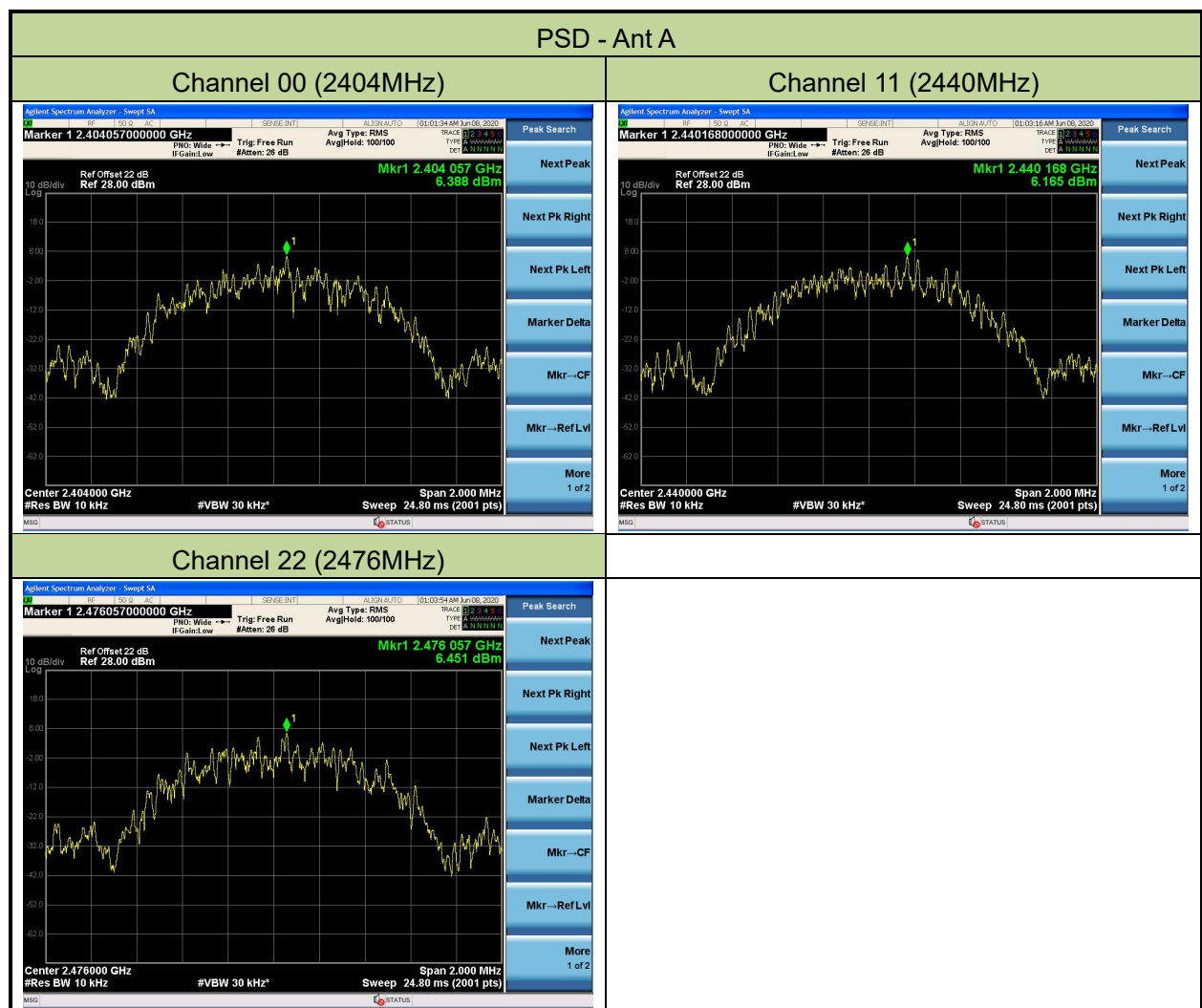

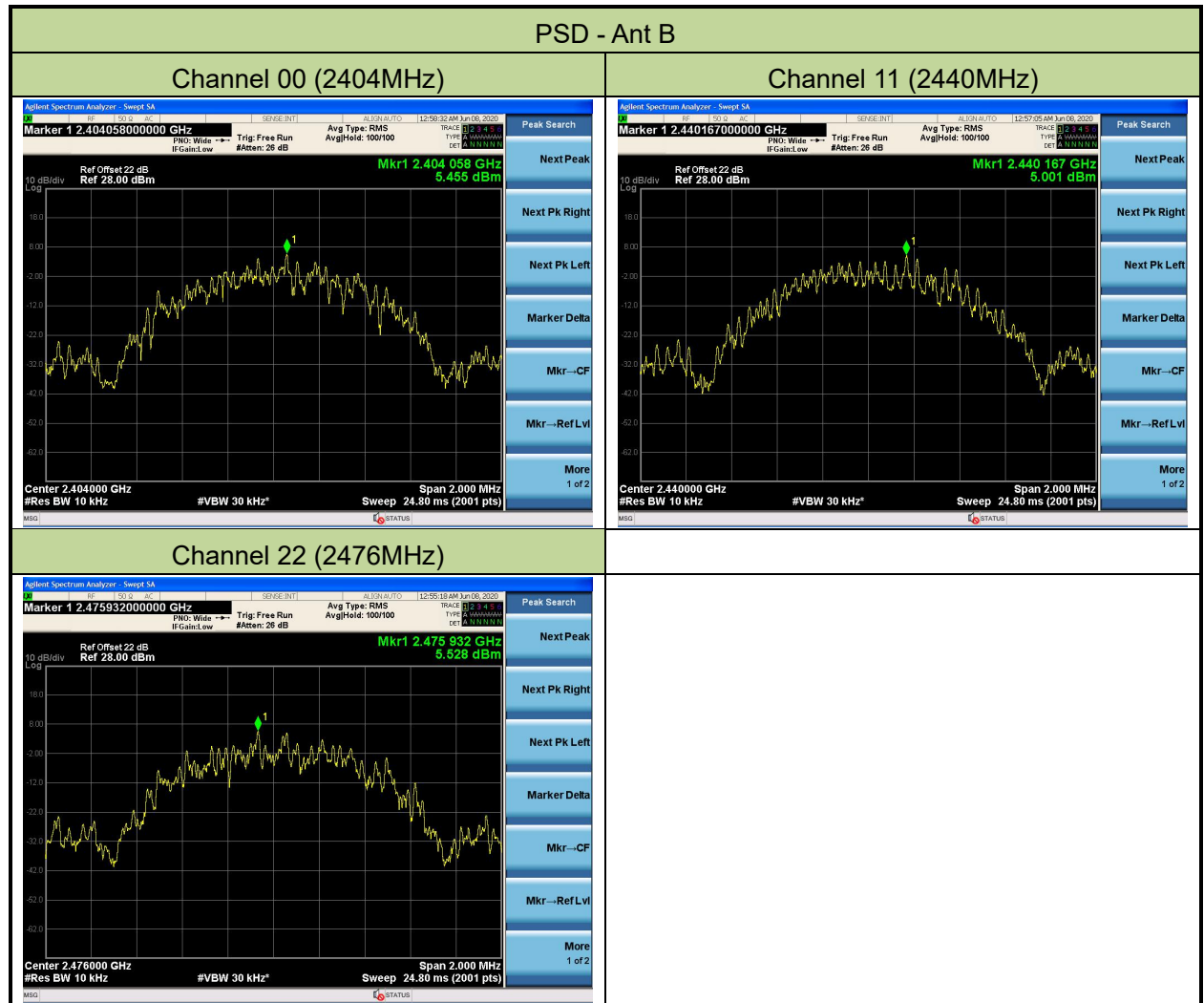

6.5. Conducted Band Edge and Out-of-Band Emissions

6.5.1. Test Limit

The limit for out-of-band spurious emissions at the band edge is 30dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100 kHz bandwidth per the PSD procedure.

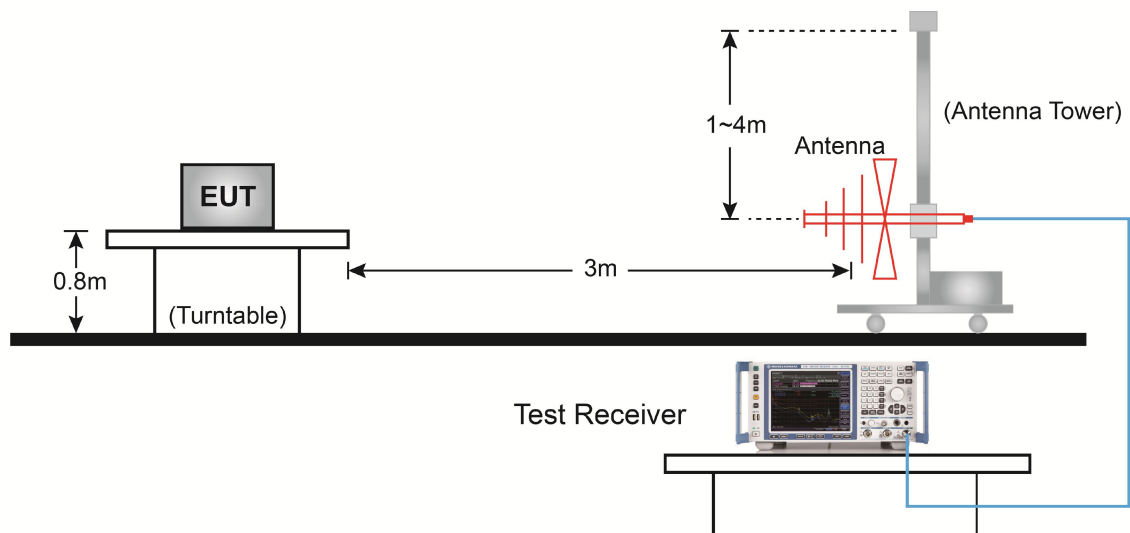

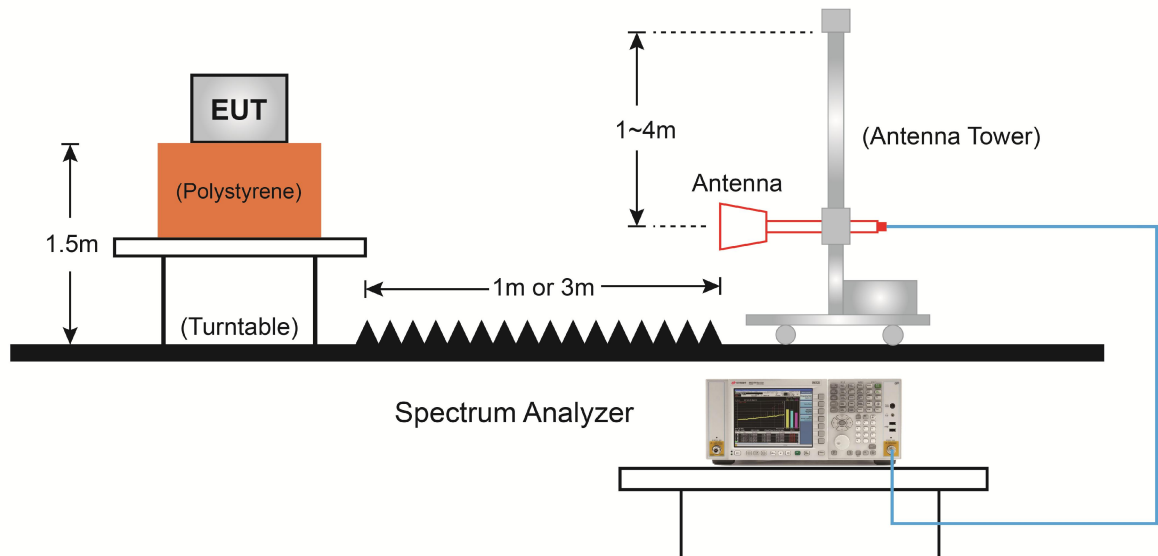
