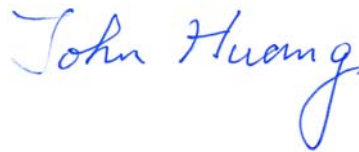
- a) comply with the relevant provisions of the certification program;
