Hi Chris,

1. The Antenna Specification exhibits (file names: TMZ007Data Antenna Spec Part 1.xls and TMZ007Data Antenna Spec Part 2.xls) provide only antenna information for 2000 - 2500 MHz. The EUT operation is in the Cellular 850 MHz and PCS 1900 MHz bands. Please provide antenna specifications for the new antenna in the bands in which it will be used.

<CCS ANSWER:> The Antenna spec on this application is huge. It was submitted in 2 parts to meet document size requirements. Please note that on the bottom of the excel sheet for part one, there are numerous tabs. I believe if you click to the left, you will find the bands that you were missing before. (There may also be additional tabs on part 2 document.)

2. Please note that the Internal Antenna Location photo can not be held confidential.

<CCS ANSWER:> The customer has only requested confidentiality on the antenna specification.

3. The test report appears to have a typo in many locations, referring to HSPDA operation as HSDPA.

<CCS ANSWER:> The Report has been corrected and a revised copy is attached.

4. Please provide a more detailed explanation showing that the antenna location is >20cm from the lap in the lap-held position and that there are no other transmitters located in the host computer.

<CCS ANSWER:> A better photo showing the antenna location is attached. If you look at the photo, it is clear that the antenna location is at the top of the monitor portion only, making it >20cm from the lap in the lap-held position. These are the only transmitters in the host computer.
