

1. NO ELECTRICAL SHORTS ALLOWED BETWEEN CENTER CONDUCTOR AND OUTER COPPER BRAID SHIELD
2. NO NICKS ALLOWED IN COPPER BRAID
3. HEAT SHRINK TUBING SHOULD BE SHRUNK TIGHTLY AROUND THE CABLE
4. F-CONNECTOR (CNR 002) SHOULD BE SECURELY CLINCHED TO WITHSTAND 10 POUND PULL FORCE
5. COIL ANTENNA INTO A DIAMETER NO LARGER THAN 7" AND SECURE WITH TWIST TIES
6. HARDWARE KIT: CABLE CLAMPS AND SELF-TAP SCREWS ARE HEAT SEALED IN BAG 003
7. COILED ANTENNA AND HARDWARE KIT ARE SEALED IN LARGER BAG
8. LABEL ON PACKAGED ANTENNA TO CONTAIN PART NUMBER ("ANT 005") AND PRODUCTION DATE (MMYY OR SIMILAR)
