





**Exhibit 1: FCC ID Label**Equipment Identification Label

In accordance with the requirements of Sections 15.19 (a)(3), 15.311, 2.925 and 2.926 of the FCC Rules, the following information will be permanently affixed to the Comdial Corporation Unlicensed Personal Communications Systems (UPCS). There are two different Model numbers for the Base Station, one for the four antenna unit (MN: MCW-BASE4) and one for the outdoor unit (MN: MCW-BASE4-OD), both units are covered under the same FCC ID number.
