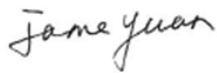

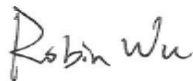

Distances are illustrated in the following Table. The equation and threshold in Note 1 must be applied to determine SAR test exclusion.

Note: The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$$[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] * \sqrt{f(\text{GHz})} \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

$$[\sqrt{f(\text{GHz})}] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

- $f(\text{GHz})$ is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison
- 3.0 and 7.5 are referred to as the numeric thresholds in the step 2 below

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to 5) in section 4.1 is applied to determine SAR test exclusion.

Note 1: Max tune-up procedure power range is 10 dBm.

Note 2: Per FCC KDB 447498 D01v06, the SAR exclusion threshold for distances < 50mm is defined by the following equation:

$$\frac{\text{Max Power of Channel (mW)}}{\text{Test Separation Dist (mm)}} * \sqrt{\text{Frequency (GHz)}} \leq 3.0$$

Based on the maximum conducted power or radiated power of Wireless Microphone and the antenna to use separation distance, Wireless Microphone SAR was not required;

Maximum power = 10.00dBm + 2.80dBi = 19.05mW.

$$\text{Max } P_d = \left(\frac{19.05\text{mW}}{5} \right) * \sqrt{0.514} = 2.732 < 3.00$$

When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.
