





1 To Set Up

Parent's Unit

1. Install the batteries

- Press on the indented finger grip to release, then slide and lift the battery compartment cover
- Insert the three AA rechargeable batteries supplied.
 Position them so the + and contacts are aligned with the corresponding contacts on the battery clip.
- Lower the battery compartment cover, and slide it until it clicks into place.

When it's time to change these batteries:
Use the pull tab to release the old batteries. Remove them, and replace them with three AA nickel cadmium (NiCd)—rechargeable batteries. Do not install standard (non-rechargeable) batteries; doing so could result in damage to the unit, and warranty would become void.

2. Charge the batteries.

Batteries must be fully charged for optimum performance.

- a. Insert the AC adapter plug into the jack on the side of the unit, then plug the adapter into an electrical outlet.
- b. Allow the batteries to charge for 10 to 16 hours (16 hours is recommended, as this is the maximum required to charge the batteries fully.) The power light will change from red to green when the battery is fully charged.

Note: You can use the Monitor while the Parent's Unit is being charged, or it can be charged with the unit off.

CAUTION: Always use the AC adapter(s) supplied with this product. Do not use any other adapter. Monitor could be damaged and warranty would become void.

Child's Unit

 Position the Child's Unit within approximately 6 feet of your child, yet out of the child's reach.

CAUTION: Do not place Child's Unit in crib of attach to crib.

(To prevent heat build-up, place on an open surface away from heat sources; do not place in an enclosed space.)


- Position the antenna straight up, as shown, whether the unit is in the upright or flat position.
- Insert the A/C adapter plug into the jack on the side of the unit, then plug the adapter into an electrical outlet.


For battery operation (optional): Unplug the unit, and install three AA batteries. (See Care of Your Monitor).


Important: Do not plug in the AC adapter with batteries installed in the Child's Unit. Unit could be damaged.

For wall mounting (optional):

- Securely fasten two #6 flat head wood screws 1 5/8 inches apart on the wall so they will align with the screw head slots on the back of the unit. (For best results, use 3/4-inch screws; mount in a solid wood panel, or use screw anchors).
- 2. Leave screw heads protruding from the wall by at least 1/8-inch.
- Fit the screw head slots (on the back of the unit) over the screw heads and slide the unit down to seat it firmly.
- 4. To test that the unit is securely mounted, press on its edges.
