On behalf of the applicant, Teledex Corporation, the attached application for Certification is being filed under the provisions of FCC Part 2.933.

The original device was designed and manufactured by Uniden, and was subsequently submitted to the FCC for Certification under the applicant name of Radio Shack, a Division of Tandy Corporation. RadioShack has consented to allow Teledex Corporation (see attached permission letter) to apply to the FCC for Equipment Authorization using the test data and other supporting documentation that accompanied the original application.

The original identification used on the equipment prior to the change in identification was FCC ID: AAO43-696.


The date of the original grant of the equipment authorization was August 22, 1996.

The difference between the device subject to this application, versus the originally granted device is just the markings showing the new tradename and model identification. There is no change in the circuitry of the models.


