## 1. GENERAL INFORMATION

### 1-1. Product Description

The TECO Information System Co., Ltd. Model: JC-1738VMA-(TW) (referred to as the EUT in this report) is a VGA, and VESA compatible multi-sync. color monitor featuring a maximum pixel resolution of 1280x1024.

The EUT provides a permanently attached video interface cable, approx. 1.5 meter, incorporated with a ferrite core in addition to a detachable type power cord.

Following described the summarized feature of EUT:

1. Display Tube : 17" color, 90 degree deflection, 0.28 mm dot pitch.
2. Display Area : 306mm x 230mm(Hor. x Vert.)
3. Compatibility : VGA and VESA
4. Resolution : Max. Resolution Modes are:  
(H)1280x(V)1024; (H) 64KHz / (V)60Hz (Max. Pixel Rate Mode)  
(H)1024x(V)768; (H) 69KHz / (V)85Hz(Max. Sweep Rate Mode)
5. Synchronization: Horizontal 30-72 KHz Vertical 50-100Hz
6. Input Signal: RGB: Analog (0.7OR 1.0 Vp-p)
7. Input Connector: 15-pin D-shell connector
8. Power: 100-240Vac, 50-60Hz
9. Video Bandwidth 110MHz

### 1-2. Related Submittal(s) / Grant (s)

This submittals is intended for filing a Class II Permissive Change for the certified equipment FCC ID : E8OTE772(date of grant Sep. 23, 1998).

Comparing with current model, the following change are initiated into the modified model:

## 1. Electrical Circuitry – Power Supply

Deleting the Power Factor Correction (PFC) circuit for cost down purpose.

## 2. PWB

Partial printed wiring Board routing (layout), location of L901, C902, R901, R902, FL902, D901 ~ D904, D90, PTH901, NTH901, BD901 and BD903, modified due to the charge(s) of PFC circuit.

The charges will be made only in those units produce after the charges is authorized. Also, the product will keep two versions in market.

**1-4. Test Methodology**

Both conducted and radiated testing were performed according to the procedures in ANSI C63.4 (1992)/CISPR 22 (1996). Radiated testing was performed at an antenna to EUT distance 10 meters.

**1-5. Test Facility**

The open area test site and conducted measurement facility used to collect the radiated data is located on the address of No. 5, All 2, Lane 220, Kang Lo St., Nei Hwu, Taipei, Taiwan, R.O.C. of NEUTRON ENGINEERING INC. This site has been fully described in report dated Feb. 4, 1998 Submitted to your office, and accepted in a letter dated March 28, 1998 (31040/SIT-1300F2).

### **3. System Test Configuration**

#### **3-1. Justification**

The system was configured for testing in a typical fashion (as a customer would normally use it). The EUT was connected to support equipment-personal computer. Peripherals of PC, such as printer, modem, mouse and keyboard as well as the VGA add-on card were contained in this system in order to comply with the ANSI C63.4 standard requirement. The system was tested in the highest pixel resolution mode of 1280x1024 Hsync. 64KHz, and the highest horizontal sweep rate mode of 1024 x 768, Hsync. 69KHz. Both modes were investigated and were used to collect the included data.

The second serial port(COM2) was tested in addition to the first port (COM1) ANSI C63.4, second paragraph. The simultaneous testing of this identical port did not take the system out of compliance. Therefore, the final qualification testing was completed with COM1 port connected by a stand along modem.

#### **3-2. EUT Exercise Software**

The EUT exercise program used during radiated and conducted testing was designed to exercise the various system components in a manner similar to a typical use. The software, contained on a 3-1/2 inch disk, was inserted into driver A and is auto-starting on power-up. Once loaded, the program sequentially exercises each system component in turn. The sequence used is:

1. Read(write) from(to)the disk desk driver.
2. Send " H " pattern to the parallel port device (Printer).
3. Send " H " pattern to the video port device (Monitor).
4. Send " H " pattern to the serial port device (Modem).
5. Repeated from 1 to 4 continuously.

As the Keyboard and mouse are strictly input devices, no data is transmitted to (from) them during test. They are, however, continuously scanned for data input activity.

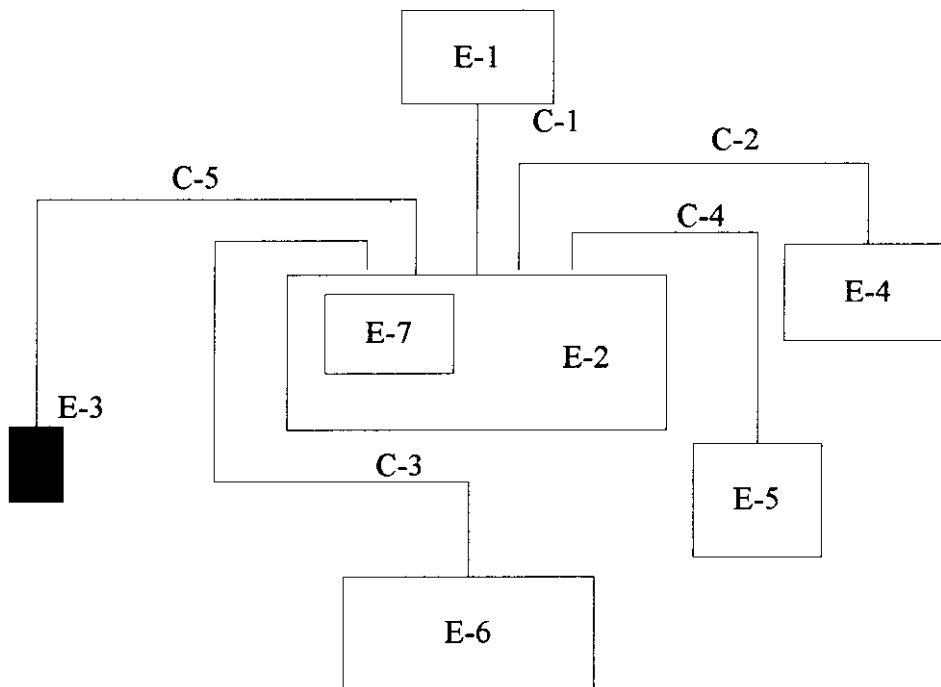

## 7-2. Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CL - AG$$

**Where**    **FS = Field Strength**

**RA = Receiver Amplitude**

**AF = Antenna Factor (1)**

**CL = Cable Attenuation Factor (1)**

**AG = Amplifier Gain (1) (2)**

**Remark :**

(1) The Correction Factor =  $AF + CL - AG$ , as shown in the data tables' Correction Factor column.

(2) AG is not available for Neutron's Open Site Facility

**Example of Calculation:**

Assume a Receiver Reading of 23.7 dBuV is obtained with an Antenna Factor of 7.2 dB and a Cable Factor of 1.1 dB. Then:

1. The Correction Factor will be calculated by

$$\text{Correction Factor} = AF + CL - AG = 7.2 + 1.1 - 0 = 8.3 \text{ (dB)}$$

as shown in the data tables' Correction Factor column.

2. The Field Strength will be calculated by

$$FS = RA + \text{Correction Factor} = 23.7 + 8.3 = 32 \text{ (dBuV/m)}.$$

FS is the value shown in the data tables' Corrected Reading column and RA is the value shown in the data tables' Receiver Reading column. The 32 dBuV/m value was mathematically converted to its corresponding level in uV/m as:

$$\text{Log}^{-1} \left[ (32.0 \text{ dBuV/m}) / 20 \right] = 39.8 \text{ (uV/m)}$$
