### **General Population/Uncontrolled Exposure:**

47 CFR 2.1093(d) (2)

Limits for General Population/Uncontrolled exposure: 0.08 W/kg as averaged over the whole-body and spatial peak SAR not exceeding 1.6 W/kg as averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the hands, wrists, feet and ankles where the spatial peak SAR shall not exceed 4 W/kg, as averaged over any 10 grams of tissue (defined as a tissue volume in the shape of a cube). General Population/Uncontrolled limits apply when the general public may be exposed, or when persons that are exposed as a consequence of their employment may not be fully aware of the potential for exposure or do not exercise control over their exposure. # 4. RF Exposure Evaluation

#### > Standalone Transmission SAR Evaluation:

- According to KDB 447498 section 4.3.1, the 1-g SAR test exclusion thresholds at test separation Distances≤ 50 mm are determined by:
   [(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)]·[√f(GHz)] ≤ 3.0.
  - $\cdot$  f(GHz) is the RF channel transmit frequency in GHz
  - · Power and distance are rounded to the nearest mW and mm before calculation
  - · The result is rounded to one decimal place for comparison
- 2. When the device is used, 5mm as the most conservative minimum test separation distance was used for evaluating.
