
Enclosed, please find Microtek International Inc's application for equipment authorization dated January 19, 2000. This device is in compliance with Part 15, Subpart B of the FCC Rules.

The subject device is a USB Color Flatbed Image Scanner with color and gray scale resolutions of optical up to 1200 dpi by 2400 dpi and maximum up to 9600 dpi. This device is marketed with such features as: (1) image data processor, type ASIC M012 that operated at 24 MHz; (2) external plug-in photo mask with permanently attached 1.0m shielded cable with one bonded ferrite core that gets plugged into this device's accessory port; (3) USB interface port and detachable 1.4m shielded cable with one bonded ferrite core; and (4) Direct Plug-In AC Adaptor with DC cable with one bonded ferrite core by Li Shin, type LSE9801B15-2; or by Kentex type KB18-150 or by Bestec type BPA-201A.

This scanner with all three AC Adaptors were system tested in accordance with ANSI C63.4-1992 to show compliance with CISPR Pub 22 Class B limits.
