This application is for the certification of Intermec's 6820 printer with Bluetooth transmitter, FCC ID: EHABTS080-1. The radio will be used only as a mobile transmitter.

The EUT can be configured with only one antenna. The antenna is a printed circuit board trace integral to the radio module, therefore it satisfies the requirements of 47 CFR 15.203.
