EXHIBIT 1 GENERAL DESCRIPTION

1.0 **General Description**

1.1 Product Description

The Equipment Under Test (EUT) is a Receiver operating at 433MHz. The EUT is powered by 120V a.c. It receives control signal from remote transmitter and the device connected to it will be on/off accordingly.

Model differences/similarities are as follow:

- 1. The Model: Dimplex 47-1010-R is the same as the Model: JECKSON 47-1010-R in hardware aspect. The difference in trade name serves as marketing strategy.
- 2. The Model: Dimplex 47-1010-B is the same as the Model: JECKSON 47-1010-B in hardware aspect. The difference in trade name serves as marketing strategy.
- 3. The Model: JECKSON 47-1010-B is the same as the Model: JECKSON 47-1010-R in hardware aspect except that JECKSON 47-1010-B is a bare board version and has no enclosure. Also, the receptacle is replaced by tabs.
- 4. Each model can have alternative relay.

Antenna Type: Integral, Internal

For electronic filing, the brief circuit description is saved with filename: descri.pdf.

1.2 Related Submittal(s) Grants

This is an application for Certification of a receiver. The transmitter, associated with this receiver, has FCC ID: ELY547-47-1010-T and has been filed at the same time.

1.3 Test Methodology

Both AC mains line-conducted and radiated emission measurements were performed according to the procedures in ANSI C63.4 (2003). All radiated measurements were performed in an Open Area Test Site. Preliminary scans were performed in the Open Area Test Site only to determine worst case modes. For each scan, the procedure for maximizing emissions in Appendices D and E were followed. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application.

1.4 Test Facility

The open area test site and conducted measurement facility used to collect the radiated data is located at Garment Centre, 576 Castle Peak Road, Kowloon, Hong Kong. This test facility and site measurement data have been placed on file with the FCC.

EXHIBIT 2 SYSTEM TEST CONFIGURATION

2.0 **System Test Configuration**

2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.4 (2003).

The device was powered from 120V a.c.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. The step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was mounted to a cardboard box, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

Model: JECKSON 47-1010-R was used for testing. The test results on both relay versions are demonstrated on the report.

2.2 EUT Exercising Software

There was no special software to exercise the device. Once the unit is powered up, it received continuously.

2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

During test, a 100W light bulb was connected to the socket-outlet on the EUT.

2.4 Equipment Modification

Any modifications installed previous to testing by Jeckson Electric Co., Ltd. will be incorporated in each production model sold/leased in the United States.

No modifications were installed by Intertek Testing Services.

2.5 Measurement Uncertainty

When determining of the test conclusion, the Measurement Uncertainty of test has been considered.

This product was tested in standalone configuration.

EMISSION RESULTS

3.0 **Emission Results**

Data is included of the worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

FS = RA + AF + CF - AG

where $FS = Field Strength in dB\mu V/m$

RA = Receiver Amplitude (including preamplifier) in dBµV

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB AG = Amplifier Gain in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain. An example for the calculations in the following table is as follows:

FS = RR + LF

where $FS = Field Strength in dB\mu V/m$

 $RR = RA - AG \text{ in } dB\mu V$ LF = CF + AF in dB

Assume a receiver reading of 52.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB are added. The amplifier gain of 29 dB is subtracted, giving a field strength of 32 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

 $AF = 7.4 \text{ dB} \qquad \qquad RR = 23.0 \text{ dB}\mu\text{V}$ $CF = 1.6 \text{ dB} \qquad \qquad LF = 9.0 \text{ dB}$

Level in μ V/m = Common Antilogarithm [(32 dB μ V/m)/20] = 39.8 μ V/m

MISCELLANEOUS INFORMATION

8.0 <u>Miscellaneous Information</u>

This miscellaneous information includes details of the stabilizing process (including a plot of the stabilized waveform), the test procedure and calculation of factors such as pulse desensitization and averaging factor.

8.1 Stabilization Waveform

Previous to the testing, the superregenerative receiver was stabilized as outlined in the test procedure. For the electronic filing, the plot saved with filename: superreg.pdf shows the fundamental emission when a signal generator was used to stabilize the receiver. Please note that the antenna was placed as close as possible to the EUT for clear demonstration of the waveform and that accurate readings are not possible from this plot.

8.2 Discussion of Pulse Desensitization

The determination of pulse desensitivity was made in accordance with Hewlett Packard Application Note 150-2, *Spectrum Analysis ... Pulsed RF.*

This device is a superregenerative receiver. The stabilized signals are continuous, and no desensitization of the measurement equipment occurs.

8.3 Calculation of Average Factor

The emission limits are specified using spectrum analyzers or receivers which incorporate quasi-peak detectors. Typical measurements are made using peak detectors, however, emissions which approach the respective emission limit are measured using a quasi-peak detector.

For measurements above 1 GHz, spectrum analyzers or receivers using average detectors are employed, or the appropriate average factor can be applied.

Measurements using spectrum analyzers with filters other than peak detectors are recorded in the data table section of this report.

This device is a superregenerative receiver.

It is not necessary to apply average factor to the measurement results.

8.4 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services Hong Kong Ltd. in the measurements of superregenerative receivers operating under the Part 15, Subpart B rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.4 - 2003. Superregenerative receivers are stabilized prior to measurement by generating a signal well above the receiver threshold whose frequency is tuned until the emissions stabilize into a line spectrum. The signal is usually generated as CW with a Marconi 2022D signal generator and a short whip antenna and is at a level of several hundred to several thousand mV/m. Plots of the stabilized signal will be shown. If a modulated signal is used, it will be noted.

The equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately one meter in height above the groundplane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axis to obtain maximum emission levels. The antenna height and polarization are also varied during the testing to search for maximum signal levels. The height of the antenna is varied from one to four meters.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in Exhibit 8.3.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower. For line conducted emissions, the range scanned is 150 kHz to 30 MHz.

8.4 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements were made as described in ANSI C63.4 - 2003.

The IF bandwidth used for measurement of radiated signal strength was 100 kHz or greater when frequency is below 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. A discussion of whether pulse desensitivity is applicable to this unit is included in this report (See Exhibit 8.2). Above 1000 MHz, a resolution bandwidth of 1 MHz is used.

Measurements are normally conducted at a measurement distance of three meters. All measurements are extrapolated to three meters using inverse scaling, unless otherwise reported. Measurements taken at a closer distance are so marked.
