Installing the keyboard / Instalando o teclado

This chapter provides instructions on how to install the keyboard and mouse

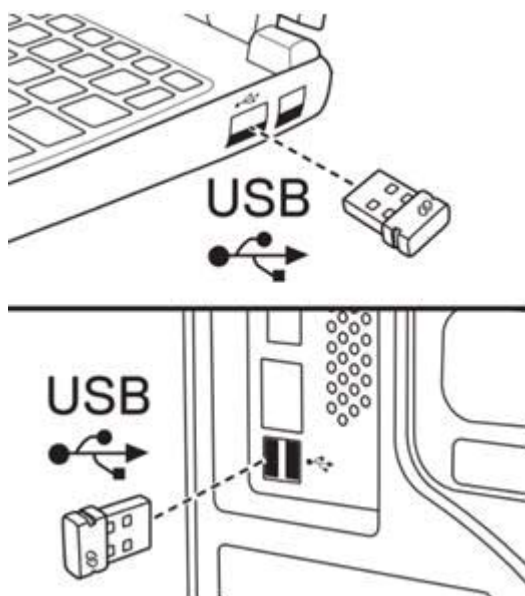
To install the keyboard & mouse, do the following:

1. Remove isolated mylar from keyboard and mouse bottom battery door.
2. Open mouse bottom battery door, and pick dongle out
3. Connect the dongle to an available USB connector on your computer.
4. Close mouse battery door, and slide power button to [ON]
5. Adjust the tilt feet to set the keyboard near your computer to your preference.
6. The keyboard and mouse will be ready for use after it is identified by the operating system.

Este capítulo fornece instruções sobre como instalar o teclado e o mouse

Para instalar o teclado e o mouse, faça o seguinte:

1. Remova o mylar isolado da porta da bateria inferior do teclado e do mouse.
2. Abra a porta da bateria inferior do mouse e retire o dongle
3. Conecte o dongle a um conector USB disponível no seu computador.
4. Feche a porta da bateria do mouse e deslize o botão liga/desliga para [ON]
5. Ajuste os pés de inclinação para colocar o teclado próximo ao seu computador conforme sua preferência.
6. O teclado e o mouse estarão prontos para uso após serem identificados pelo sistema operacional.

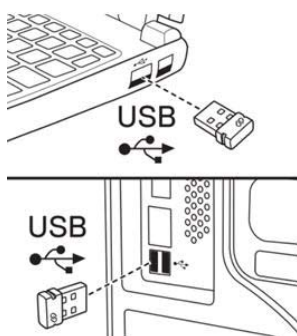

安裝使用說明

本章提供有關如何安裝鍵盤和滑鼠的說明，要安裝鍵盤和滑鼠，請執行以下操作：從鍵盤和滑鼠底部電池蓋上取下絕緣片。打開滑鼠底部電池蓋，取出 USB 連接器，並連接到電腦上可用的 USB 埠。關閉滑鼠電池蓋，然後將電源按鈕滑動到 [ON]，電腦作業系統識別到連接器後，鍵盤滑鼠即可使用。鍵盤可以根據使用需求調整腳架。
