Using the lighting

Press the lighting button repeatedly to cycle through 4 light shows: Pulse to the Beat (works with BT), Slow Pulse (If BT is paused), Bright, Dim, Off.

Connecting to Bluetooth

- Turn on your Bluetooth device and enable Bluetooth mode (check in Phone Settings).
- Press the Power Button. The unit will enter pairing mode in the first usage.
- Using your Bluetooth device, select the Bluetooth pairing name for your product "WH-B37"
- A voice prompt "connected" will sound to confirm once your device is paired. Use the controls on your device to play/pause, navigate tracks, and control

- To clear Bluetooth pairing table, press and hold the Power/Bluetooth Pairing Button for 10 seconds until you hear confirmation SFX.
