Enclosed please find revised user manual and external photo for the product.

Regarding your question #3, the power of the EUT, Touch screen, was supplied by the main board of the LCD monitor. Also, the power of the main board for the monitor supplied from the AC/DC Adapter. That's a reason the AC/DC Adapter was connected to the LISN. As you can see in the internal photo, there were 3 connectors on the controller board for touch screen. Connector CN1 was connected to the touch panel and connector 2 was connected to the main board of the LCD Monitor. The other one is blank.
