#### 2.0 **General Description**

#### 2.1 Product Description

The CL82215 is a 1.9GHz Digital Modulation Cordless Phone with Caller ID and Digital Answering Machine. It operates at frequency range of 1921.536MHz to 1928.448MHz with 5 channels (1921.536MHz, 1923.264MHz, 1924.992MHz, 1926.720MHz and 1928.448MHz). The Base Unit is powered by an adaptor 100-120VAC to 6VDC 400mA Handset is powered by a Ni-MH type rechargeable battery pack (2.4V 400mAh).

The antennas used in base unit and handset are integral, and the test sample is a prototype.

For FCC, the Model(s): CL82115, CL82315, CL82415, CL82465, CL82515 and CL82XY5 are the same as the Model: CL82215 in electrical designs including software & firmware, PCB layout and construction design/physical design/enclosure. The Handset Model(s) CL84115, CL84215, CL84265, CL84365 and CL84XY5 are the same as the Model: CL84115 in electrical designs including software & firmware, PCB layout and construction design/physical design/enclosure. The only differences between these models are color, model number, package type and no. of Handset and Charger to be sold for marketing purpose. Suffix (X) indicates different any alphanumeric character is presenting no. of Handset and suffix (Y) indicates different number (0, 1, 2, 3, 4, 5, 6, 7, 8) is presenting different package type or color of enclosure; Y=Number (9) is presenting different package type or color of enclosure with Wireless Speaker.

For IC, the Model(s): CL82115, CL82315, CL82415, CL82465 and CL82515 are the same as the Model: CL82215 in electrical designs including software & firmware, PCB layout and construction design/physical design/enclosure. The only differences between these models are color, model number, no. of Handset and extra Charger and package type(material) difference to be sold for marketing purpose.

Connection between the device and the telephone network is accomplished through the use of USOC RJ11C in the 2-wire loop calling central office line.

#### 2.2 Technical Description

The circuit description and digital modulation techniques description are saved with filename: descri.pdf.

#### 2.3 Test Methodology

The radiated emission measurements for unintentional radiator (if any) and AC power line-conducted emission measurements were performed according to the test procedures specified in ANSI C63.4 (2009). The radiated emission measurements for intentional radiator contained in UPCS device, conducted emission measurements, Listen Before Transmit (LBT) tests, Time Frame and Frequency Stability tests were performed according to the test procedures specified in ANSI C63.17 (2013). All radiated measurements were performed in Open Area Test Sites. Preliminary scans were performed in the Open Area Test Sites only to determine worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application. All other measurements were made in accordance with the procedures in 47 CFR Part 2 / RSS-Gen Issue 3 (2010).

#### 2.4 Test Facility

The open area test site, AC power line conducted measurement facility and antenna port conducted measurement facility used to collect the radiated data, AC Power Line conducted data, and conductive data are at Intertek Testing Services Hong Kong Ltd., which is located at Garment Centre, 576 Castle Peak Road, Kowloon, Hong Kong Workshop No. 3, G/F., World-Wide Industrial Centre, 43-47 Shan Mei Street, Fo Tan, Sha Tin, N.T., Hong Kong. This test facility and site measurement data have been fully placed on file with FCC and Industry Canada.

#### 3.0 **System Test Configuration**

#### 3.1 Justification

For emissions testing, the equipment under test (EUT) was set up to transmit continuously in burst mode with pseudo-random data to simplify the measurement methodology. Care was taken to ensure proper power supply voltages during testing. During testing, all cables (if any) were manipulated to produce worst-case emissions.

The Base Unit was powered by a 100-120VAC to 6.0VDC 400mA adaptor. The handset was powered by a fully charged battery.

For the measurements, the EUT was attached to a plastic stand if necessary and placed on the wooden turntable. If the EUT is attached to accessories, they were connected and operational (as typical as possible).

The signal was maximized through rotation and placement in the three orthogonal axes. The antenna height and polarization were varied during the search for maximum signal level. The antenna height was varied from 1 to 4 meters. Detector function was in peak mode. Radiated emissions are taken at three meters unless the signal level was too low for measurement at that distance. If necessary, a pre-amplifier was used and/or the test was conducted at a closer distance.

For UPCS transmitter radiated measurement, the spectrum analyzer resolution bandwidth was approximately 1% of EUT emission bandwidth, unless otherwise specified.

Radiated emission measurements for UPCS transmitter were performed from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.

As the base unit has 2 antennas, both have been checked. While conducting the test on one of antennas, another one was being disable its transmission. The data in this report represented the worst-case.

For AC line conducted emission test, the EUT along with its peripherals were placed on a 1.0m(W)x1.5m(L) and 0.8m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane. The EUT was connected to power mains through a line impedance stabilization network (LISN), which provided 50ohm coupling impedance for measuring instrument. The LISN housing, measuring instrument case, reference ground plane, and vertical ground plane were bounded together. The excess power cable between the EUT and the LISN was bundled.

All connecting cables of EUT and peripherals were manipulated to find the maximum emission.

All relevant operation modes have been tested and the worst case data is included in this report.

#### 3.2 Conducted Emission Test Configuration

The setup and equipment setting were made in accordance with ANSI C63.17. The antenna of EUT transmitter was replaced by a coaxial cable. The impendence matching of connection, cable loss and external RF attenuator are taken into account. The EUT was arranged to communicate via a fixed carrier frequency between its transmitter and a companion device. The transmission was configured in burst mode with pseudo-random data as typical as normal operation.







#### Base unit, Lowest channel, Traffic carrier





#### Base unit, Highest channel, Traffic carrier





#### Plots of emission bandwidth






#### Handset unit, Highest channel, Traffic carrier









#### Base unit, Lowest channel, Traffic carrier




## Base unit, Middle channel, Traffic carrier





## Base unit, Highest channel, Traffic carrier









## Plots of the power spectral density (FCC)











## Handset unit, Highest channel, Traffic carrier









#### Base unit, Lowest channel, Traffic carrier







#### Handset unit, Lowest channel, Traffic carrier







#### Base unit, Lowest channel, Traffic carrier




#### Base unit, Middle channel, Traffic carrier





## Plots of the unwanted emission inside the sub-band (IC)









If no signal above the threshold level is detected, transmission may commence and continue with the same emission bandwidth in the monitored time and spectrum windows without further monitoring.
