(i) The radio elements of the modular transmitter must have their own RF shielding.	The module have a shield can.
(ii) The modular transmitter must have buffered modulation/data inputs (if such inputs are provided).	All data inputs have buffered inputs.
(iii) The modular transmitter must have its own power supply regulation.	The module will only be under two conditions; 1. With an external DCDC source at 3.25-3.35V 2. Coin cell battery 1.65-3.1V
(iv) The modular transmitter must comply with the antenna and transmission system requirements of §§ 15.203, 15.204(b) and 15.204(c).	The module is incorporating a pcb antenna as the only antenna option.
(v) The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing for compliance with Part 15 parameters.	The module was tested standalone.
