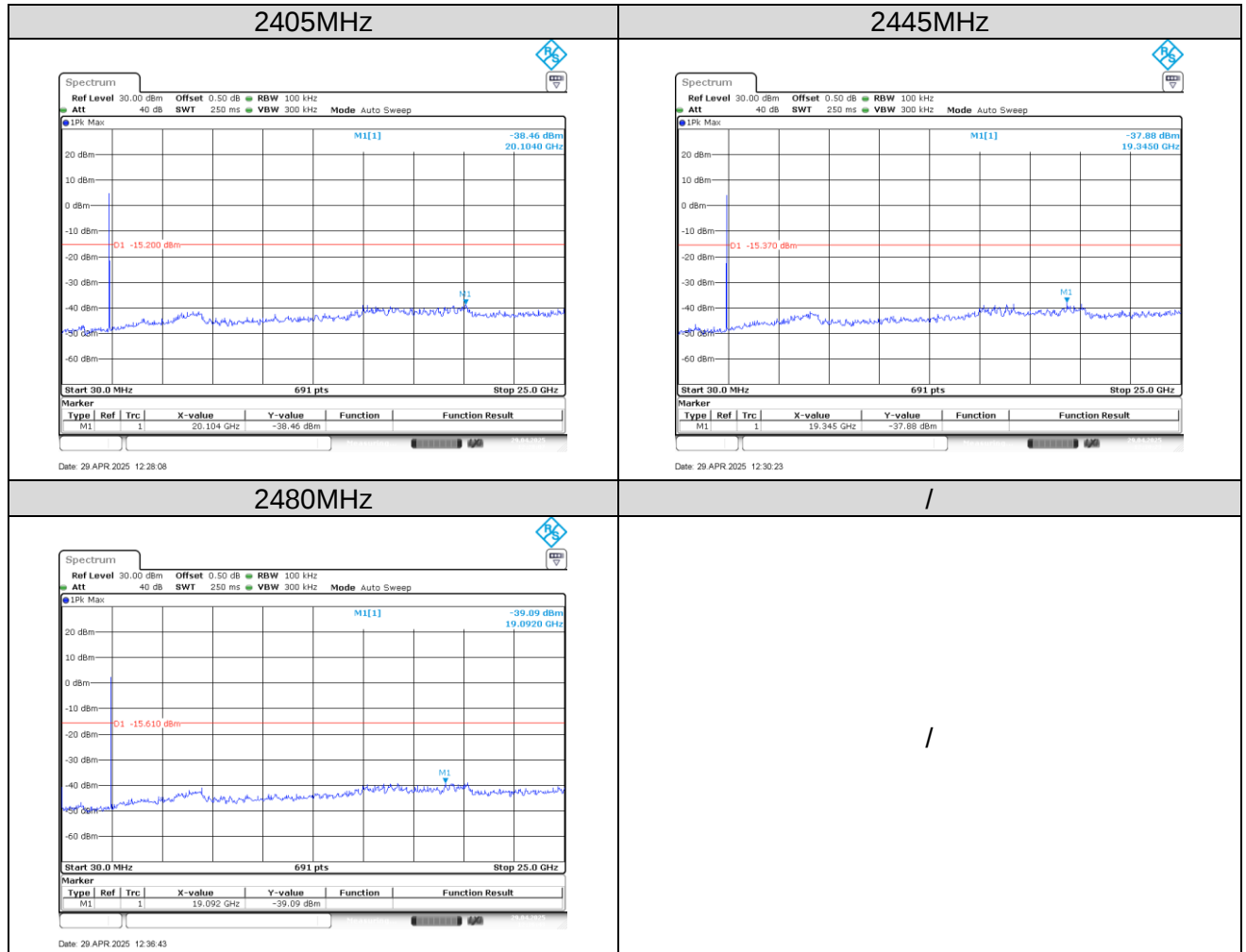

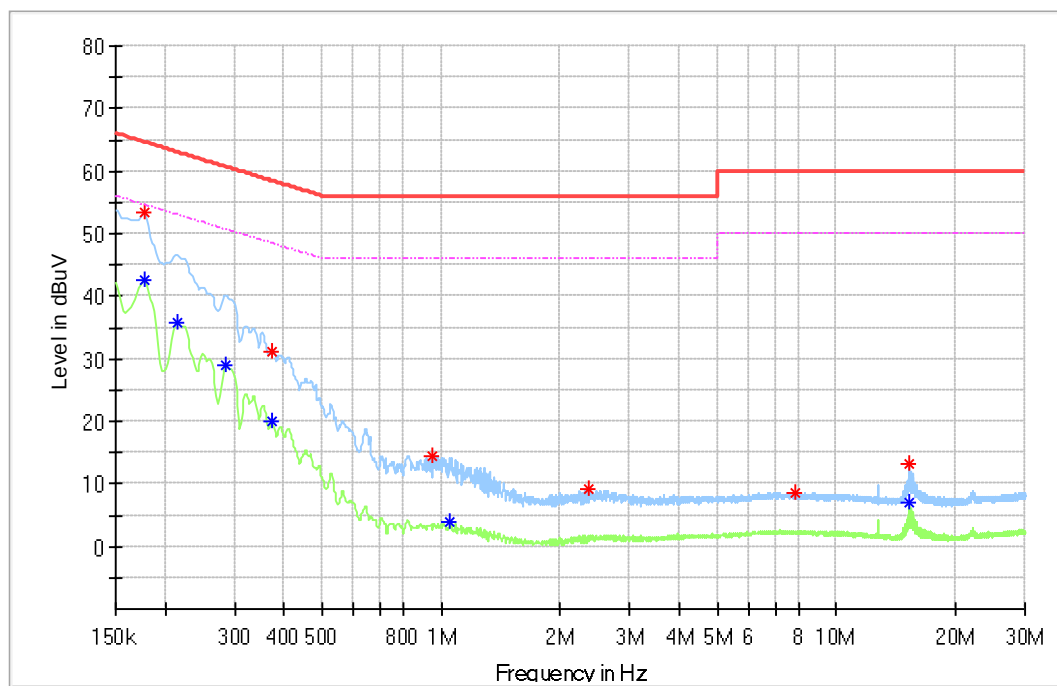
**Figure 2: Conducted Spurious Emission**

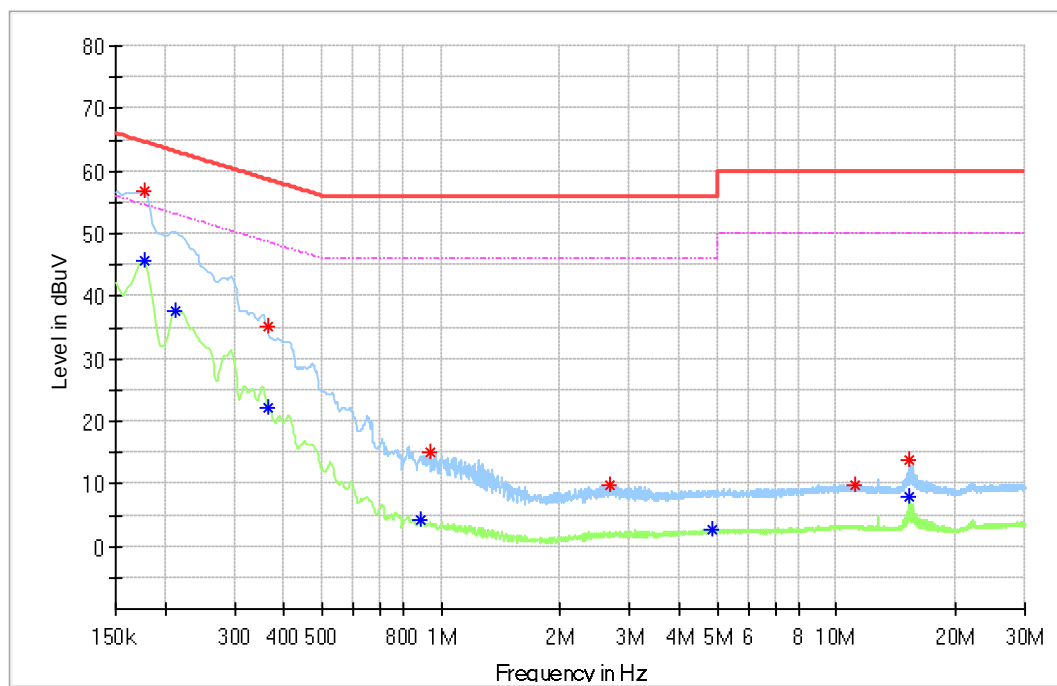

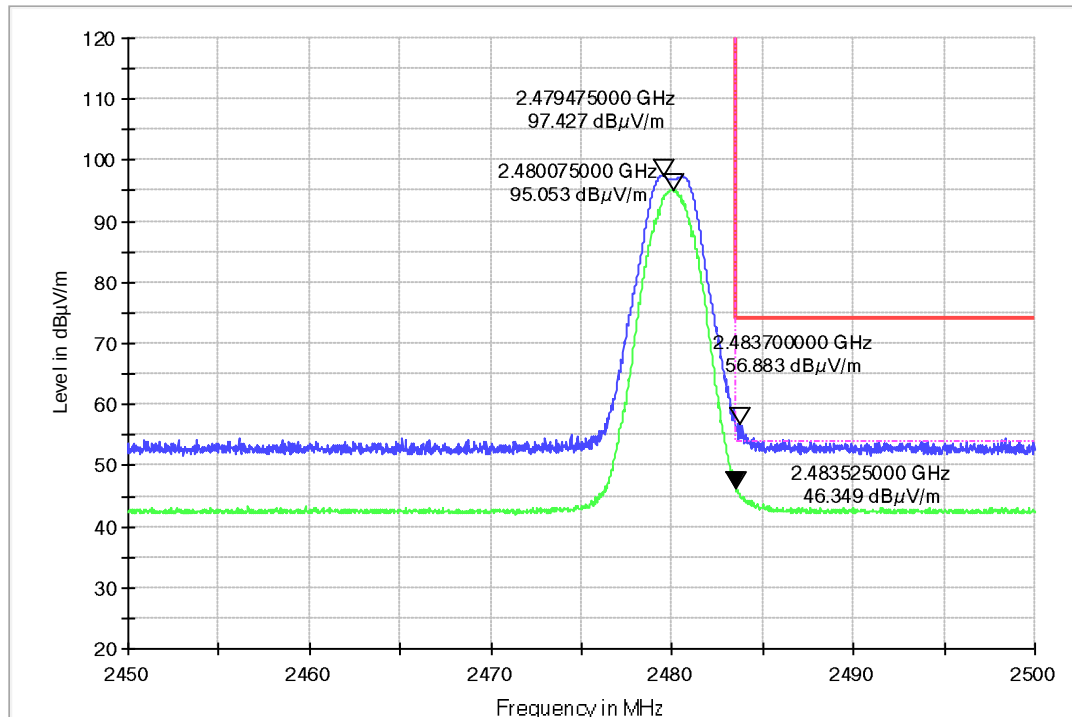

**Figure 7: Radiated Band-Edge, 2405MHz, V**

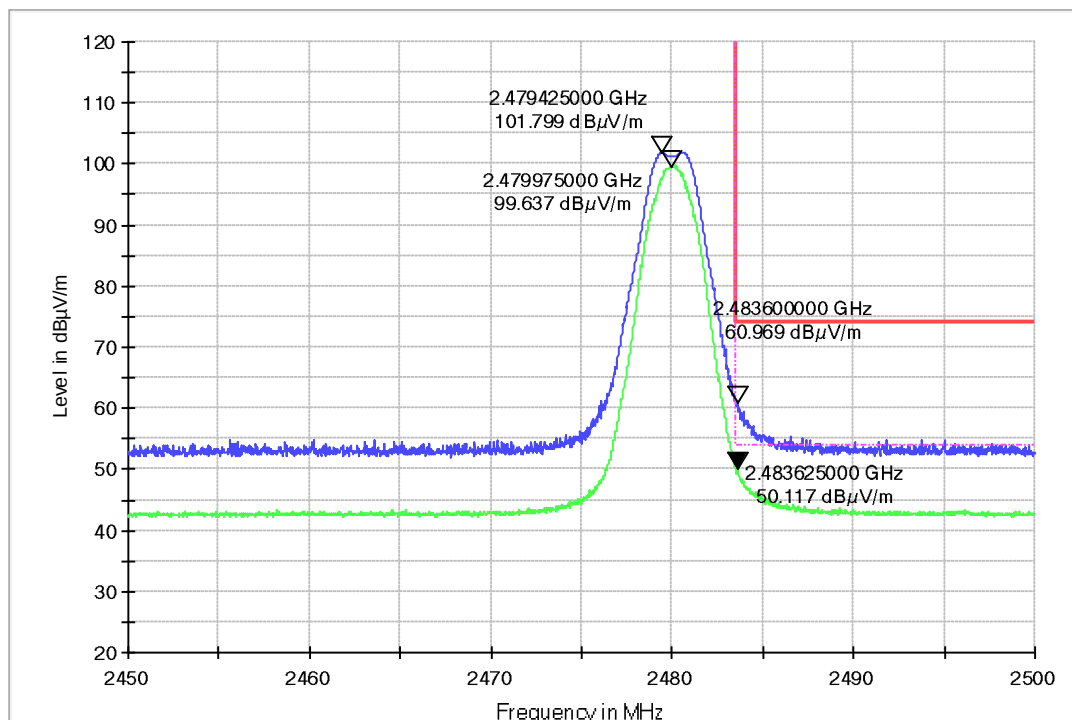


**Figure 8: Radiated Band-Edge, 2480MHz, H**

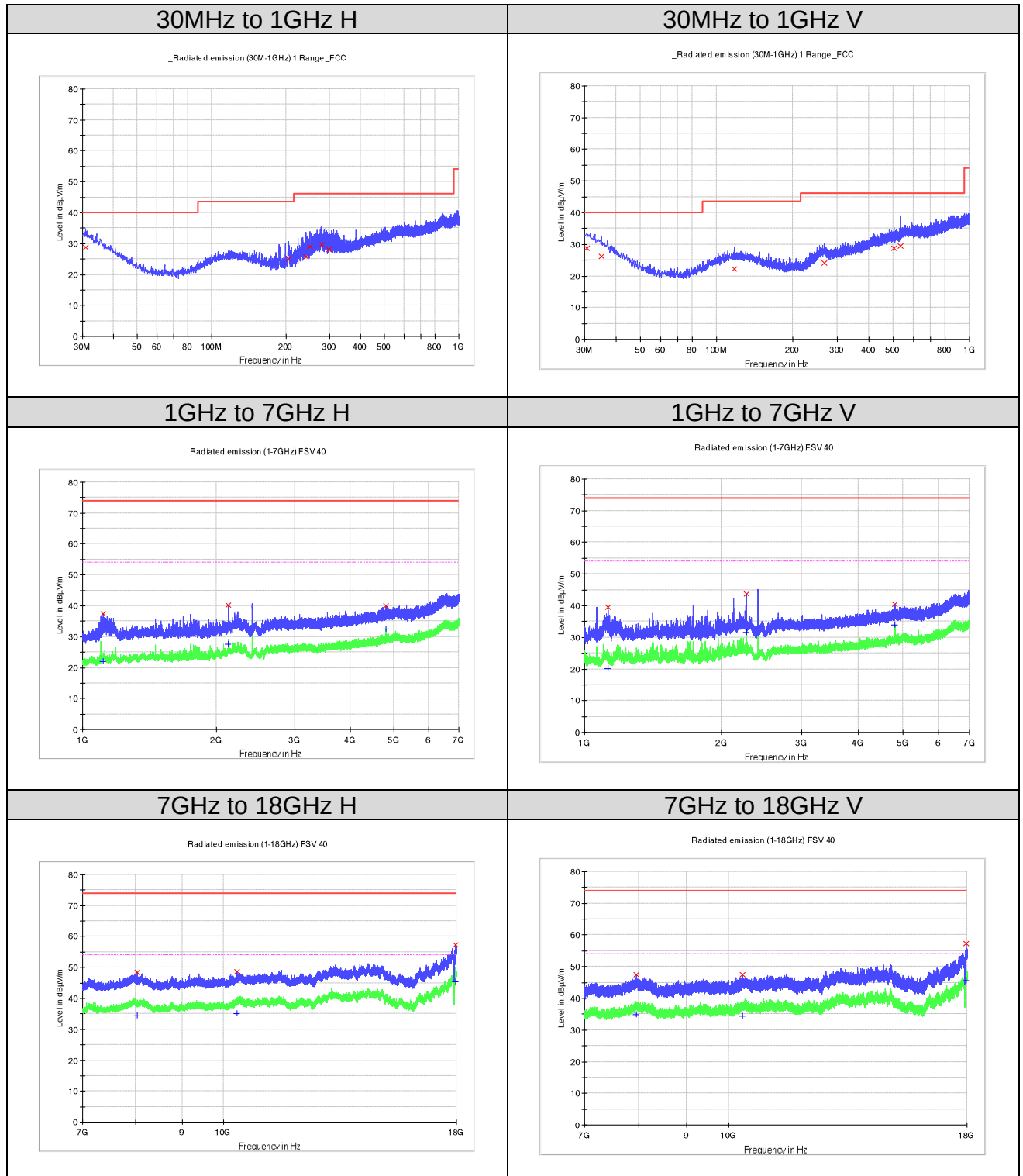

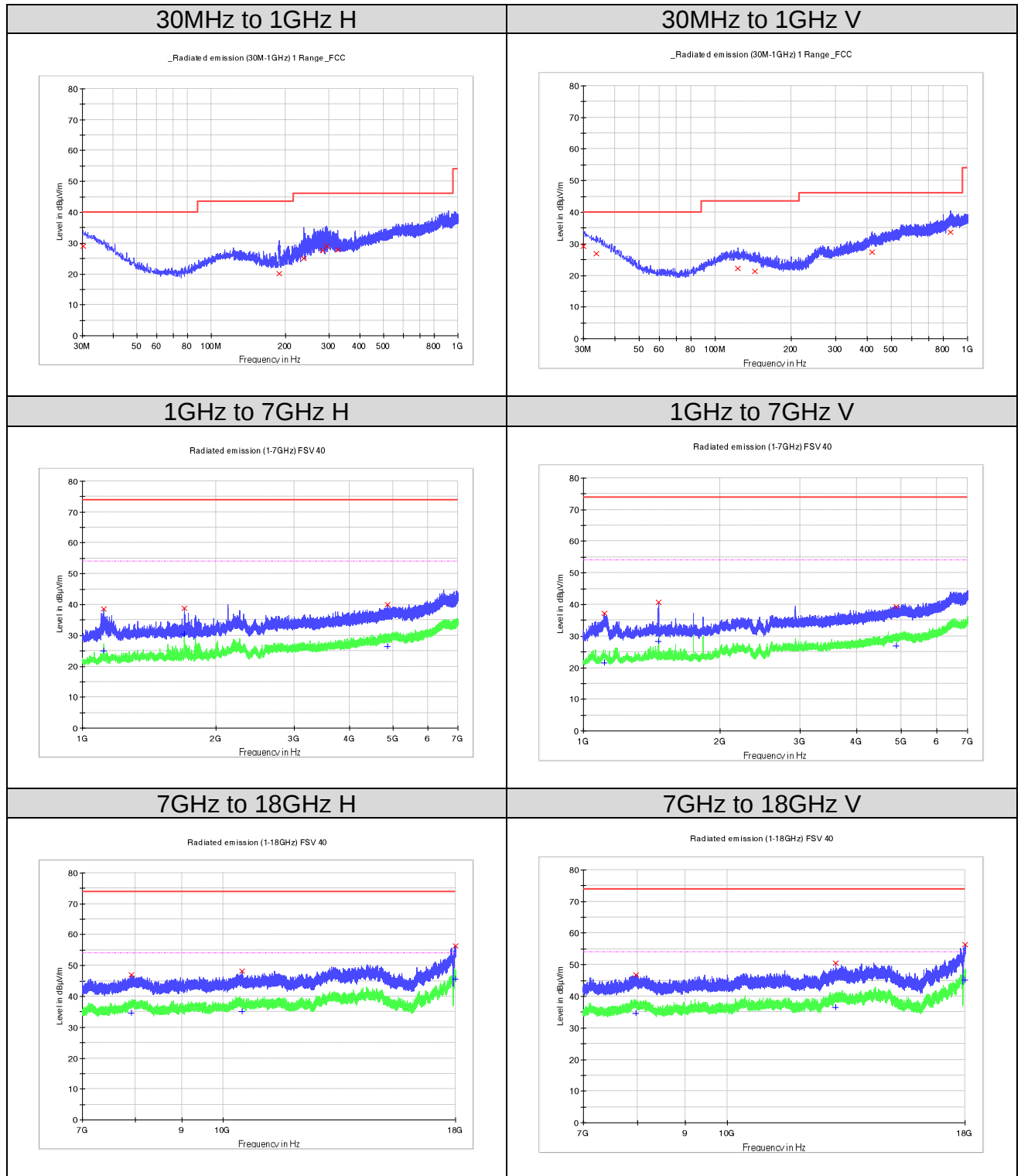

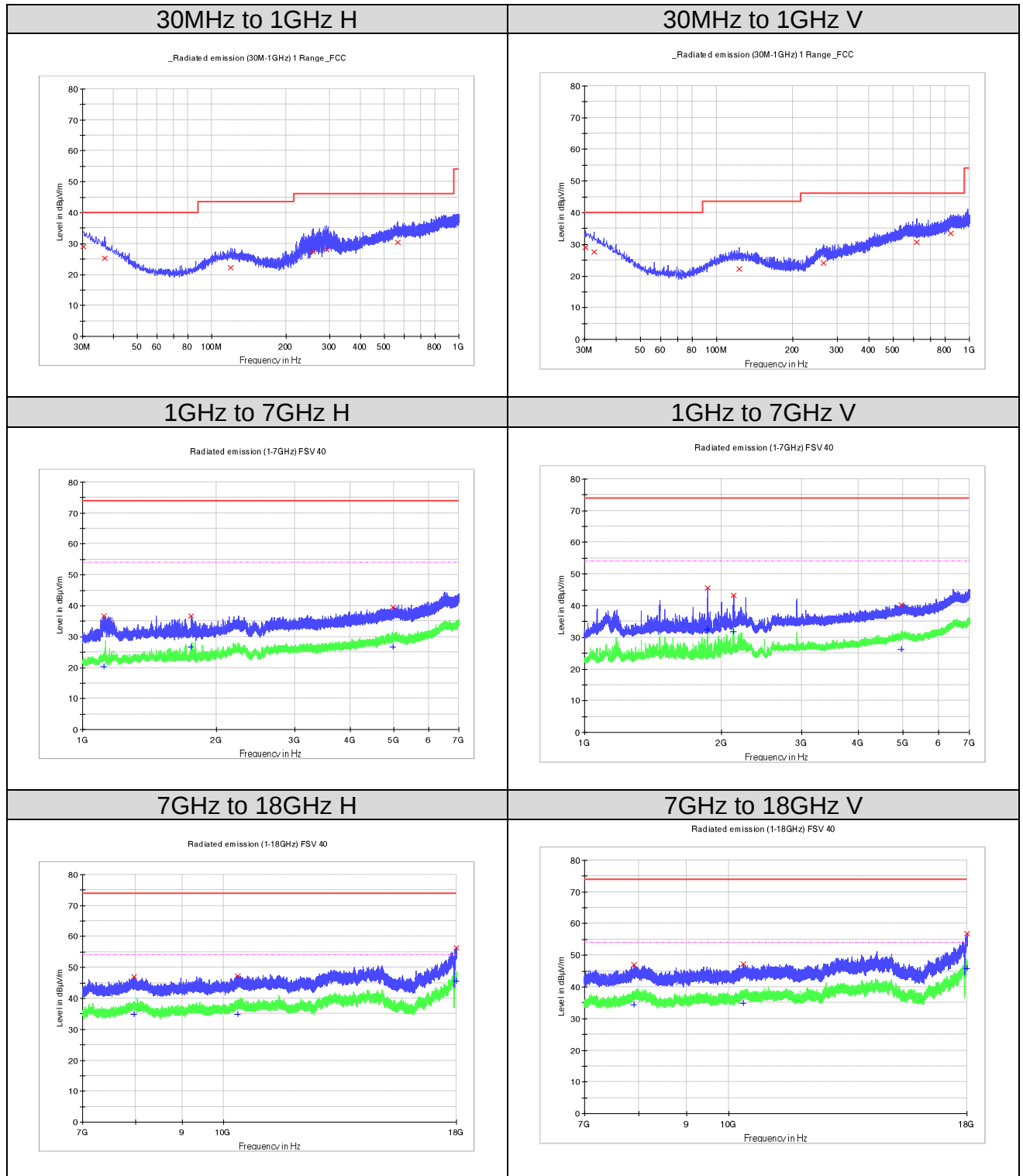
