

The sample was placed 0.8m above the ground plane of Semi-Anechoic Chamber\*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.





#### Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (49.72msec) never exceeds a series of 1 long (531.06µsec), 1 short + 1 (230.46µsec) and 6 short 2 (50.1µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered  $1 \times 531.06 \mu\text{sec} + 1 \times 230.46 \mu\text{sec} + 6 \times 50.1 \mu\text{sec}$  per 49.72msec = 2.13% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Duty Cycle Correction =  $20\text{Log}(0.0213) = -33.4\text{dB}$




