

Authorization Letter

For FCC Certification of the TG211, TG213 and TG215

Dear Sir or Madam,

- 4) Cameo shall indemnify, defend and hold Technicolor, its officers, employees, agents, customers and end-users and each of its affiliated companies and their respective officers, employees and agents harmless from any claims, liabilities, losses, damages, costs and expenses (including reasonable attorneys' fees) incurred by Technicolor as a result of Cameo's misuse of Technicolor's FCC ID, unauthorized disclosure of any confidential information accessed by Cameo or otherwise in relation to the purpose of this authorization letter.

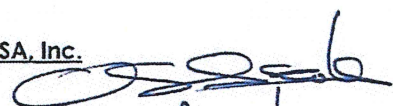

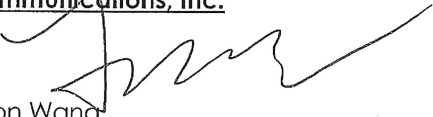
