**Operating Configurations and Exposure Conditions:**

The EUT base unit is normally operated at least 20 cm away from the human body.

The EUT handset is operated close to the head and to the body with belt clip. Refer to Exhibit A(9) for the SAR Test Report.

**Maximum Permissible Exposure Calculation:      BASE UNIT**

The minimum separation distance, for compliance with the limit, is calculated as follows:

$$E(V/m) = \frac{\sqrt{30 \times P \times G}}{d} \quad \text{Power density: } P_d(mW/cm^2) = \frac{E^2}{3770}$$

The limit for general population/uncontrolled exposure environment above 1500MHz is 1mW/cm2

**BASE UNIT****RF Exposure Calculations**

1. The limit for general population/uncontrolled environment above 1500 MHz is 1.0 mW/cm<sup>2</sup>.
2. The Field Strength  $E$  (V/M) =  $\sqrt{1.0 \times 3770} = 61.4$
3. The distance  $d$  to achieve the 1.0 mW/cm<sup>2</sup> power density is as follows

$$d = \frac{\sqrt{30 \times P \times G}}{E}$$

$$d = \frac{\sqrt{30 \times 0.1529 \text{ W} \times 1}}{61.4} = \frac{2.1417}{61.4} = 3.49 \text{ cm}$$

**RF Field Strength Calculations:**

1. F. S. = 120.84 dB $\mu$ V/m
2.  $F.S. = \text{antilog} \frac{120.84}{20} = \text{antilog } 6.042 = 1.1015 \text{ V/M}$
3.  $ERP = \frac{(1.1015)^2 \times 9}{49.2} = 222 \text{ mW}$
4. EIRP = 222 x 1.64 = 364 mW
5. Time Division Source Based Average Power  

$$= 364 \times \frac{1.05 \text{ mS (ontime 1 + 4 slots)}}{10 \text{ mS}} = 364 \times 0.42 = \underline{152.9 \text{ mW}}$$

**Conclusion:**

The device complies with the MPE requirements by providing a safe separation distance between the antenna, including any radiating structure, and any persons (human body excluding hands, wrists, ankles, and feet).
