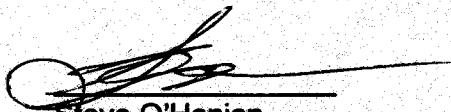

Pursuant to CFR Title 47, Paragraph 2.929, Honeywell Inc., Commercial Flight Systems Group, Business and Commuter Aviation Systems Division wishes to inform the FCC that as a result of a merger with AlliedSignal Inc. we are in the process of changing our name. The physical location of the Design and Manufacturing facility for the Business and Commuter Aviation Systems Division products will remain the same. Our name change is as follows:

At our three facilities here in the Phoenix area, we design and manufacture avionics equipment and presently have 28 equipments certified under the FCC Grantee Codes RT-300, GB8, GB84DV, and BEU9E0. GB8 and GB84DV were granted to Honeywell Inc. in 1987, BEU9E0 and RT-300 were granted to the Sperry Corporation, Aerospace and Marine Group which was

previously acquired by Honeywell Inc. in 1987. Honeywell continued the marking of the BEU9EO and RT-300 products. RT-300 was granted before grantee codes were issued.

It is Honeywell's desire to continue to label our units with the FCC Grantee Codes noted above. This would alleviate the enormous task of requesting different Grantee Code changes to all our units as well as re-certification of all our foreign approvals. Under the Honeywell format, we have adequately maintained the multiple FCC Grantee Codes on our units with no confusion. All new designs submitted for FCC certification will be under grantee code GB8.

Please update your records to our new address and advise if additional information is needed in relation to the name change. It is Honeywell International Inc.'s intention, at all its facilities, to continue to maintain full compliance with all the FCC regulations that pertain to the equipment that we manufacture and certificate with the FCC.
