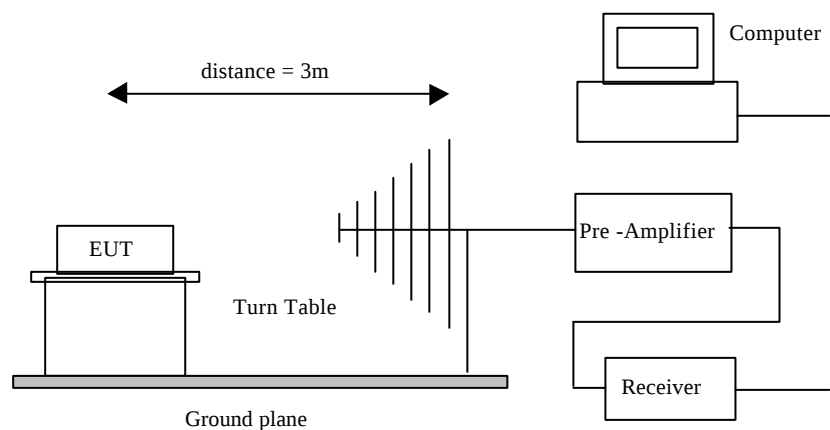

Test Method:

The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigate all operating modes, rotated about all 3 axis (X, Y & Z) to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

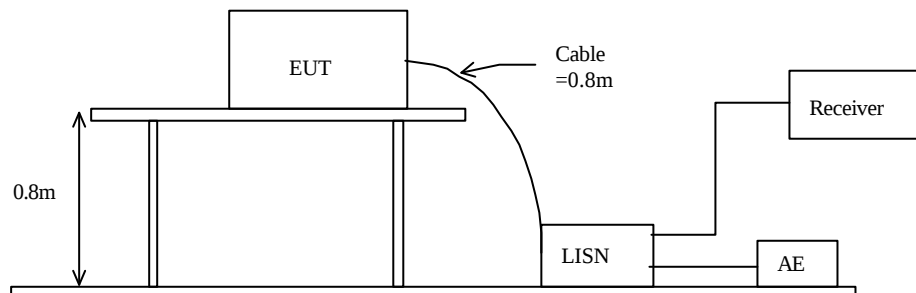

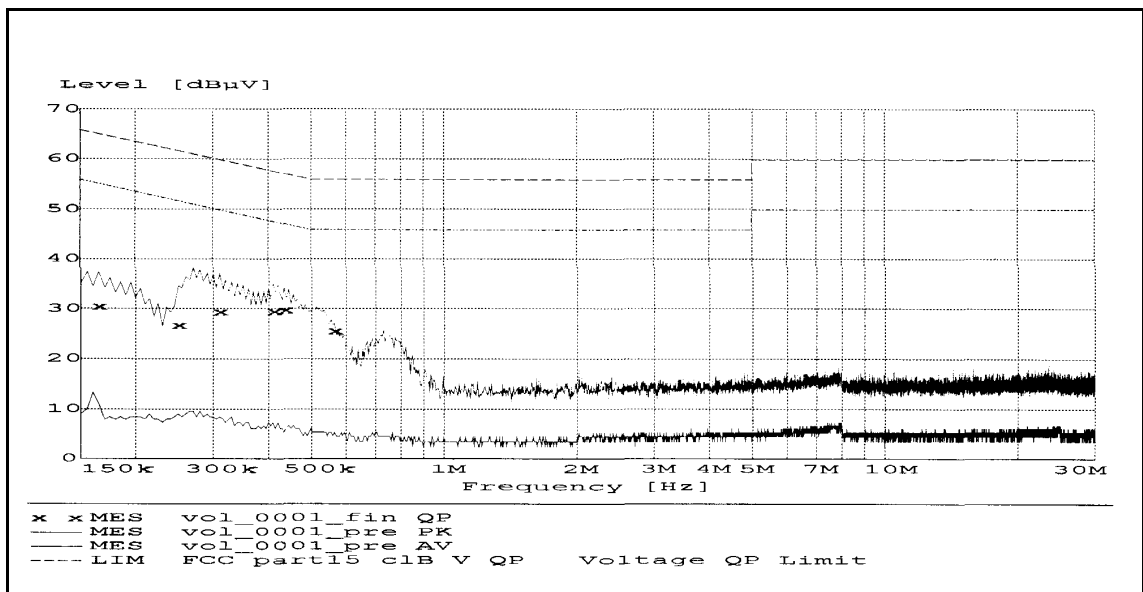

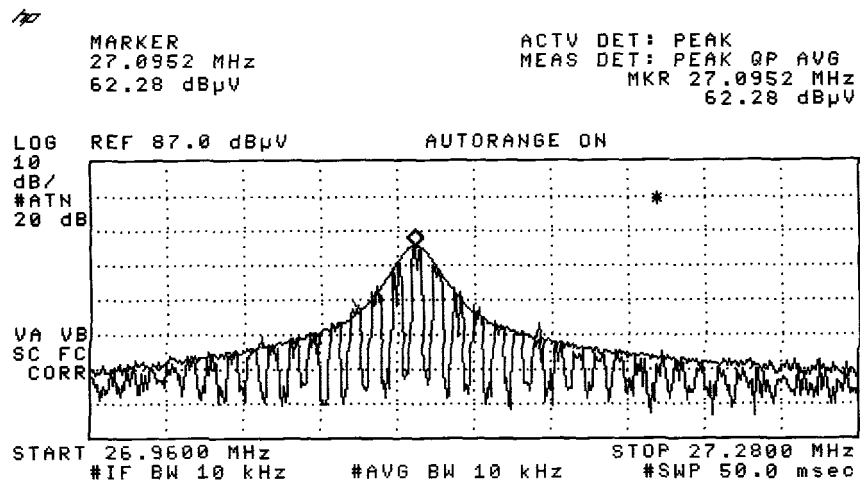

Appendix B**Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (43.5msec) never exceeds a series of 33 long (625µsec) or short (500µsec) pulse. Assuming any combination of short and long pulse may be obtained due to encoding the worse case transmit duty cycle would be considered 33x625µsec per 43.5msec=47.4% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

$$\text{Duty Cycle Correction} = 20\text{Log}(0.474) = -6.4\text{dB}$$

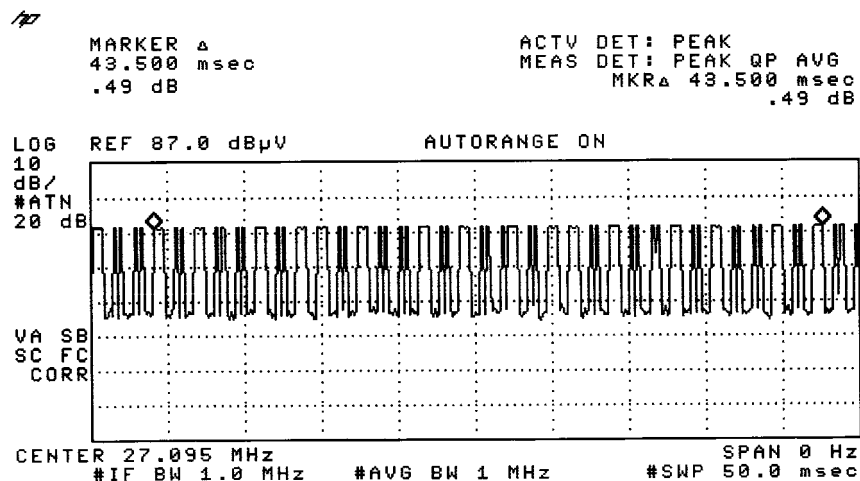
Figure A [Pulse Train]

Figure B [Long Pulse]

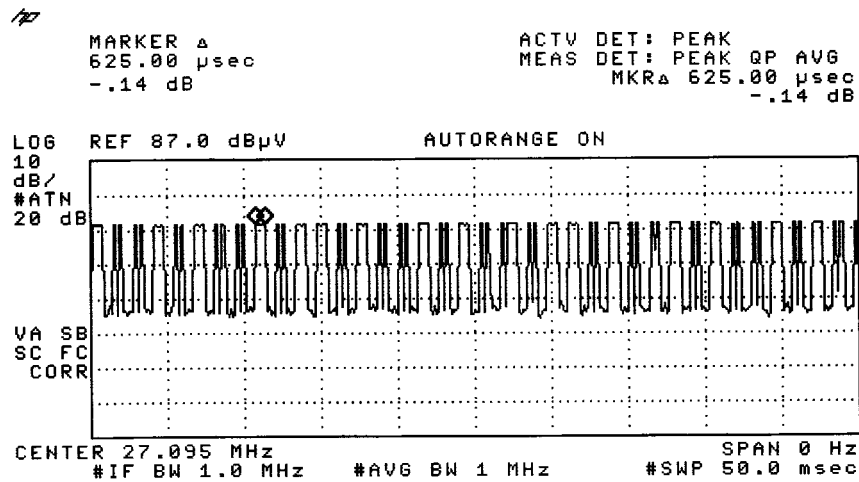
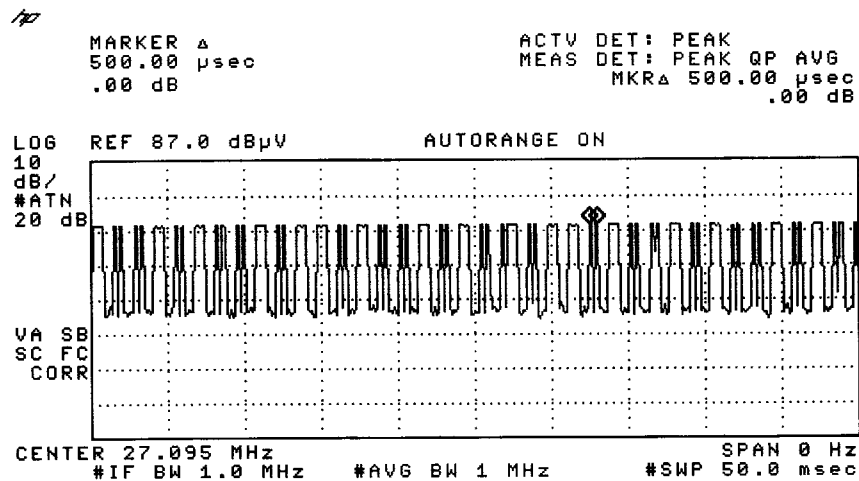


Figure C [Short Pulse]

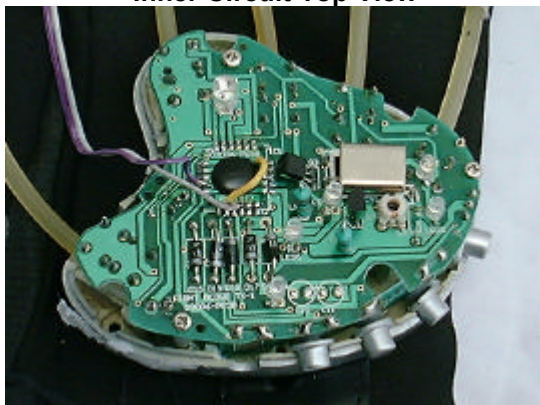
Front View of the product



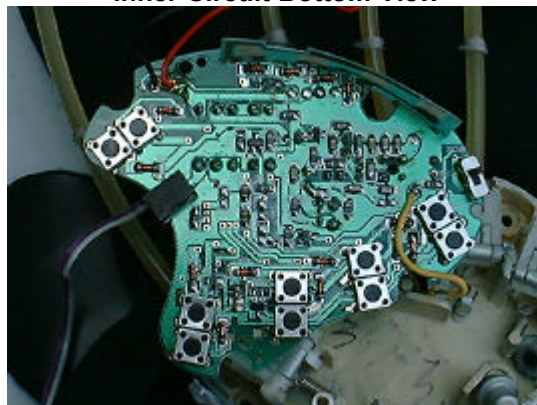
Rear View of the product

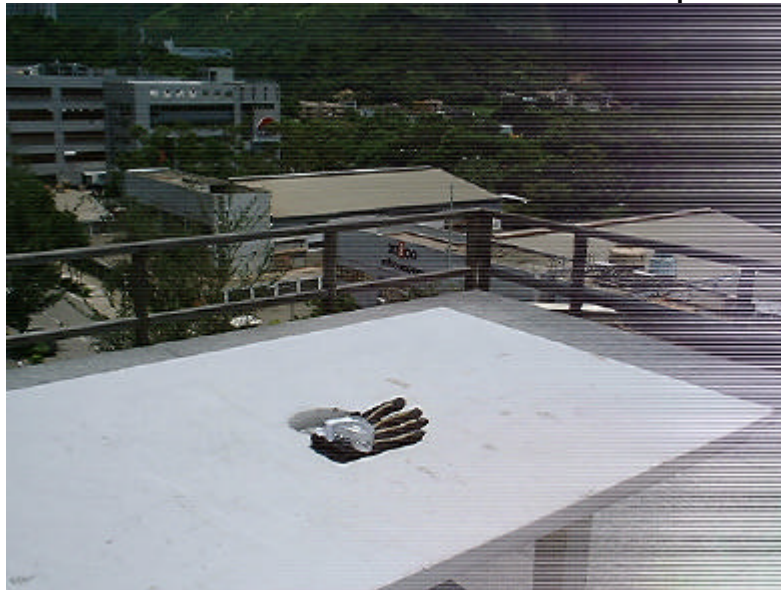
