

Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (45.125msec) never exceeds a series of 32 long (625μsec) or short (500μsec) pulse. Assuming any combination of short and long pulse may be obtained due to encoding the worse case transmit duty cycle would be considered 32x625μsec per 45.125msec=44.3% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Figure B [Long Pulse]





Figure C [Short Pulse]


Rear View of the product
