



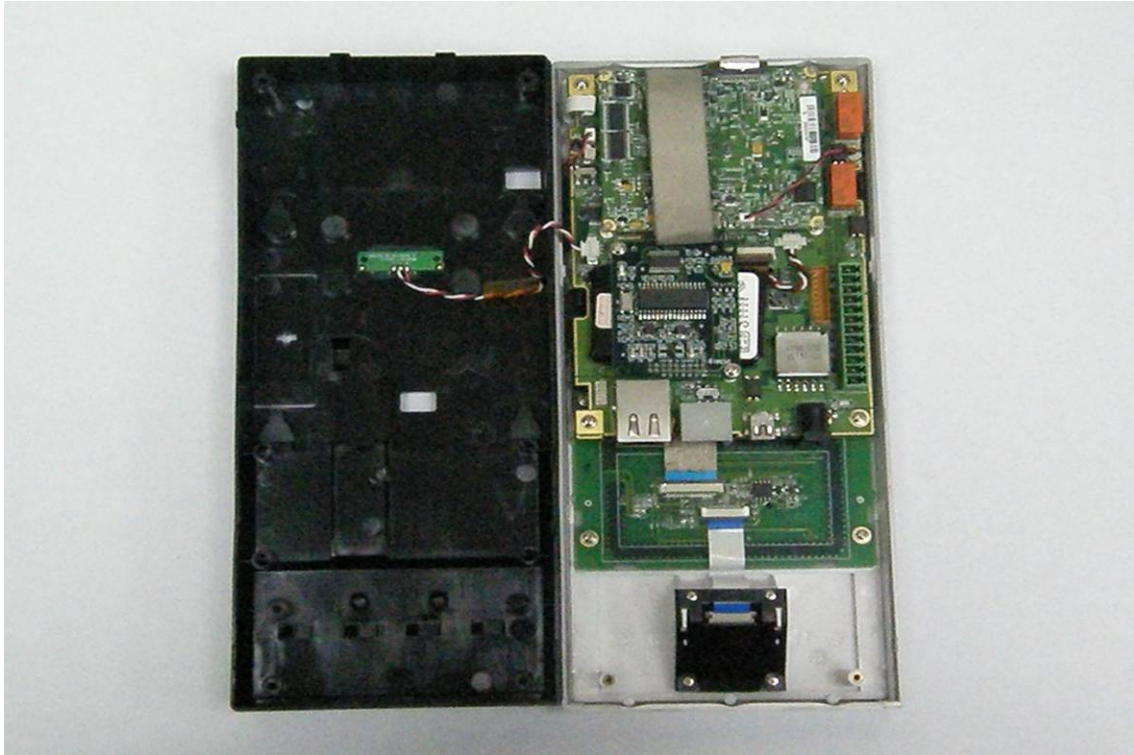

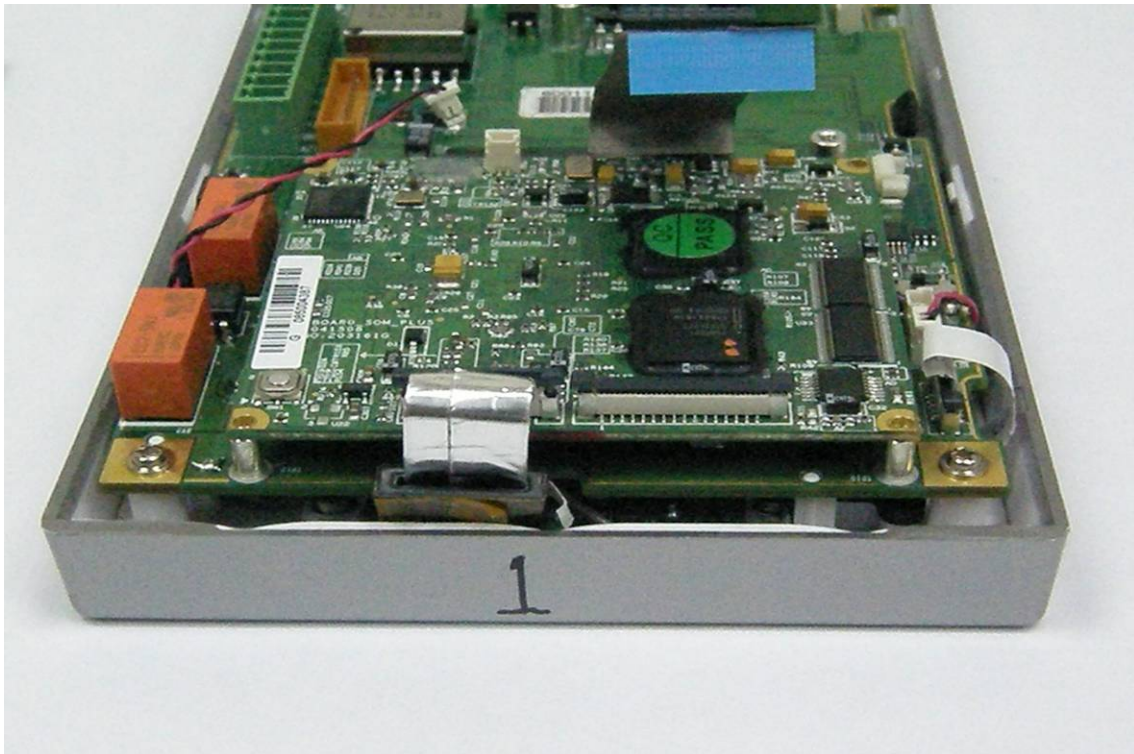

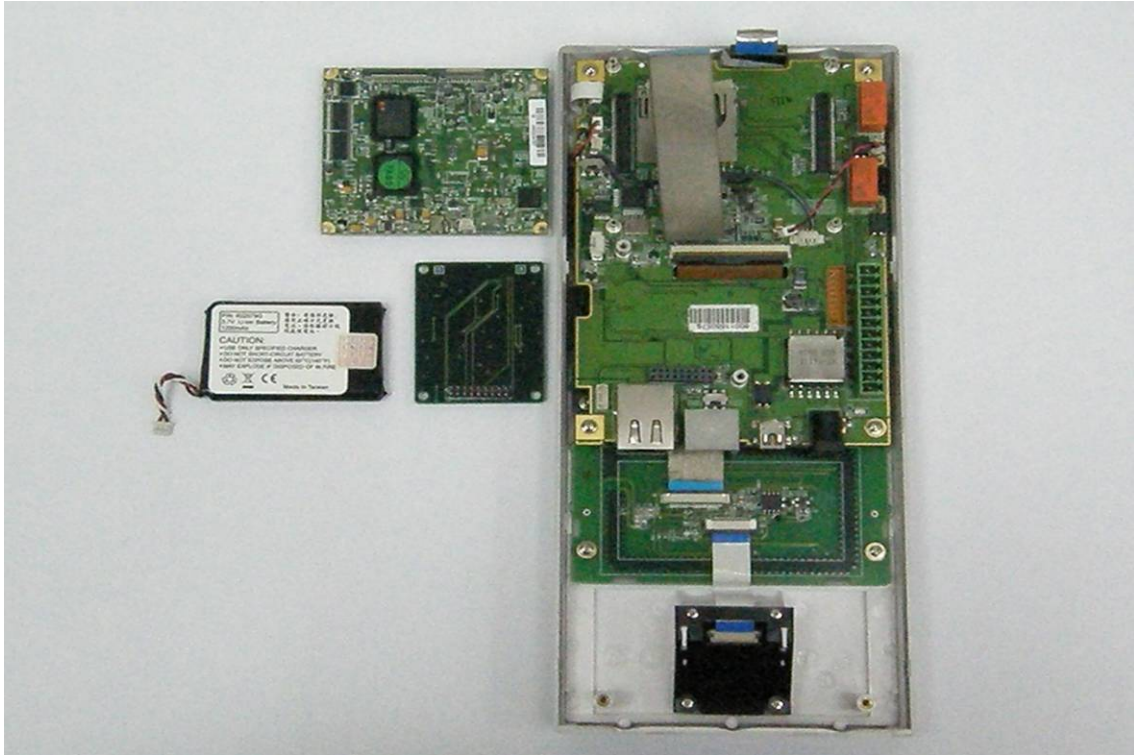


*Open View of EUT – 2*

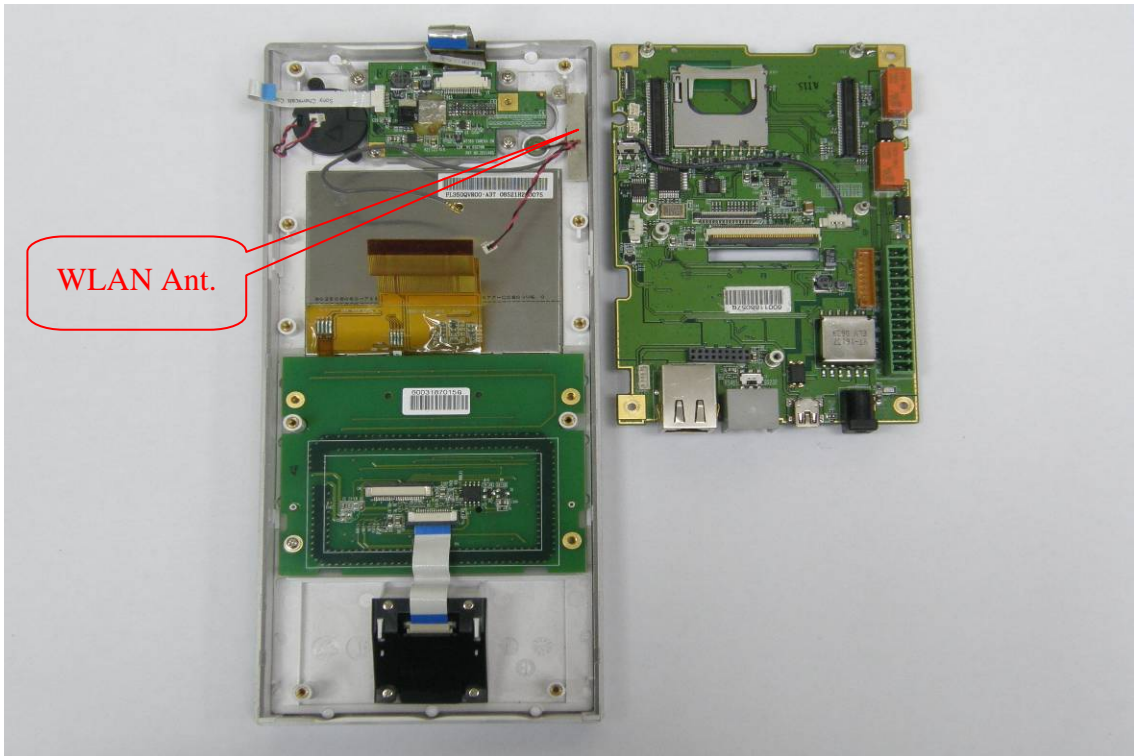

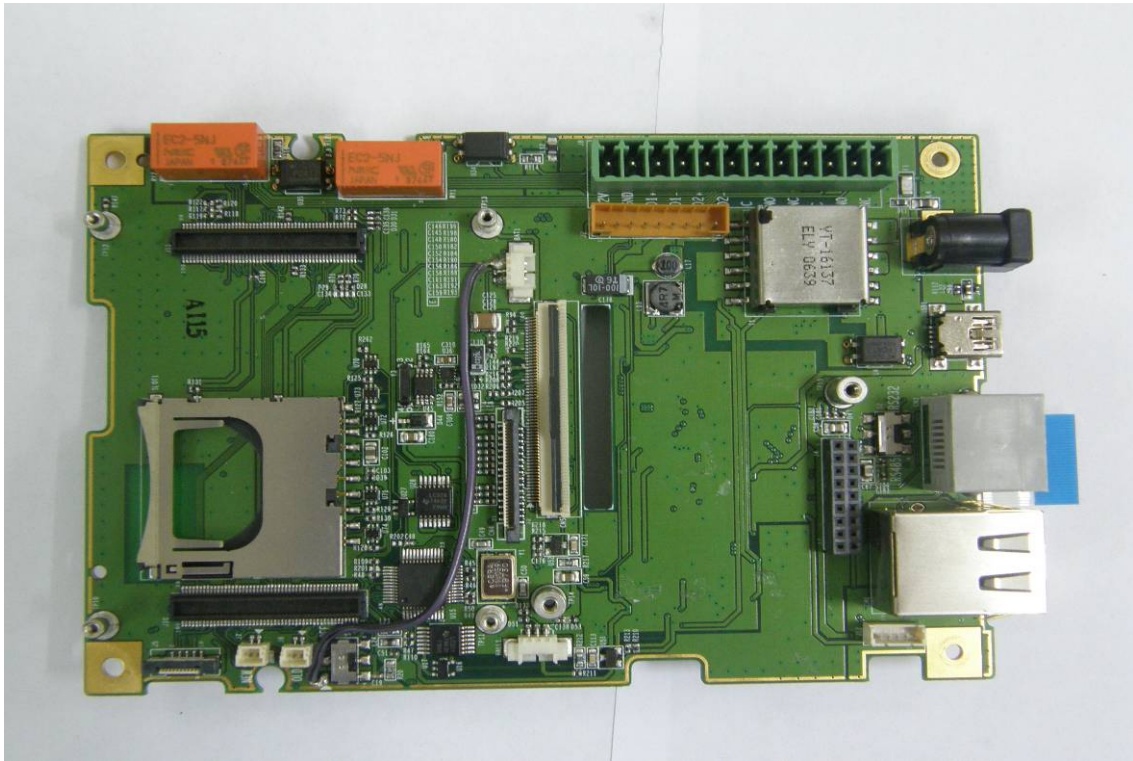


*Open View of EUT – 4*

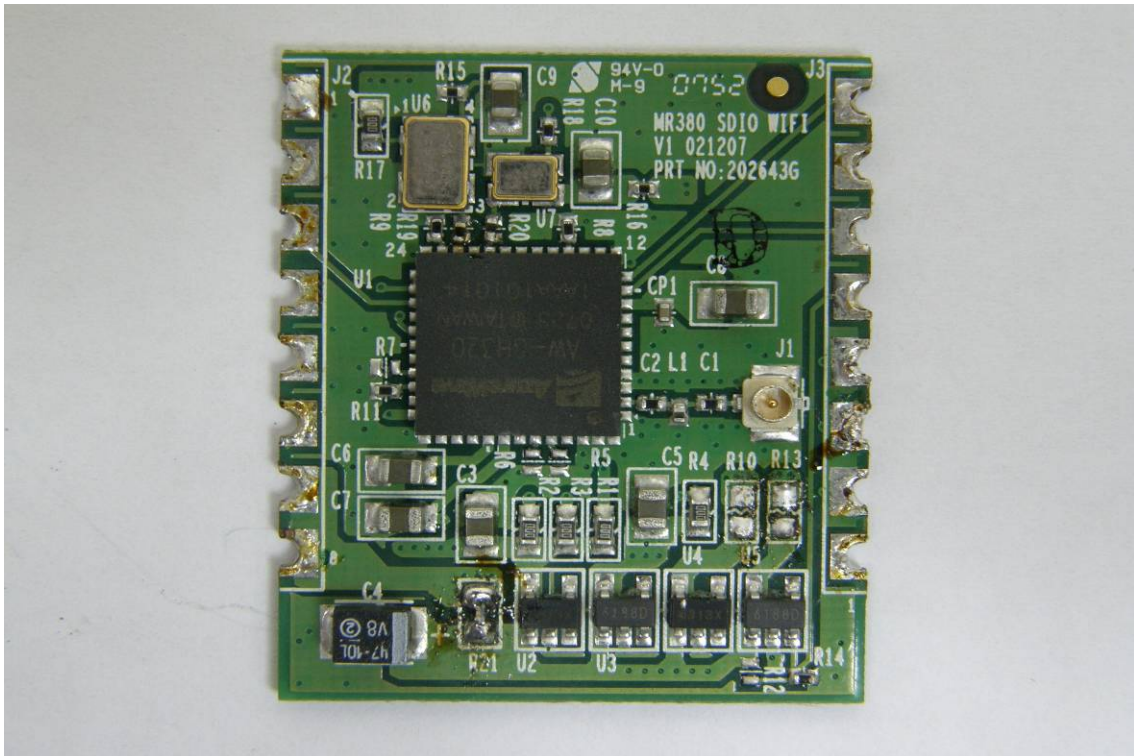

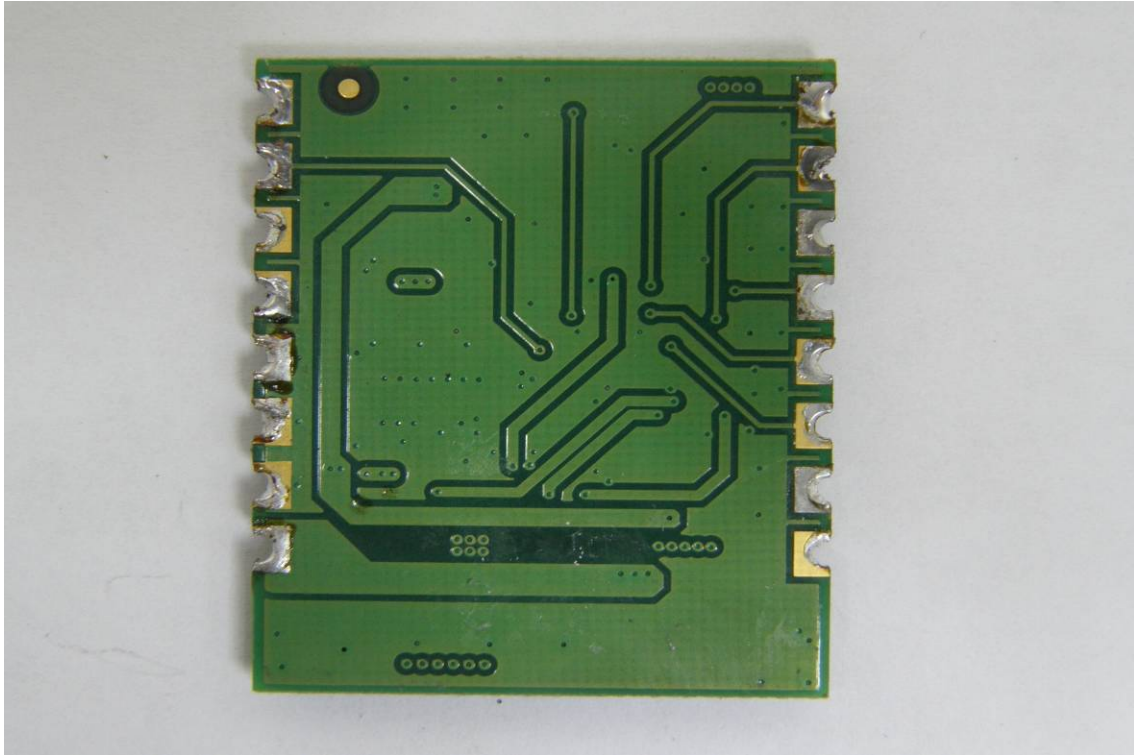


*Internal of EUT – 4 (WLAN)*

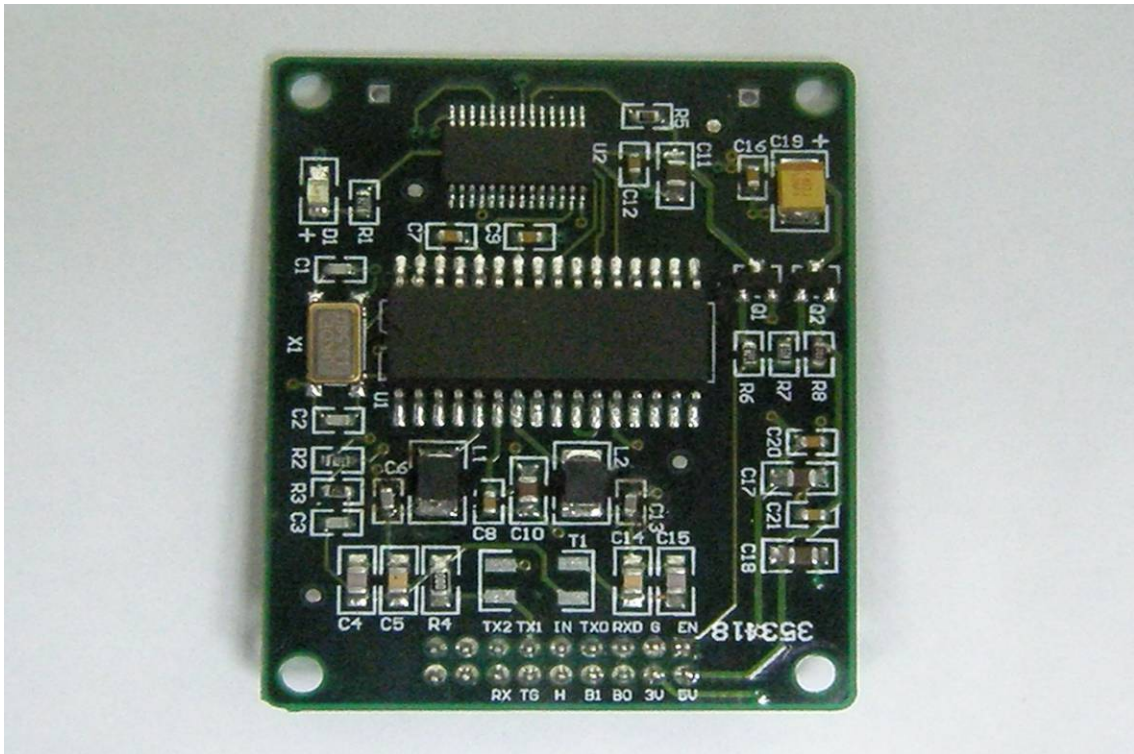

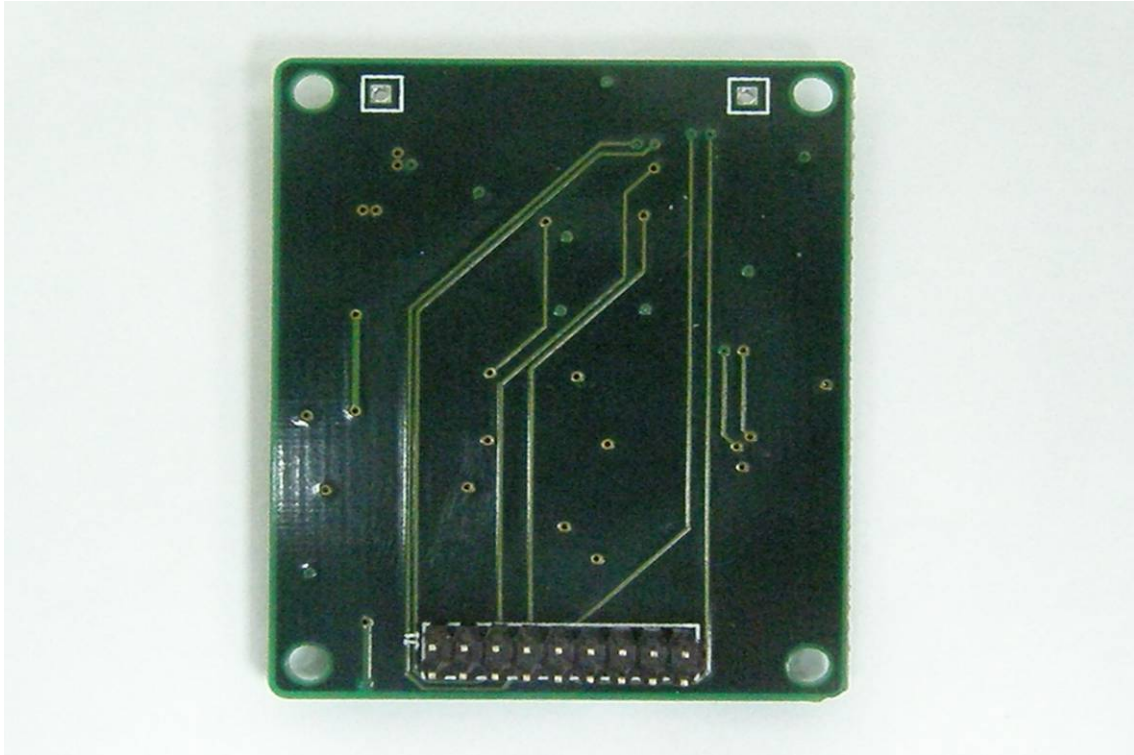


*Internal of EUT – 6 (RFID)*

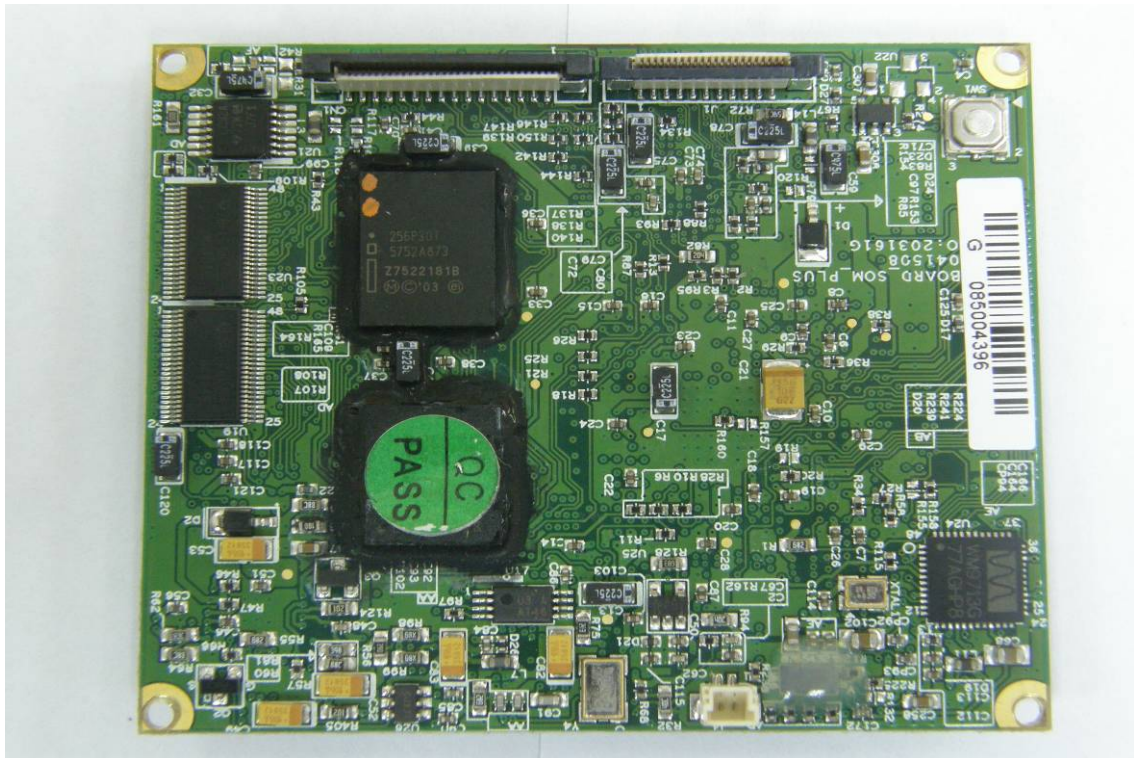

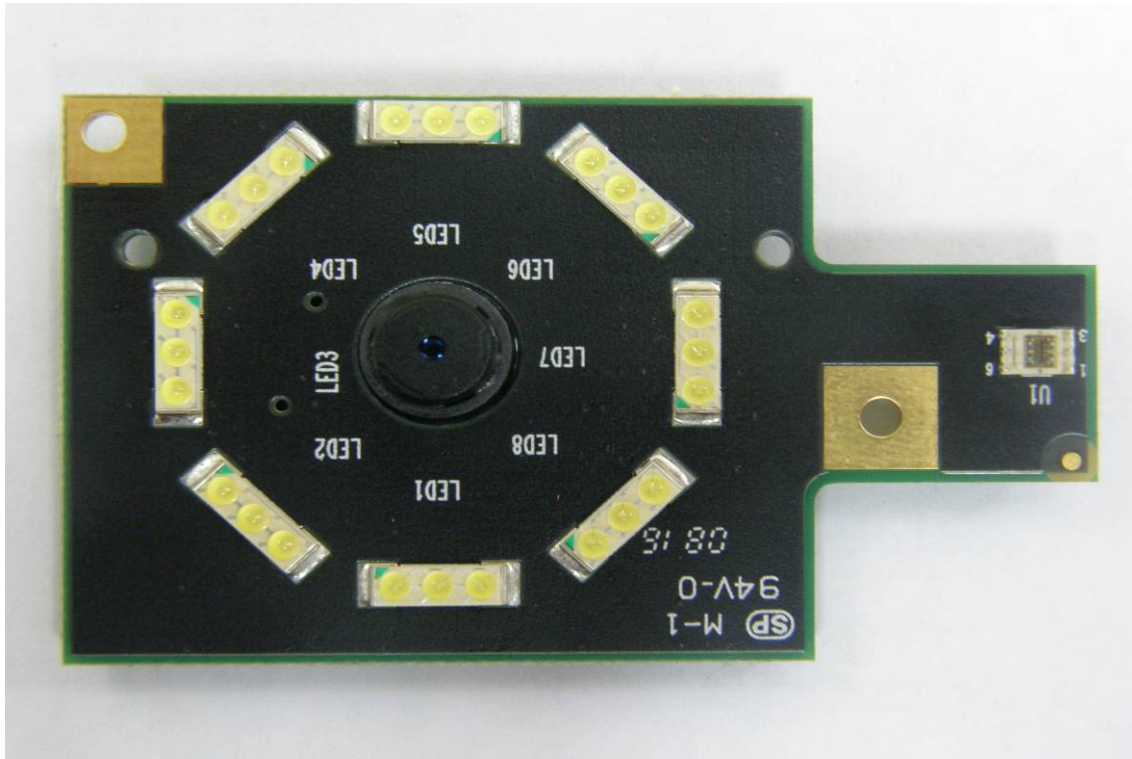

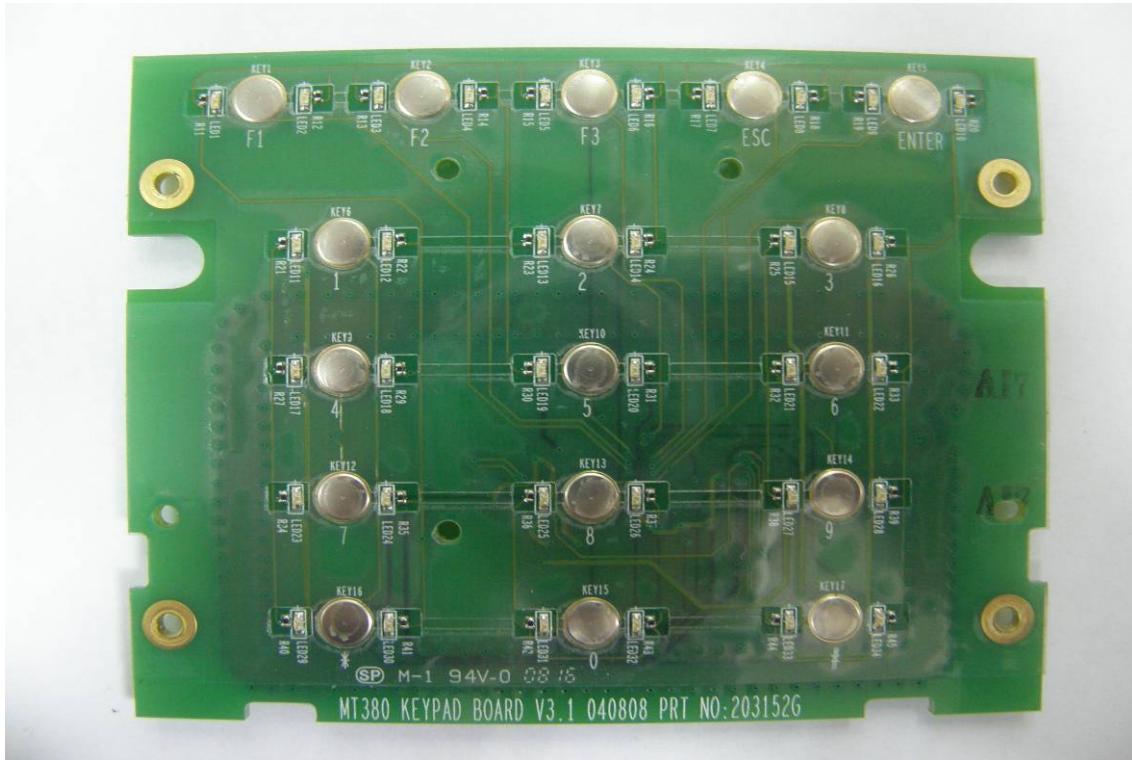
