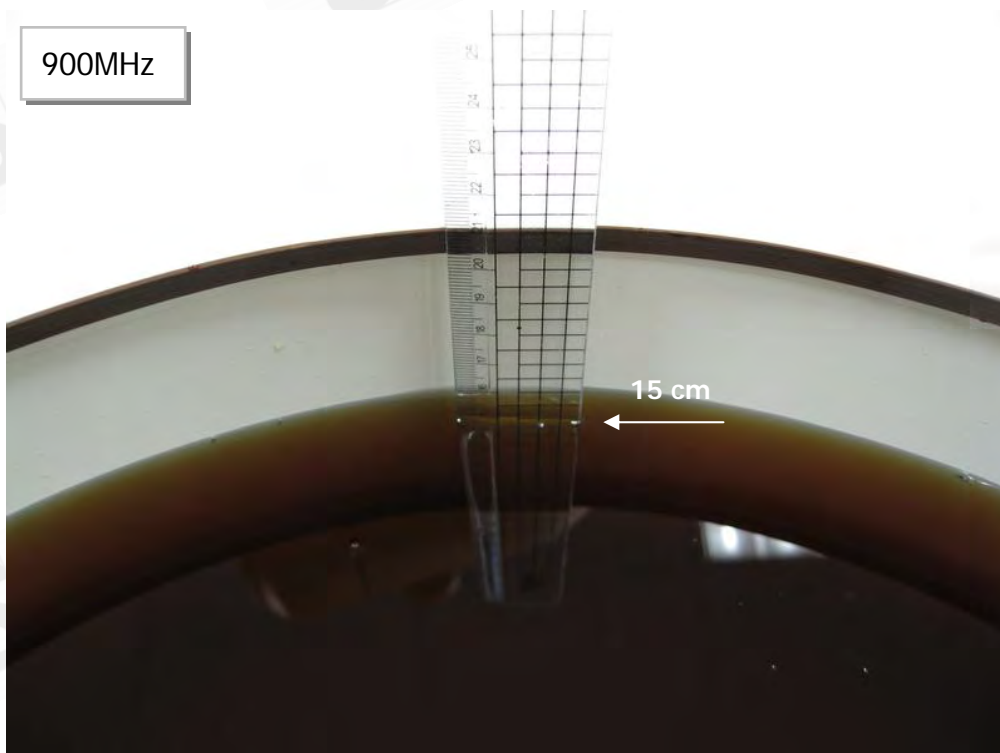

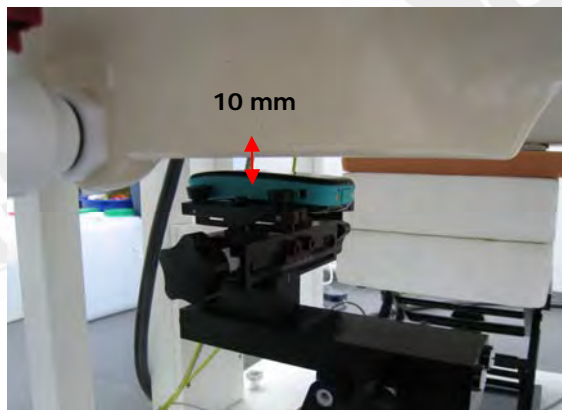

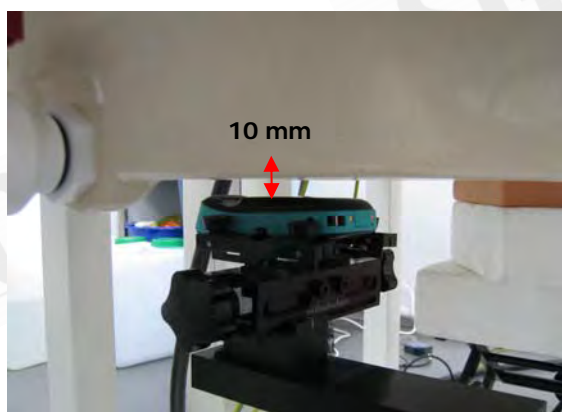

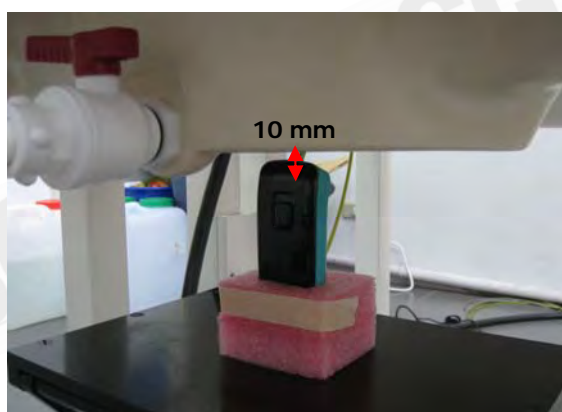

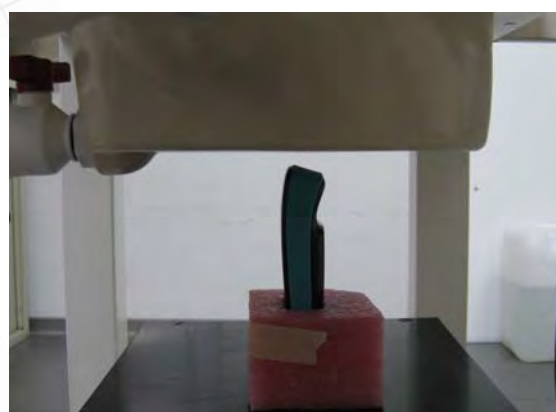
**Fig.3 EUT Front side to flat phantom**

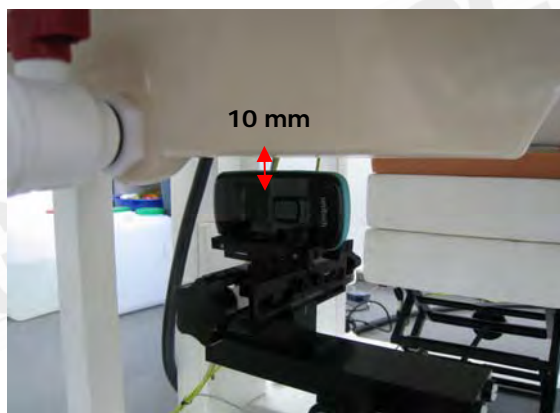

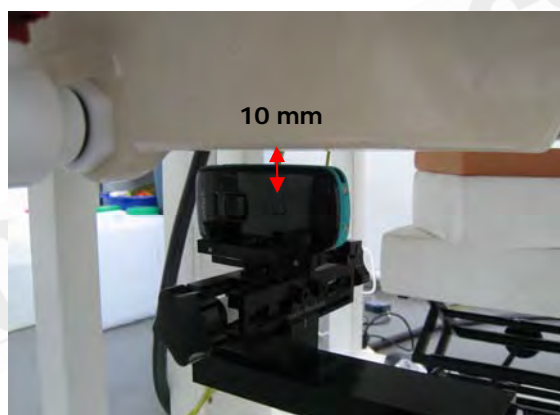

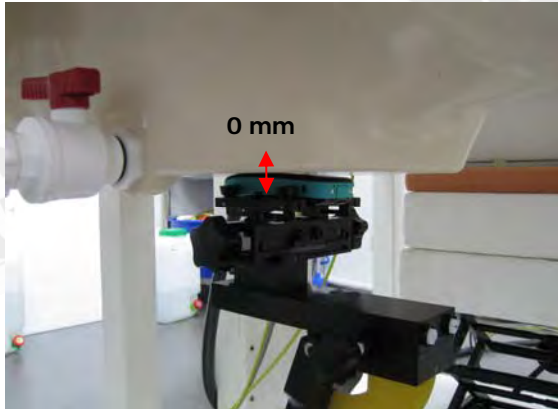

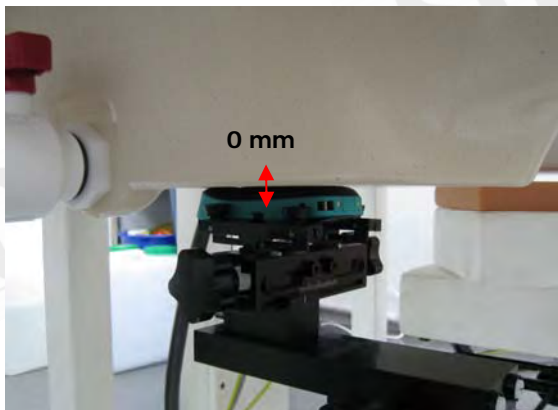
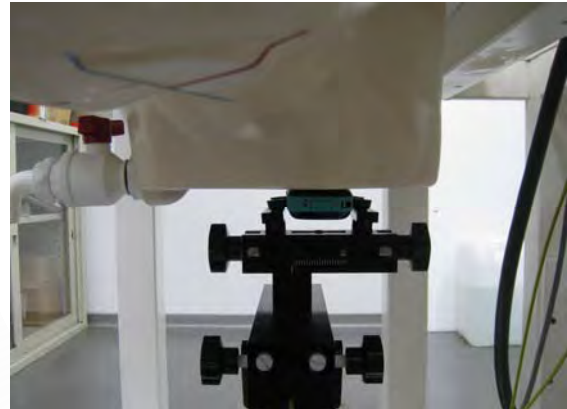

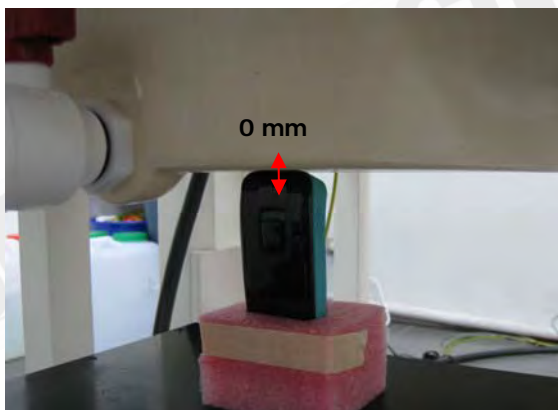
**Extremity - distance between flat phantom and EUT is 0 mm**



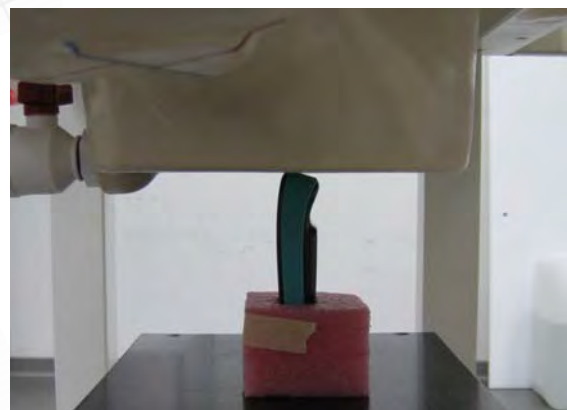
**Fig.8 EUT Front side mode to flat phantom**

**Fig.10 EUT Top side to flat phantom**



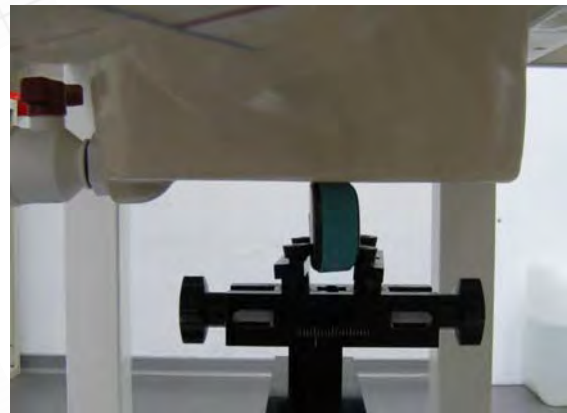

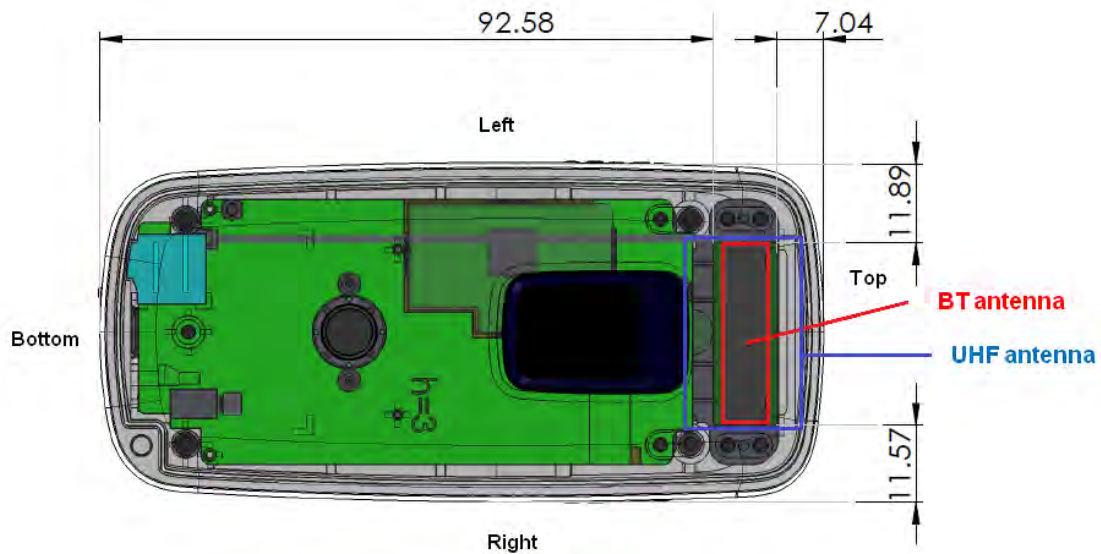


Fig.15 Antenna location (front view)
