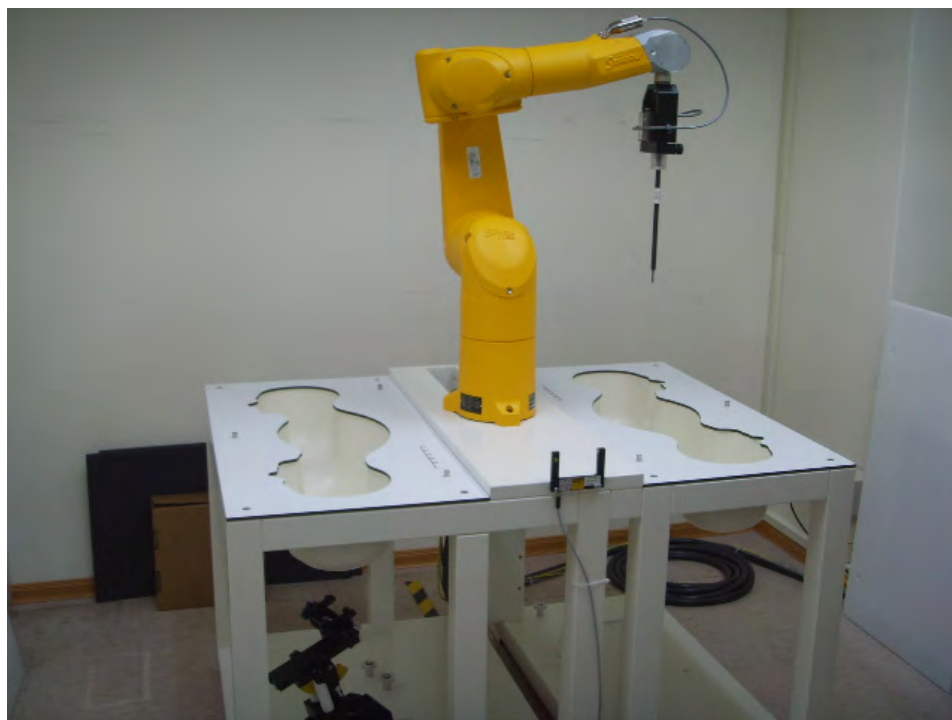


Fig.1 Photograph of the SAR measurement system

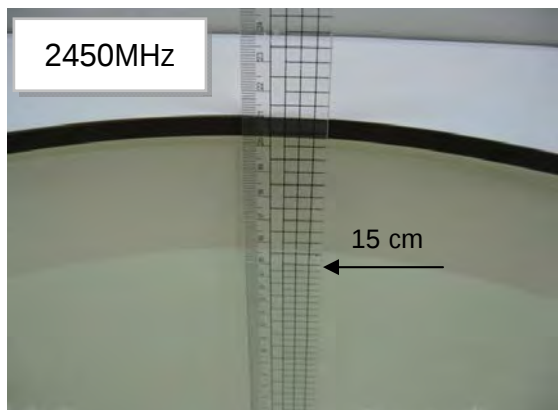

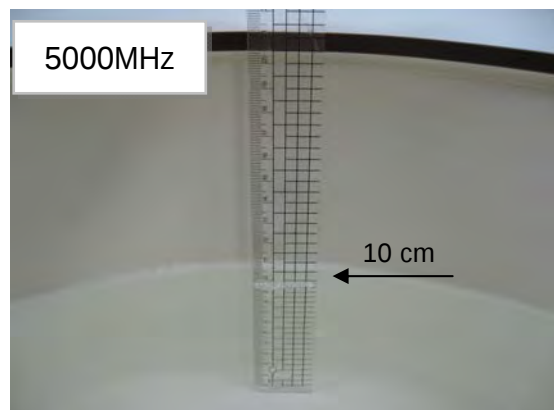

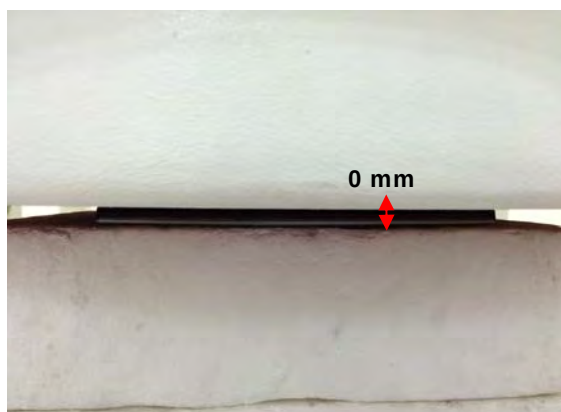
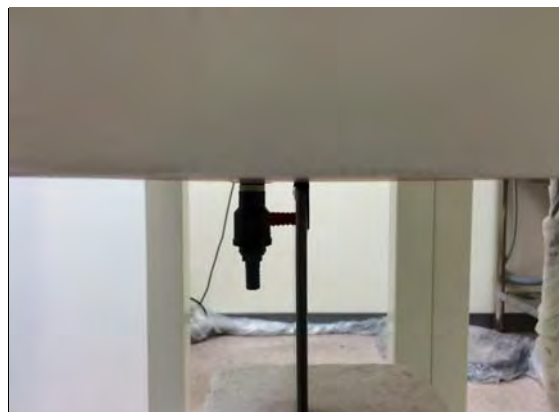


Fig.4 EUT Back side to flat phantom

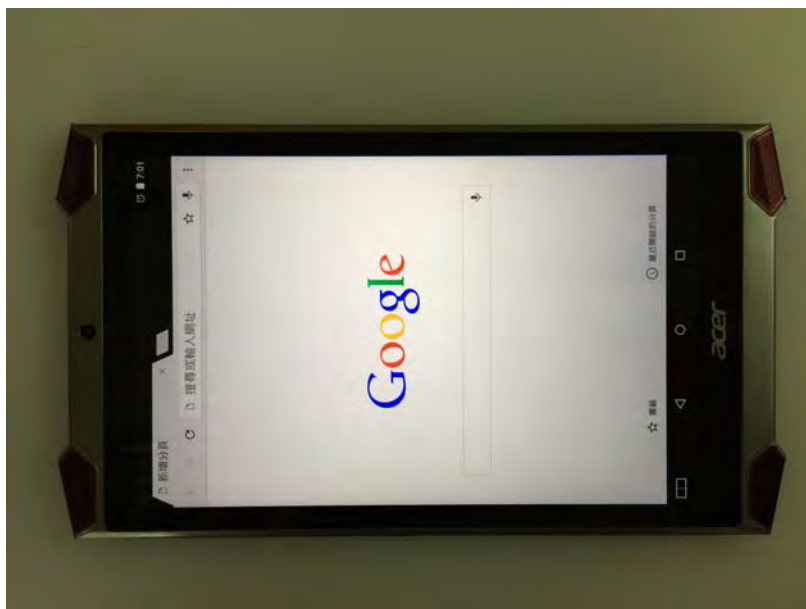


Fig.5 Front view of EUT

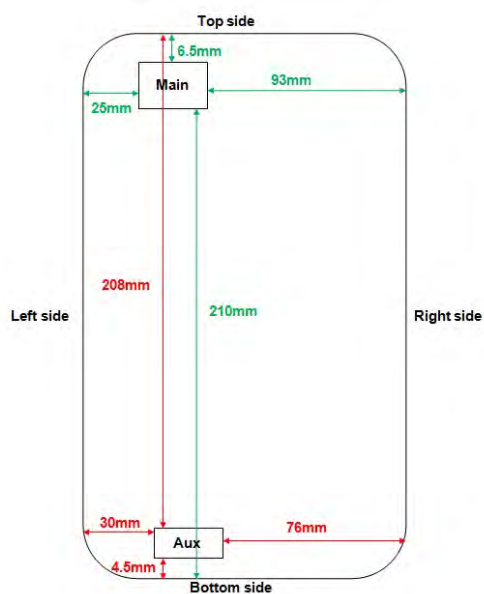


Fig.8 Antenna position of EUT (Back view)
