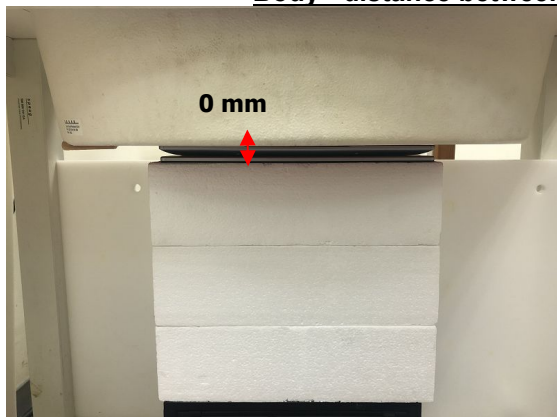

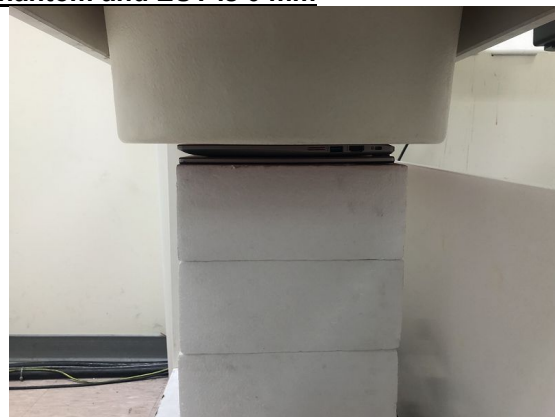

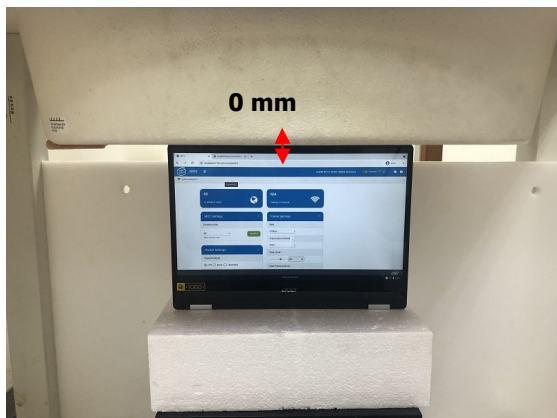

**Photograph 1. Body, Back Surface, 0mm**



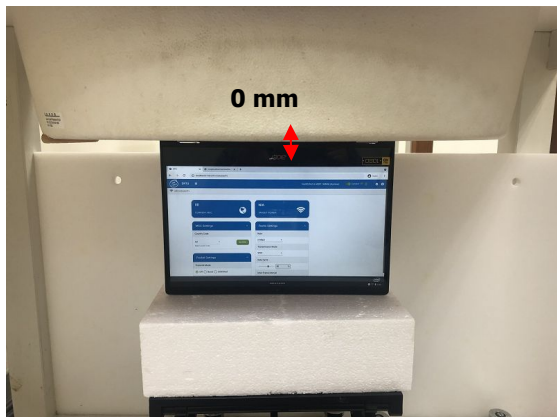
**Photograph 2. Body, Back Surface, 0mm**



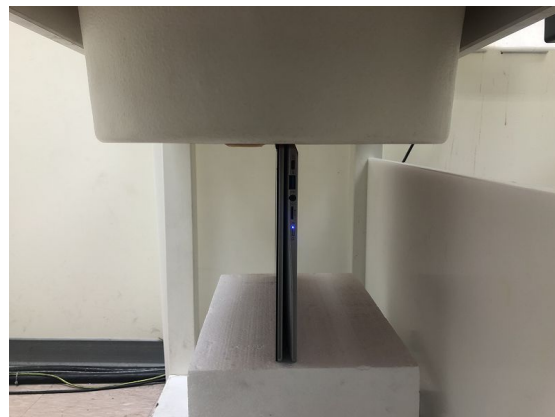
**Photograph 3. Body, Top Edge, 0mm**

**Photograph 5. Body, Bottom Edge, 0mm**

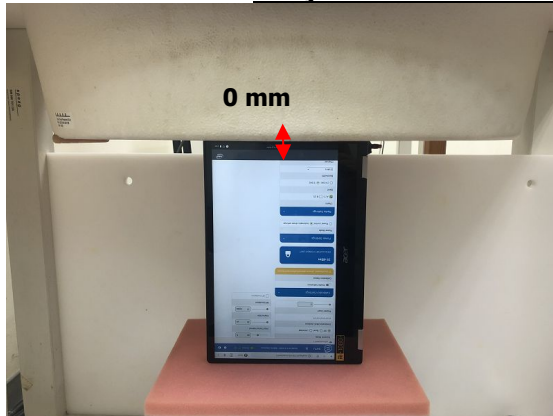


**Photograph 6. Body, Bottom Edge, 0mm**

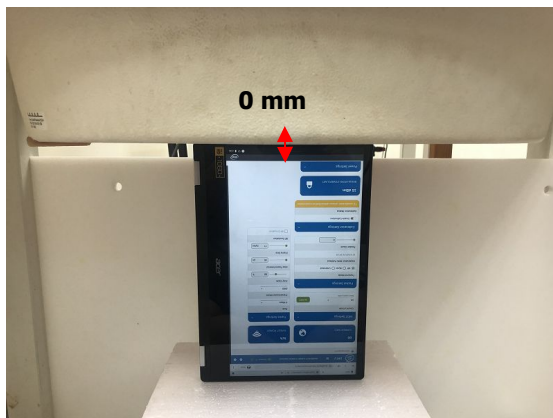

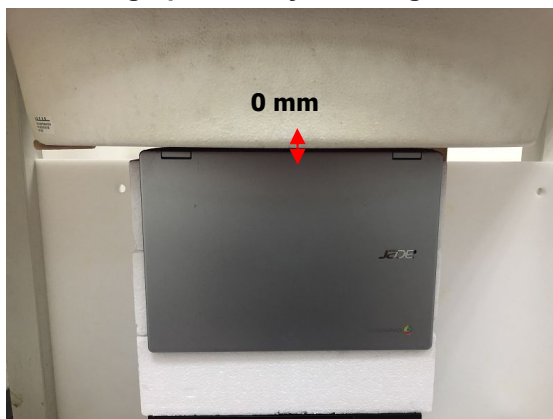
