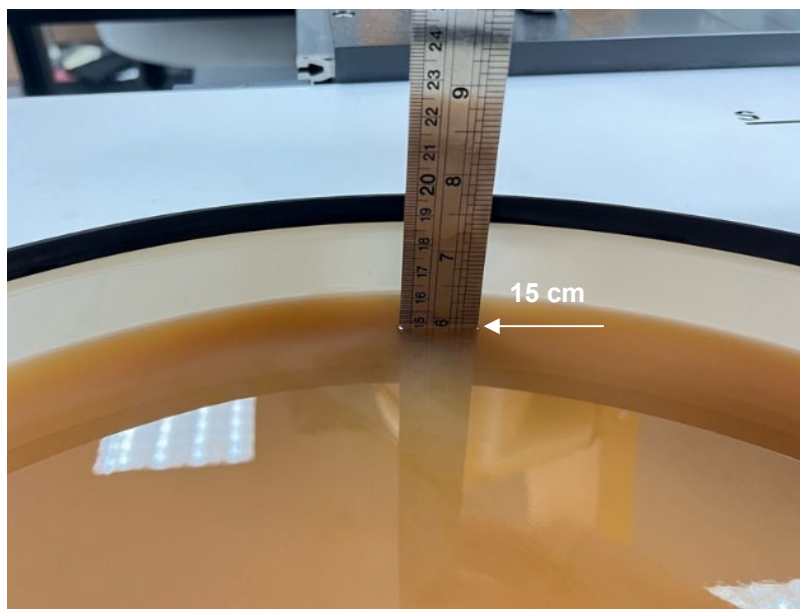

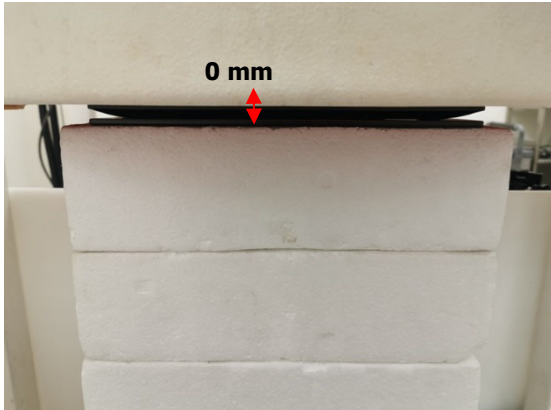

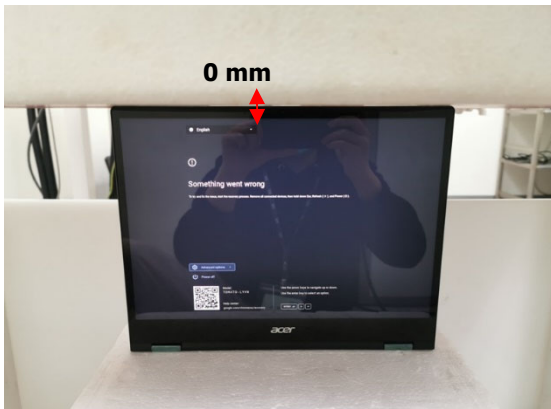

**Photograph 1. Body, Back Surface, 0mm**



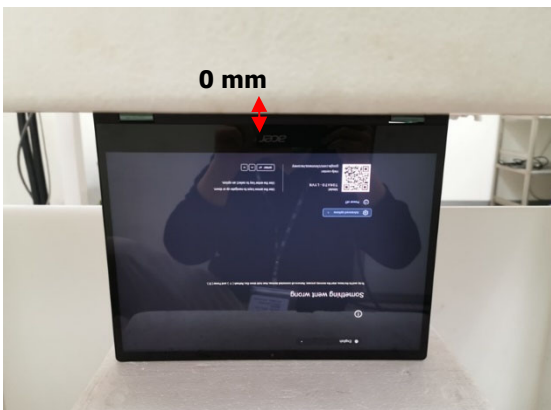
**Photograph 2. Body, Back Surface, 0mm**

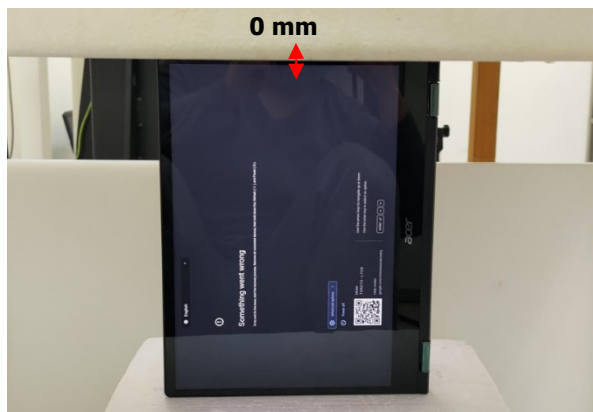


**Photograph 6. Body, Bottom Edge, 0mm**

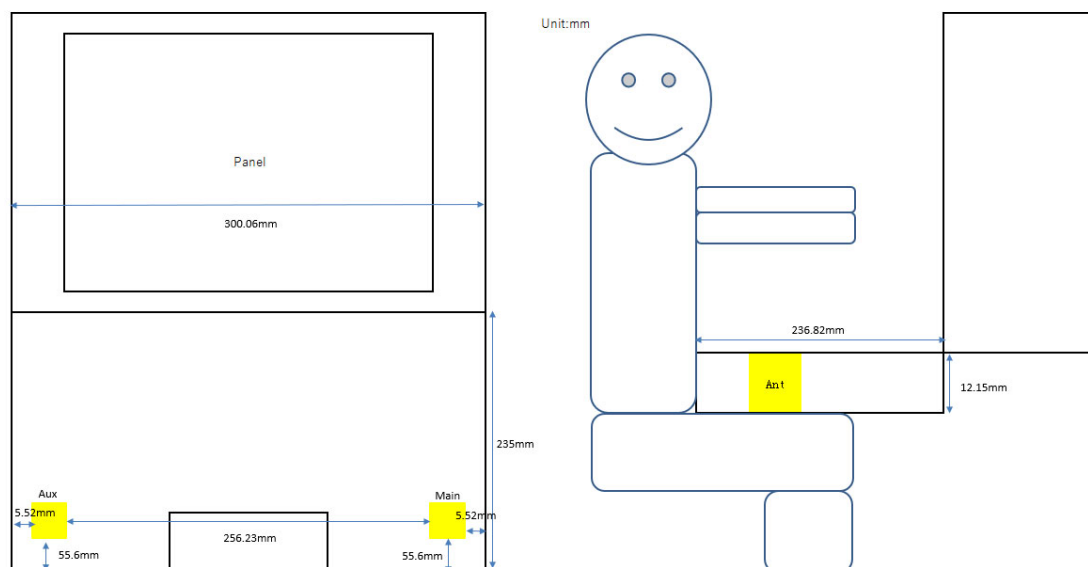


Photograph 14. Back view of EUT
