

Battery requirements

1 size "9V" or equivalent Alkaline Battery for each walkie talkie.
(not included)

Note:

- Do not mix alkaline, Standard (carbon zinc), or rechargeable (nickel-cadmium) batteries.
- Do not mix old and new batteries.
- Different types of batteries or new and used batteries are not to be mixed.
- Do not use rechargeable batteries.
- Non-rechargeable batteries are not to be recharged.
- Only batteries of the same or equivalent type as recommended are to be used.
- Batteries are to be inserted with the correct polarity.
- Exhausted batteries are to be removed from the toy.
- The supply terminals are not to be short-circuited.

Installation of batteries

Place the set face down on a flat surface. Press down on tabs to open battery cover.
Insert 1 size "9V" or equivalent Alkaline Batteries as indicated inside the battery compartment. Close the battery cover. Push the tabs on the cover to snap into cabinet.

TO RECEIVE:

Turn the power on by sliding the power switch to "on" position.
Your Walkie Talkie is now in receiving mode.

TO TRANSMIT:

With the power on, hold the talk button down and speak into the microphone. To receive a message, release the hold on the talk button.

MORSE CODE:

To practice: Set the unit to receiving mode. Press the morse code signal button to practice morse code from the chart.

SENDING MORSE CODE:

Set the unit to transmit mode. Press the morse code signal button as shown on the chart.

When the sound becomes weak, it is the time to replace the battery.
After use, slide the power switch to "off" position, in order to save the battery power.
